"There is no doubt," concedes the New York Times' political writer, "that there has been more activity in these clubs than in the clubs of either the Democratic or Republican Party." The clubs accept individual membership, but are directed primarily by trade unionists. In upper New York state, ALP organizations are functioning 32 counties. Thus the party is organizationally far stronger than it ever was.

Yet, strange as it may seem, attempts by the ALP leaders to get some concessions, in the form of endorsements for one or two ALP members for state office in the fall election, have been flatly refused by both the Democratic 1936 have conclusively demoncontrols the balance of power in the state? Isn't ALP help worth an office or two? On the other hand why are the ALP leaders getting themselves into a position which, unless they are prepared to lose face, will necessitate thatrefused the concessions they demand-they will have to run candidates against New Dealer Democratic candidates, although professing loyalty to the New Deal?

OMAHA NEWS FLASH! Labor Spy Says Franks Wanted Dynamiting Job

Omaha-(By Telephone)-Franks participated in instructing a labor spy to involve strikers in a dynamiting job in order to break the strike, was the sensational allegation made Wednesday by the self-con-fessed spy at a Labor Board hearing here.

The spy, Raymond Marchand, testified that during the

street car strike in April, 1935, he was arrested, beaten up by police, and then persuaded to turn spy by Former Detective Chief Ben Danbaum and De-tective Chief Franks. Danbaum, head of a private detective agency, paid him \$35 a week. Franks joined Danbaum in urging Marchand to get strikers to dynamite company property, tipping off the police in time to assure arrest of the dynamiters and thereby breaking the strike. When Marchand did not arrange the dynamiting, Danbaum fired him.

Steps are now being taken by the Lincoln Drivers Union, Local 20297, Mondays night in regular membership meeting, unanimously expelled Harold Larson, and notified the labor press to inform all unions to be on guard against this individual. The Great Strike of July-August, 1934

We Celebrate Today the Anniversary of the Northwest's Greatest Struggle

By consciously and cold-bloodedly piling up a record of over 700 cases of discrimination against union members, and by reckless chiseling on the agreement signed in May, the Minneapolis trucking employers prepared the ground for the 36-day strike of July-August, 1934.

A series of lurid advertisements made their appearance in the daily press, sponsored by the Citizens Alliance and directed against the General Drivers Union. The ads only threw light on the sluggish minds and hardened hearts of the exploiters. They thought it easier to label the strike leaders with epithets.

The farmers set up their own market on the plot of ground at Tenth Street between Hennepin and First Avenue North. As in the May strike, the Farm Holiday Association made substantial food contributions to the union commissary. 




