At last Wednesday's stewards meeting of the Federal Workers Section, a Youth Committee was set up with Oscar Kohler as the Youth Secretary. The following program is to be the basis of the activities of the Youth Committee of the FWS:

- We call for the establishment of YOUTH WPA PROJECTS, for those between the ages of 16-25. No youth shall be kept off because he or she is single and regardless of whether any other member of the family is on WPA or any other federal or state agency. THE BASIS OF THIS DEMAND IS THE RIGHT TO WORK IF ONE WANTS A JOB, AND NOT ON THE BASIS OF NEED AS DETERMINED BY THE RELIEF DEPARTMENT.
- NYA for all unemployed youth, whether their families are on relief or not.
- 3. All youth work at the union wage scale.

#### The North Central Drivers Movement

One of the outstanding instances of the growth of the organized labor movement in recent years has been the phenomenal gains made by the International Brotherhood of Teamsters, which today is probably the largest, and certainly the most strategic, union in the American

The growth of the drivers union movement in the Middle West has been particularly marked. Under the inspiration of the North Central District Drivers Council—a five-state body—and then under the stimulus of the 11-state North Central Area Negotiating Committee, drivers of the control of the ers locals have become vigorously active in scores of cities in Minnesota, Wisconsin, North and South Dakota, Iowa, Nebraska, Kansas, Illinois and other states. Tens of thousands of workers have been brought into the union fold, and have learned to work together for a common purpose

Next month it appears that the sweat poured into this organizational campaign will finally bear rich divi-dends. The achievement of a standard over-the-road contract, stabilizing wages and working conditions for the tens of thousands of over-the-road drivers in the North Central area, will bring immense benefits to all drivers

For the Minneapolis drivers movement, it will mean that we will no longer be so far ahead of the parade that the brunt of the attack of the organized employers will be directed against us. For drivers unions in many towns, it will mean not only higher wages paid over-the-road drivers, but that these wages will tend to elevate the Sunday. scale for all city drivers.

Nor are the teaming crafts the only section that stands to benefit from the work of the Area Negotiating Committee. It has become a proverb in American labor circles that "wherever the drivers are well organized, there you'll find a strong labor movement." The network of well-organized and intelligently directed drivers unions in the Middle West is like a spine around which a union movement of immense power can and is taking shape.

Not a day passes but the North Central work proves its value to the drivers movement. A dozen strikes have allowed us to weigh the value of inter-union cooperation. The union grapevine has brought company after company to heel, and not one strike struggle has been lost. If a boss in one city takes on the drivers union, he quickly finds he has taken on every drivers union in this part

The Minneapolis drivers may well be proud of the leading role they have played in this development. They have not only gained from it themselves, but have helped their fellow-workers.

#### Crocodile Tears

Every trade unionist understands and sympathizes with the working farmer's feeling of outrage against the Federal government's orders to cut his wheat acreage. Workers and farmers, producers of all the world's goods, able and willing to produce far more than the profit-making system permits them to, are revolted by enforced idleness. Destruction of the productive forces, whether by outright unemployment, or by restrictions on produc-tion, cannot fail to enrage all who realize that the great masses of the people could use everything that this country could produce at capacity.

But when the railroad barons who squeeze the farmers by high freight rates, the bankers who mulct them by high interest rates, the grain operators who take the lion's share of wheat income, and their newspaper hirelings, proceed to weep crocodile tears for the farmer who must cut his acreage, we can only feel disgust. All these leeches who have fattened off the farmer have no real symmethy for the farmer who they are the farmer whether the farmer who must consider the farmer who m sympathy for the farmer whatever. They are merely try-ing to incite the farmer against the AAA, in order to turn the attention of the farmer away from the leeches who, with or without the AAA, continue to exploit the

(Continued from page 1)

The Louisiana legislature passed a resolution calling upon the city officials of New Orleans to drive the CIO out of the state.

A comprehensive survey of violations of workers legal rights is being compiled by the attorneys engaged for the purpose of defending the strikers. Yet the beatings, the arrests, the deportations, the raids go on. A situation like that in Minneapolisnever! We know how to fight back.

From Westwood Hills, Califor, nia, comes the story of another attack on workers—viciously brutal, cowardly, yet typical of like

When a 1712 % wage cut was instituted by the Red River Lumber Company which owns the town of Westwood Hills lock, stock and barrel, the CIO International Woodworkers of America called a strike. So successful was the strike that before long the largest lumber mill in the world was closed tight.

As the strike held firm and all attempts to reopen it with the assistance of a company union failed, the company became de perate. An appeal to the sheriff got them a large band of deputized vigilantes.

At 1 a. m. on July 13 this mob began visiting the homes of the best known strikers and strike leaders. Some were given an hour to get out of town. Others were driven at the point of guns to the town limits and warned not to return.

At six a. m. the fire siren sound ed. This was the signal for a rushing attack on the already weak-ened picket line. A mob of 1,000 marched on the strikers, armed with pick-axe handles, axes, clubs, of town, the remaining strikers were forced to flee for their lives. One man was shot, thirty others were horribly beaten.

Someone called Governor Merriman for the militia. He sent out a detachment of thirty troopers. They were met at the county line by the sheriff who said that "order" had been restored. "Order' is being maintained by 800 depuies, especially deputized by the sheriff for the Lumber company.

And in Newton, Iowa, home of the famous Maytag washing machine, the workers are now fighting not only the bosses and the city cops but also the militia.

The bosses own the police, the press, the radio, the pulpit, the government. What then is left for the workers?

When you fight a forest fire you fight fire with fire. Union defense squads, trained to repulse such attacks are a necessity without which the fighting workers can no longer exist. Organize your own defense! Fight fire with fire! Do not stand idly by and see what you have fought and bled for, wrested from you without a struggle. That's what the American labor movement must learn, or
