# Unions Plan War on Stassen's Anti-Labor Bill

### On the National Picket Line

Washington, D. C., this week the joint committees of the AFL and the CIO meet to attempt to bring peace to the labor move-ment. Daniel Tobin, president of the powerful International Brotherhood of Teamsters, is back on the committee, as its chairman.

Secretary of Labor Perkins announced Monday that since the beginning of the meetings 1,500,000 messages express-ing hopes for the reconcilia-tion of the two warring labor factions have been received by the Department of Labor. There is no doubt that the great mass of American labor is eager for peace.

When the meetings started John L. Lewis presented a proposal for the amalgamation of not only the AFL and the CIO but also of the four great railroad brotherhoods united federation to be known as the American Congress of La-bor. The plan called for the elimination of both John L. Lewis and William Green from the executive council of the proposed set-up. William Green would have been retired at full pay for the rest of

William Green turned thumbs down on this plan. It would have forever shut him out of active participation in the multitudinous affairs of the movement and ould have left Lewis still safely ensconsed in the seat of power. Lewis still controls the United Mine Workers. Green, who also rose from the ranks of the miners, was expelled from the UMW after his expulsion of the CIO affiliates late in 1936. He was given a card in the musicians union but holds no official

William Green and John L. Lewis were once bosom friends, but since they began their bitter fight over the issue of industrial unionism, they have become deadenemies. Each has opposed the other with deadly earnestness. During the past two years this bitter personal feud between the leaders of the two factions has been one of the factors keeping union movement divided.

It has been neither the will nor the desire of the great majority of the organized la-bor movement, both AFL and CIO, to continue the fight In many cities joint councils composed of the two groups have been formed to promote many strike situations the the CIO affiliates and viceversa. The Houston, Texas, Warehouse Workers, (AFL) were assisted financially and with pickets by the CIO. In Akron, the AFL unions came to the assistance of the CIO Rubber Workers in the Goodha, during the 22-week strike of the truck drivers, the CIO supported the strike.

In Washington and in California the two factions are united to defeat the "Initiative Measure" designed to put the curb and bit on labor. In Oregon where interunion fighting is still bitter, there was voted into existence a "labor" bill so reactionary that, if it is en-forced, it will endanger the very life of the labor movement in that

Below is the new working agreement signed late in January between General Drivers Union Local 544 and the Gamble-Skogmo corporation. GAMBLE-SKOGMO, INC., hereimafter referred to as the Employer and the GENERAL DRIVERS
AND HELPERS UNION, LOCAL
544, A. F. of L., hereinafter referred to as the Union, agree to
be bound by the following terms
and provisions covering wages and
working conditions.

1. This agreement applies only
to members of the Union or those
who may become members engaged in receiving, stocking and
shipping new merchandise for resale in Gamble Stores out of Employer's warehouse in the City of
Minneapolis, and also truck drivers
and truck helpers operating out of
said warehouse in accordance with
the present seniority list as revised. The Union shall be the sole
representative of those classifications of employees covered by this
agreement in collective bargaining
with the Employer. There shall
be no discrimination against any
employee because of Union affiliation.

2. From amongst the employee members of the Union, there shall be elected or appointed a Shop or Job Committee, also a Job Steward who shall handle such Union business as may from time to time be delegated to such Job Steward or Job Committee by the Union or by the Union employees of the Employer. This Job Steward or the Shop Committee shall attempt to adjust all grievances by direct contact with the management. This shall not be construed as prevent-Tob Committee to take up direct with the Union any matters in-olving the Union employees of

Employer.
The Employer agrees not to

3. The Employer agrees not to enter into any agreement or contract with his employees, individually or collectively, which in any way conflicts with the terms and provisions of this agreement.

4. The Employer agrees that all conditions of employment relating to wages, hours of work, overtime differentials, vacations and general working conditions shall be maintained at not less than the highest minimum standards in effect at the time of the signing of this agreement and the conditions of employment shall be improved wherever specific provisions for improvement are made elsewhere in this agreement.

5. Any controversy arising over

improvement are made elsewhere in this agreement.

5. Any controversy arising over the interpretation of or adherence to the terms and provisions of this agreement shall be settled by negotiation. If satisfactory settlement cannot be made, such controversy may be referred to a Board of Arbitration composed of two representatives of the Union, two representatives of the Union, two representatives of the Employer, and a fifth neutral member selected by a majority vote of the first four. The majority decision of this Board shall be final and binding on both the Union and the Employer in any controversy so settled.

It is further agreed that the Employer will take the matter of discharge of an employee up with the Job Steward or Shop Committee or the Union previous to time of discharge. This will eliminate any controversy which may arise if not handled in this manner. ### MARCHING AS TO WAR By Dwight Macdonald

#### **Business Is Business**

Although business men overwhelmingly approve of President Roosevelt's imperialistic foreign policy, you don't find them passing up any chances for profits. If a dictatorship wants munitions and can lay cash on the line, it gets them—and from the same business interests as support so enthusiastically the New Deal's war drive to save "democracy." Thus, the Department of Commerce has announced that the biggest foreign purchaser of American steel ingots and scrap iron in January of this year was Japan. Also, in 1937 Italy got 63 per cent of its scrap iron imports from this country. Last year the United States supplied 68 per cent of Italy's scrap imports.

Not long ago, a friend who had just returned from Pitts-

burg told me of an interesting married couple there. The husband is president of a big firm of scrap iron dealers, and his best customer was the Japanese government. His wife is a leader in the Stalinist stooge outfit, the League for Peace and Democracy, and at the time was especially active in getting the en of Pittsburgh to boycott sockings made of Japane

#### Fourteen Minutes: \$520,000,000

On March 3, the House of Representatives passed the Army Supply Bill for 1940, voting \$520,000,000 in exactly fourteen minutes. This is the biggest Army appropriation since the war, and also, to quote Representative Snyder of Pennsylvania, its sponsor, "the first Army Supply Bill in 150 years of our constitutional history that hasn't had an amendment offered." This fact, he added, "serves notice on the dictators that we mean


Notice has also been served on the unemployed that the New Deal means business when it comes to ruthless cutting of the relief rolls. (Relief cuts are the inevitable result of the enormous rearmanent program.) Colonel Harrington, Administrator, states that unless Congress restores the \$150,000,000 it lopped off the President's original request for relief funds, it would be necessary to begin "serious" reductions in the WPA rolls. When asked what he meant by "serious," he replied that the 3,000,000 now on WPA might have to be cut in a short time to 2,000,000. And even if Congress restores the \$150,000,000, which it so far shows no signs of doing, Colonel Harrington said that 150,000 WPA workers would still have to be dropped every month, "a reduction which had been con-templated all along by the President and was intended by him when he originally asked Congress for \$875,000,000."

#### The Air Corps Goes to Town

The special darling of the President is the air corps, which he would expand into something that would make even General Goering's air force look sick. In the new Army Supply Bill, the air corps gets \$50,000,000, which is much the biggest in-crease granted any branch of the service. Furthermore, an important and little-noticed change has just been made Army air corps. It is no secret that the Army's Chief of Staff, General Malin Craig, thinks the New Deal's plans for enlarging the air force much too ambitious. The General, of course, in this shows a certain lack of political sophistication. He apparently takes seriously the statement of the White House that the armed forces are designed to repel a foreign invader from our shores. And so, from a purely technical military viewpoint, the General can't see why such a huge air force is needed. But he forgets that the President, like Woodrow Wilson before him, has ambitions to act as the moral policeman of the world, to overawe—and, if necessary, conquer—the wicked dictators on land, sea, and in the air. Hence a big air force is needed, and hence the control of the Army air corps has just been taken out of the hands of the unimaginative Chief of Staff and turned over to a younger and more amenable colleague, Major General Arnold, who is 100 per cent for the biggest fleet of planes in The Army air corps is now an independent arm of the service-independent, that is, of the stick-in-the-mud General Craig but not, of course, of the great moral crusader in the White House. 

Some Pick-up!

With all the lay-offs already made from WPA, and the greater lay-offs pending, it is sure gratifying to know that private industry is picking up so well that it can absorb the unemployed. At least the Republicans and Democrats in Washington who voted for the relief cut TELL us business is picking up.

But the business indexes tell just the other kind of a story Rusiness activity isn't rising, it is declining. Private

story. Business activity isn't rising, it is declining. Private industry isn't absorbing the persons laid off from WPA,

industry isn't absorbing the persons laid off from WPA, it is firing workers on its own hook.

The WPA lay-offs reached large proportions in December, 1938. The latter part of that month, the New York Times business index, one of the most reliable business barometers, began to fall. With a few slight zig-zags, it has fallen ever since. "For the fourth consecutive week," wrote the Times' financial editor last Sunday, "the weekly index of business activity has declined." By now it has more than retraced the ground gained by October, 1938. Indeed, it has put us right back to the level of the summer of 1934, before there was a WPA.

And Roosevelt has the gall to ask for a lower WPA appropriation than last year! And congress has the gall to give even less than the inadequate figure proposed by the president!

### There Are Farmers . . . and Farmers

One of the slimier sides of the campaign for Stassen's labor bill is the pretense by the labor-haters that it is the

farmers of the state, after all, who are taking the lead in this campaign to wreck organized labor.

The sort of person that is being presented to the people of Minnesota as a "farmer" is typified by Myre, co-drafter of Stassen's "labor relations act."

Myre is about as genuine a farmer as was Calvin Coolidge. The truth is that this Myre is the same fink-herder who was sheriff in Albert Lea during the American Gas strike there in 1936. He got his ears clipped during that strike by the militant pickets from Austin and Albert Lea.

But if the employers' labor relations bill has the support of all the phony "farmers" in the state, it is gratfying to know that the real honest-to-God farmers' movement in Minnesota is standing side-by-side with organized labor

in opposing this vicious bill. When news first leaked out that the labor-haters were When news first leaked out that the labor-haters were cooking up such a bill, a sub-committee of the Farmer-Cooperative-Labor-Council was the first to seek out the executive council of the Minnesota State Federation of Labor and offer its services in fighting the bill.
