Elmer packed up his family and his scanty belongings and took the family up north, to Belcounty, where bought 40 acres and tried to be a farmer.

"back to the land" talk and thought there might be something to it.

But it takes money to buy seed and implements and cattle and chickens. The Hemsworth family couldn't make a go of farming. In December, 1937, they moved back to Robbinsdale. The Robbinsdale relief authorities didn't have any house for them and so installed the Hemsworths at 906 3rd Avenue North in Minneapolis.

Elmer got a job on WPA at \$71.40 a month — for twelve people. In August the Robbinsdale relief authorities tried to force Elmer to work around the Robbinsdale city

work. Five of the kids were down with whooping cough at the time and Elmer had to stay up nights caring for them while his wife slept.

The Robbinsdale authorities promptly had him jailed for non-support. They weren't interested in his reasons not reporting for work. After two weeks they released him again to WPA. He was transferred to a Minneapolis project in order to save carfar

544-Walgreen Pact Brings More Pay

Below is the text of the new working agreement signed last week between the General Drivers Union Local 544 and the Walgreen company:

THE WALGREEN COMPANY4 and GENERAL DRIVERS AND HELPERS UNION, LOCAL NUMBER 544, agree to be bound by the following working.

Article I.

The General Drivers and Helpers Union, Local Number 544, is recognized as the collective bargaining agency for its members employed in the warehouse of the Walgreen Company, Minnesota.

Article II.

The Walgreen Company agrees not to enter into any agreement or contract with its employees individually or collectively which in any way conflicts with the terms and provisions of this agreement and further agrees not to discriminate against any employee because of his membership or nonmembership in a labor union.

Article III.

inate against any employee because of his membership or nonmembership in a labor union.

Article III.

The maximum hour work week for drivers shall be forty-eight (48) hours. Overtime at the rate of time and one-half shall be paid for all over the forty-eight (48) hour work week.

For all other employees coming under the classification of this agreement, the maximum hour work week shall be forty-six and one half (46½) hours and the maximum work day shall be eight and one half (46½) hours. For employees under this classification overtime shall be paid at the rate of time and one half for all hours in excess of eight and one half (8½) hours per day and forty-six and one half (46½) hours per week.

It is agreed, however, that in

(8½) hours per day and forty-six and one half (46½) hours per week.

It is agreed, however, that in the event the Company deems it necessary to close the warehouse on Saturday, the maximum work week shall then be forty-five (45) hours per week and the maximum work day shall then be nine (9) hours, except for the senior men who may be required to work on Saturday. For such senior men as are required to work on Saturday. For such senior men as are required to work on Saturday for all days during the week except Saturday, and the maximum shall be four (4) hours per day for all days during the week except Saturday, and the maximum work week shall be forty-six and one-half (46½) hours. Time and one-half shall be paid such senior men for all hours worked in excess of eight and one-half hours (8½) per day on any day except Saturday and for all hours in excess of four (4) hours on Saturday. Time and one-half (46½) hours.

In the event the warehouse is closed on Saturday and except as hereinabove provided for senior employees, all other employees under this classification working on a maximum forty-five (45) hours per day and forty-five (45) hours per d

week.

Double time shall be paid for all work done on Sundays, New Year's Day, Decoration Day, Fourth of July, Labor Day Thanksgiving Day and Christmas

All employees under the classifications in this agreement shall receive four (4) hours pay for each holiday when not worked.

All time under these schedules is to be computed from the time clock. There shall be no split chiffer.

It is understood that none of the provisions of this contract is to be construed as requiring the employ-er to maintain a maximum hour week for any employee, except as provided in the provision under the seniority clause hereinafter resited

The minimum rate of pay shall be as follows:
Truck Drivers 70c per hr.
Working Foreman 75c per hr.
Receiving or Shipping
Clerks 67½c per hr.
Order Pickers, Pack
ers, Floormen and
Truckers 62½c per hr.
Pricers 62½c per hr.
All other employees 55c per hr.

Employees regularly employed who have been in the service of

Employees regularly employed who have been in the service of the Company for a period of less than three (3) years shall receive one (1) week's vacation with pay; and all others under this contract who have been regularly employed by the Company for a period of more than three (3) years shall receive two (2) weeks' vacation with pay.

Article VI.

Article VI.

Seniority shall prevail for all employees working in any of the above classifications. In the application of seniority, however, ability to do the work shall determine. In reducing the personnel because of lack of work, or other legitimate causes, the last man hired shall be the first laid off, and in returning the men to work, the last man laid off shall be the first re-hired.

Whenever work is available, the Company will attempt to maintain the full work week in accordance with the seniority standing of the Article VI.

The decision of this board of five (5) shall be final and binding upon all the parties concerned. In the event that the employer becomes involved in a controversy with any other union, it is agreed that the representatives of Local 544 will consult with the employer's committee and use every means to reach an amicable settlement before calling a sympathetic strike.

For the purpose of this agreement, it is understood that no trike shall be considered a bona dide strike where the Union involved does not represent the majority of the employees in the esablishment where the strike is atempted to be called or where picketing may be instituted.

Any employee desiring a leave of absence from the job shall secure written permission from both the Union and the Employer. 

Cure for Unemployment

We read the other day where Major Edward L. Dyer, a retired U.S. Army officer, has gone Governor Stassen one better and has proposed as the simplest way of lightening the relief burden the humane slaughter of the aged. Dyer proposes an age limit of 70 or 75.

It seems to us the Major has the germ of a good idea there. He should have carried it further, but no doubt the years of army life have softened him up and weakened

Why stop with killing off the aged? Why not take all the unemployed between the ages of 20 and 70 and melt them down for lard and bone meal? They say the average adult has about 94c worth of chemicals in his body. There must be close to 12,000,000 unemployed in this age group. Just think. The government could not only relieve itself of a heavy relief burden, but could also realize a nice little profit of about \$10,000,000, which President Roosevelt could use to buy another naval destroyer.

This plan has an added advantage in that it would keep the nation's packinghouses busy and put more men to work. The nation's packers are kicking anyhow because the government is buying its canned beef for the army people are real enemies from Argentina. Roosevelt could appease the packers trade unionist.

If such trade union committees are established in every ward, labor's victory on June 12th is absolutely assured.


