
Dear Comrade Spiegel:

Dear Comrade:

I received your letter of September 29th with the copy of the Ver article. I am very sorry that I neglected to inform you that I had received it before, and planned to publish it this week in an internal bulletin together with other documents on the Spanish question. I will remember to send you copies of the bulletin when it comes out.

I know nothing about the book on the Pullman strike to which you refer. Is that a book recently published? If you will send me the name of the book I would be in a better position to look up the book. Needless to say, I would be glad to do this or have some comrade attend to it.

It is not quite clear to me just what you mean by "a negative cable from Paris re the Russian typist". Does this refer to the one we had under consideration or another one? The friend of Goldman about whom we have written you is perfecting her typing and is to be given a test by Comrade Sara Weber this week-end. If Comrade Weber finds her proficient you will be promptly notified so that a final decision can be made.

She lives in New York, not in Chicago as Comrade Trotsky assumed. She is an old personal friend of Comrade Goldman and his sister.

Please let me know if Comrade Selander showed up again.

We received a copy of the stenographic report of the discussion on the Chinese question. It has not yet been decided how to utilize this material. Possibly it can also go in the internal bulletin.

I am working very closely with the Comrades in charge of the American Committee. It is not yet clear whether it will be feasible to change the name of the present organization or to form a new one with more or less the same personnel. The non-party people working in this committee are not so close to us that we can be sure of getting their agreement to change the name of the present committee and transform it into a permanent organization. Some of them are very touchy about being too closely identified with us permanently. It goes without saying that the present committee must continue to function until its obligations are discharged. 
findings of the Commission are made public it will ^{be} very difficult to sustain enough interest in the committee under its present name.
