Dean Rae:

I want to thank you very much for letting me see your study. I thought it was a crilliant job. Some of the data you presented was wholly now to me. Unlike you, I do not consider that the viewpoint determines the value of such a work. If it did, of what value would be the tradition of Socrates, who defended slavery? I found no difficulty whatever (save in conhection with the "law of motion" of the economy, which you must explain to me in words of a few syllables) in extracting your information from your mious beliefs. Our Journal has pious beliefs, too, only we try always to be aware of them.

With your conclusions I agreed theroughly. One can argue, perhaps, whether the Russian economy is State capitalism or a managerial economy, that is, that the dictatorship of the proletariat, by a managerial revolution, has become a dictatorship of the functionaries. I think the latter arises from Marxist heir-splitting rather than economic analysis. For its objection to the State capitalism label seems to lie in its belief that capitalism is a system based on the exclusive ownership of the means of production, etc., when the facts that under all systems the vital relationship is control, whether secured by ownership, political position, legal position, etc.

T meant to send you a letter pointing out a few technical deficiences in your statistical work in places, but I'll go over it with you some time. I do think you should be more careful about style, and you should leave the political wisecraks to the editorial writers.

My eyes are bleary from reading proof, and the end is not yet: the April-July issue of The Journal, which will be published in honor of Franz Oppenheimer, will run 230 pages. In addition, we are publishing a book of his which I must prepare for the printer. I had hoped that I might run over for lunch tomorrow, but it is out of the question. I have to get this issue off. Hany thanks for pushing the quarterly in Hount Vernon. I am now taking a week off, so I can get this work done. When I am back I hope you will let me see your study in value theory. As for my German, I regret to say that although I studied it for five years, I have forgotten it from disuse. To get Oppenheimer's work done (after he had roughed out the English himself) I must have constant recourse to a dictionary. Can't you get a French, Spanish or Italian translation? I could help you with them; the Spanish I could read to you readily. Certainly it must be in French, at least. But the German-pshah! I should waste your time. All lood wishes,

Dear Rae:

During the evening I've given very careful thought to the matter of selling the translation. It seemed to me, on second thought, that if I leave a memo to James telling him the original Russian is available from the Public Library, he would very likely decide to save translation costs by having a staff member translate it.

A better course of action seems to me to be the Tollowing: Write him (Mr. Edwin L. James, managing editor) a letter, telling him you have obtained photostatic copies of the complete criginal article from the issue used by Mr. Mins, which you believe is the only copy of this magazine to be available here. Tell him you consider the article even more significant than was indicated by The Times news stories or editorials; this is the constitution for Soviet Russia's post-war economy, in the nature of which American business men and serious leaders of opinion have a prefound interest. Tell him the original runs 10,000 or 12,000 words. Offer to provide him with thempriginal a photostatic copy of the original and a complete translation for the sum on which you have decided, on one condition: that if, because of its length, The Times decides to trint only an abridged version, you be parmitted later to make the complete managazine text available to students/of the subject. Tell him you think it is quite clear from the context that this criticle was meant for home consumption and is not intended to be circulated abroad, and therefore you doubt whether the Russian censership will allow any other copies of the magazine to reach this country.

Now, besure that neither in the letter nor in any subsequent conversation you do not mention me, for I don't want him to get any idea that I would try to "job" him; I am only anxious that you get paid for your work (as I do) and, like you, that the full text be available for those who want to see for themselves.

This won't necessarily mean that he will accept; he may prefer to wait and hope that we will

get a copy from some other source. On the other hand, he may assign a sharp reporter (not me: I'm not a reporter, you know) to dicker with you to see what your lowest price would be. You'll have to handle that yourself. In any event, try to reserve the book rights of your manuscript.

Now, besides Fortune and The Commercial and Financial Chronicle, and "Quote", the only publication I can find that I think might be interested is the following: "Asia and the Americas," 40 East 49th St., New York 17, Richard J. Walsh, editor; Elsie Weil, managing editor (pays \$15 a page). Is this a party line paper? I don't know anything about it.

Now, probably none of these outlets will want to print 12,000 words of that stuff. So in the end you probably will have to fall back on a book publisher. Here our task-will be to find a commercial publisher willing to chance the wrath of Stalin's American well-wishers. I am not sanguine about that; remember Dallin had to resort to the Yale University Fress. On that account I should be very pleased if The Times agreed to buy the translation from you, giving you permission to publish the full text in The American Economic Review, Chamberlin's Russian Review, The Journal of Political Economy, The Quarterly Journal of Economics, or some such paper.

I very much enjoyed having tea with you today. But I am most annoyed that I talked so much and let you talk so little; I guess that historian and philosopher had me wound up, to no good purpose. Ordinarily I am much less loquacious. I shall count on seeing you later in the week, when I will have read your studies. All good wishes,

Dear Miss Dunayevskaya:

This will confirm my telegram of yesterday, stating the intention of the Review to publish your translation of the article on the teaching of political economy in Russia. I have your reply of yesterday and wish to thank you for enclosing the photostat of the original article.

Some days ago I wrote to an acquaintance of mine who I thought would be a very competent person to check the translation and perhaps to write one of the commentaries upon it. I was interested to discover that he also had been very much interested in the piece and had already prepared a translation of it. He said that he would be willing to check your translation and it has already gone forward to him without any identification.

If he should raise any serious question concerning any part of your translation there would arise the problem of making a final settlement of the matter. My suggestion to him was that he submit to me any comments upon the translation which I would then send to you. If there are any serious disagreements probably the best procedure would be to have a conference between the three of us. Would your desire for anonymity preclude such an arrangement? In view of what appeared to me to be the high level of competency displayed in your translation I am led to hope that no serious questions will arise.

In his letter to me, the economist who is checking the translation included the following paragraph:

"Your idea of accompanying the article with an explanatory note is a very good one. It may not be quite clear from the text that the article is a set of instructions to teachers issued in anticipation of the publication of a new standard Soviet text on political economy, long in preparation, but held up on account of the war. In other words, the explanatory note should, I believe, first of all clarify briefly the nature and background of the document. Were one to attempt an analysis in detail of the various theoretical points made by the document, the scope of the comment might ensity become unwieldy. In addition, I believe it would be unwise to indulge in extensive comments on the basis of a partical condensation or extracts from a book that is ready, but not as yet published. When the look appears, then it should be reviewed at length in English."

Since he is thoroughly conversant with the circumstances surrounding

the publication of he article I am inclined to suggest that he prepare the explanatory note. I judge from our correspondence that you also would like to make some comment upon the article. Would it be satisfactory to you to confine your remarks primarily to a statement of your judgment concerning its significance in relation to the development of sconomic ideas and institutions in Russie, leaving the purely explanatory background to the other note? If this were the general plan it would probably be desirable that you see the other note in advance of publication so that if in your opinion the explanatory section was not adequate you could either suggestima changes in it or make some further reference to the matter in your own note.

I hope that the various suggestions made above will be satisfactory to you.

Please pardon me for not replying more promptly to your letter of June 13. The reason for the delay is that we ran into some complications with respect to the checking of your translation which we hoped to item out. Unfortunately, the arrangements which I reported to you in an earlier letter have had to be cancelled. The nature of the difficulty was that the person whom we were consulting at the end took the position that he would not cooperate unless he were assured that the translator was a person of the correct political principles with respect to Russian affairs. This was not a basis on which we found it possible to do business with him and we were therefore under the necessity of finding someone else to take his place. As soon as arrangements have been made, we shall inform you of them and arrange for a satisfactory basis of cooperation between you and the person selected. It is still our intention to run the article in the September number of the Review.

Since I am leaving for London very shortly your future correspondence will be with Dr. Fritz Machlup who is taking charge of the editing of the Review during my absence.

The preliminary report on your translation indicated the belief on the part of the checker that there were some points at which somewhat more care needed to be taken to give the exact turn of thought, and at the same time, that the translation as a whole was rendered into excellent English. No doubt any points needing attention can be easily agreed upon between you and the person chosen to do the checking.

I am very sorry for the turn of affairs which necessitates the further trouble and delay. It all seems very foolish to me since, as you know, and as the review knew, our interest is an entirely scientific one of rendering to the English-speaking public an accurate translation of an important Russian statement. It seemed to me a rather strange position for anyone to take as a condition to participation in the project that the political views of the translator must be satisfactory to him.

You will no doubt hear from Dr. Machlup in the early future.

and not have a chance for a rejoinder. I have too keen a
sense of the importance of economic problems to be moved
by any personal considerations. I myself am more involved
at the present time in American post-war economic problems
than in Russian political economy. It is precisely for
that reason, however, that a further analysis of the Russian
article is imperative for we live in "One World" and no
country can tear itself out of the vortex of world economy.
The type of economy the Russians intend to have profoundly
affects ours and vice versa.

I shall try to draft my statement this week.
Naturally, your editorial point of view must prevail as
to the suitability of any one author's contribution, but
I hope you will agree with me as to the importance, not
so much as to my having a second say, but as to the statement
I shall make.

I expect to be in Washington on Saturday, April 282. Should my statement be completed by then I shall bring in to you "in person"; otherwise, I shall mail it as promptly as it is completed so that it can, should you accept it, be included in the Fall issue of the Review.
