DEAR COMRADE JOHNSON: I have your letter dated July 3. I am inclosing a copy of a letter we sent to Comrade James which answers some of the question you raised in your letter. I wired you on Thursday in regard to the bonds. You say in your letter that you did not receive our wire. I can not understand what happened to it, unless your letter was written a few hours before our wire was sent.

I can only repeat what we said in the wire. Our bonding company, as well as the Civil Liberties Union which usually works with us in arranging this bail, both say that they will not handle amounts of \$900 for three people. This sum is so low that it could be raised almost anywhere by any alert comrades who are willing to put in the energy. I must say for ourselves, that we are of similar opinion property ball must be gotten. It is obvious there are people there with property, and the proper approach must be made. The easiest way, of course, is to demand that the International Labor Defense pay \$60 or \$70 extortionate premiums to a local surety company but if we were to conduct business on such a basis we will be able to defend about two people every year.

In regards to legal defense. Should the decision in the case be a bad one, we must, of course, appeal. You will see in my letter to Comrade James certain suggestions in this direction. After the trial if it necessary to appeal, we will then take up the matter of designating a competent attorney. Incidentally, we all think it to have been extremely stupid to postpone the cases. The comrades who were arrested are competent comrades and should have defended

the cases themselves, without going to this expense.

I have also written you in the telegram we sent Saturday that we have arranged for bail for all the Atlanta comrades. They ought to be free in a day or so.

The affidavits are being arranged for and ought to be down in a few days.
