

The Pepsi Generation... Reaches Russia

About two weeks ago, the Pepsi-Cola Co. announced that they had reached an agreement with the U.S.S.R. government to start the distribution of Pepsi Cola in Russia. The agreement included a clause giving Pepsi Cola private rights to sell Russian Vodka in the United States.

A week ago, the First National City and the Chase Manhattan Banks announced that they will soon open branches of their banks in Moscow. The two banks are controlled mainly by the Rockefeller family. David Rockefeller is president of the First National City Bank.

Recently the N.Y. Post reported that a combination of North-American and Japanese enterprises were negotiating a contract to buy natural gas from Russia. As part of the \$10 billion dollar contract, the North-American companies have committed themselves to build two pipelines of 3,000 miles in Russia, a refinery valued at \$7000,000,000 for gas and 10 ships specially built to transport the gas from Japan and the U.S.

This news comes two months after the sale of \$1 billion dollars worth of wheat to Russia by U.S. Agriculturalists.

What is the significance of the increase in commerce between the U.S. and the government of Brezhnev and Kosygin, supposedly a socialist country.

Last year Nixon visited the Peoples Republic of China. In March of this year he visited the U.S.S.R. His plan was to exploit the division which exists between Russia and China, and to ally himself with one of the two against the other.

It is clear that Nixon, Kissinger and the rich which they represent, received nothing from China, except that they saw what a true socialist country is like.

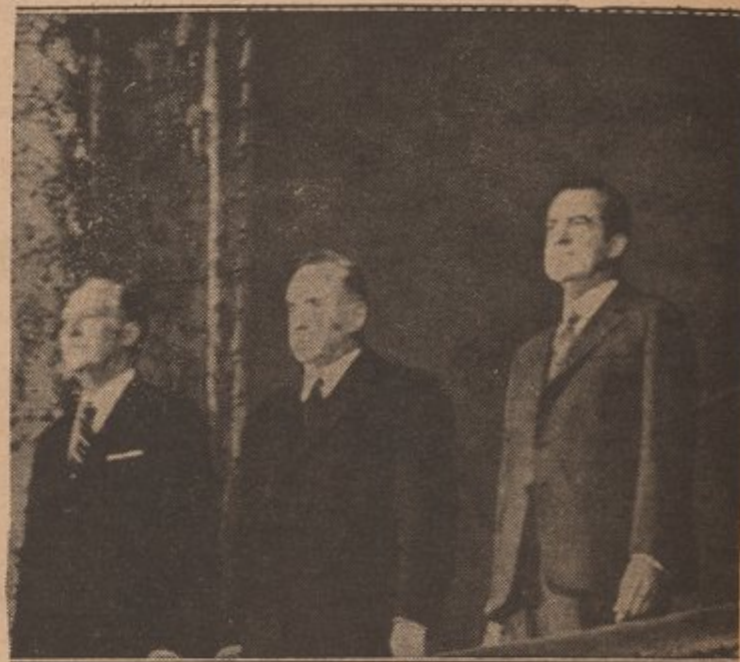
From Russia they got commercial treaties, agreements for mutual help in the Middle East and Europe, and the promise from Russia to exert pressure on the government of Vietnam to end the war in Indochina.

Finally, they will continue to strengthen their alliance with

Russia, while Russia follows it's road and becomes more and more capitalist. Russia is the new economic market for North American Companies. Russia is the new ally of the United States. In the coming years it will be a more faithful ally than England, Japan, and France. Russia will be the most faithful ally against the people of the world who rise up to fight for their freedom from foreign dominance; it will be a most faithful ally against workers of all countries whenever they rise to put an end to exploitation and oppression, and Russia will ally itself against the Peoples Republic of China.
