The incoming United Secretariat will differ from the pre-world congress Secretariat in two respects: 1. tendencies will be formally represented; 2. it must represent a big step in the direction of establishing a resident secretariat.

The IEC majority must have a larger than proportional representation in order to have a working body. The exact number of LTF comrades can be somewhat flexible depending on finances and how many are resident.

Proposed that the United Secretariat be composed of 14 IMT, roughly 5 LTF, and Karl for the Kompass Tendency in the GIM.

United Secretariat

Dear Comrades,

Several errors crept into the minutes of the last United Secretariat meeting (March 16) which while not of major importance could lead to possible misinterpretations by those who were not present but who receive copies of the minutes.

For instance, it is stated in the summary of Comrade Walter's report under Point No. 1: "The World Congress documents are ready for publication in the three basic languages..." The fact is that they were not ready for publication at the time. The translations were still under way. The resolution on Argentina, submitted in French by the majority, was not mailed for translation into English until April 6 -- that is, almost three weeks after the United Secretariat meeting -- and was not received until April 11. As of this date, the resolution may still require further editorial changes.

Among the motions at the end of Comrade Walter's report, No. 3 is listed as "To publish the Statutes without the present foreword."

I stated that I wanted to reread the foreword before voicing an opinion or being rushed into making a hasty decision. This view is not indicated in the minutes. In any case the motion is not accurately stated, since the question involved whether to include the foreword in the issues of the magazines carrying the documents of the Tenth World Congress and no ban was placed on publishing the foreword in general.

Motion No. 4 under the same point reads: "To send a circular letter to all sections about their duties concerning the dues to the International." However, Comrade Walter specified all <u>delinquent</u> sections and groups. If a letter on the question in general were to be sent out, no one would object, of course. But the discussion concerned only delinquent sections and groups, although no list was presented.

Under Point No. 8 (miscellaneous) both motions are inaccurate. The first one reads: "That all sections have to consult the United Secretariat before taking any decision on publishing publicly documents from the pre-World Congress debate."

But the motion agreed on at the meeting did not use the phrase "have to consult" but "are urged to consult" or "should consult." The formula "have to consult" would have led to further discussion on the question and possibly a negative vote. No motivation was offered for placing the motion before the United Secretariat and if it had been phrased as it appears in the minutes; that is, as an order, it would certainly have been questioned.

The second motion reads: "That to add a debate on Cuba in addition to the points on which the debate should continue after the World Congress, listed in the ten-point agreement from the United Secretariat meeting of Sept. 1973."

What was agreed to -- and a motion was not necessary on this -- was to ask the Bureau to initiate a study on the situation in Cuba. This might lead to a debate; but not necessarily so. As I understood it, the consensus of the members of the United Secretariat was that this would be the best procedure inasmuch as a well-prepared study might lead to a common agreement as to the nature of the situation in Cuba.

On the other hand, the minutes do not report that it was agreed to include in early issues of the Internal Bulletin some material on Ireland to be submitted by the RMG.

Finally, under "(b)" of Point No. 8, a motion is included that reads, "That the IEC-minority be handed the IEC-majority declaration to the minutes of the World Congress."

I do not recall that such a motion was actually made. It is true that some of the members of the Majority Tendency raised the question whether they were actually required to give the representatives of the Leninist-Trotskyist Faction a copy of the statement they had prepared for addition to the minutes. It is also true that I, among others, protest that this would be a violation of the agreement reached between the two sides at the last meeting of the Parity Committee before it was dissolved. In view of the protests, the comrades of the MT agreed to carry out the agreement, stating that "after all, the statement is not a secret one." That ended the discussion.

I do not know who was responsible for drawing up the minutes and I do not want to put any comrade on the spot for such errors. But I would like this statement to be appended to the next set of minutes. The purpose is to suggest that it might be advisable to seek a form of the minutes that would be less subject to slips of this kind. A possible safeguard on motions, for instance, would be to insist on having them down in writing at the time they are made so that it is not necessary to rely on someone's memory several days or weeks later when the minutes are drawn up.

Dear Comrades!

As you already know, the United Secretariat decided at its meeting of march 16, 1974 to publish in three language (english, french and spanish) a forthnightly magazine called "International Press Correspondance". These magazines are going to be the organ of the United Secretariat, expressing the views of the international leadership on current events. In this way the United Secretariat will have the possibility to give all sections more analytical appraisals of world events, at the same time as it will constitute an important politically homogenizing force.

The first issue will appear soon- in any case before the end of April. In the first issue you will find the following subjects dealt with: Fortugal: The beginning of a crise; by Udry Itali: The referendum on the divorce and the by Livio Maitan political crise; The political crises in Bolivia is head-Bolivia: ing towards a confrontation The Goulag Archipeligo: by Ernest Mandel Resolution of the Ceylonese section The economic and political crises of the Saigonese regime by Pierre Rousset The general election in Colombia:

The spanish CP and the Sovjet Union:
by Piere Frank

After this the next issue will appear in the middle of May, which means that between the first and the second issue their will be a timegap of about one month. The reason for that is that we want to give you enough time to raise a lot of subscriptions and send in the money to the center, before the second issue appears.

After this problem period the magazine will appear regularely

After this probing period, the magazine will appear regularely as a forthnightly.

The following is the way we want you to act:

1. Make big efforts in raising a lot of subscritpions. The whole undertaking is dependent on that.

- 2. We want you to arrange the distribution in the following way:
 a. The first way is that each branch of your section or sympathising group recieve the magazine directly and distribute it to subscribers inside the branch and to close sympathizer This arrangement is done in order not to delay the arriwal of the magazine to each subscriber, which will be the case if it has first to go through the center of your section.
 - b. The second way of distribution is that we send it directly to the adress of individual subscribers. But in order to lower the costs of distribution we want you to use this way only for people outside the section and in exceptional cases inside the section.

- 3. Give us immediately indications on how many copies you need and to which adresses you want them. (And in which language)
- 5. Money for subscriptions has to be paid to the following bank account:

Dear Comrade Jens:

We received today a letter from you dated April 12.

We will call to the attention of our branches the information about the publication of "International Press Correspondence," but before we do so we need some clarification on the rate structure and circulation procedures.

It has always been the custom in this country for individual comrades to receive subscriptions for all publications at their home addresses, and we think comrades will want to follow this custom in this case, too.

Various branches may want to order a bundle of the publication for sale in their bookstores, but they always decide such questions in the light of local needs and possibilities. Can you give us the rates for bundles by seamail and airmail, so that we can pass the information on to the branches?

Potential subscribers will want to know what the dollar equivalent is for a subscription, as well as the duration of the subscription. The figures should be calculated for both sea mail and airmail. Also will you have a special rate for a short-term trial subscription?

It is not clear to us how payment for subscriptions should be sent or to whom. It is not possible in this country to send payments directly to a bank account, whether by check or postal order. It is possible to wire or mail a draft payable in francs when you have the name and address of the individual or publication, but this is very complicated, and not many comrades are familiar with the procedure. Comrades can send their payments via personal check or international money order. To whom should these be made payable? To what address should they be sent? Can the payments be made in U.S. dollars?

We would appreciate your clarification on these questions.
