TO ALL ORGANIZERS AND ANTIRACIST WORK DIRECTORS

Dear Comrades,

On March 17-21 the Third National Black Political Convention will take place in Cincinnati, Ohio. (See attached for schedule and registration information.)

This convention is being organized by the National Black Assembly, which is the body formed out of the first Black convention held in Gary, Indiana, in 1972. The NBA is only a shell of the body projected by the 8,000-attended Gary convention.

At the Gary convention a program for Black liberation was developed, which, if implemented, would have advanced the overall struggle for Black rights. The BNA's purpose was to make this program become a reality. This never happened. In fact, NBA chapters have rarely met in its four years existence. And, as far as we know, few of the planned NBA delegate selection meetings that were scheduled to be organized prior to the Cincinnati convention have actually been held.

It is not yet clear what the organizers of this third convention hope to accomplish at this gathering. Since they announced last February, 1975, their intention to run an "independent" Black campaign in 1976, the organizers of the NBA -- from Amiri Baraka, the former secretary-general of the NBA to Ron Daniels, present chairperson of the NBA -- said this presidential campaign would be "anti-Democratic and anti-Republican." Yet their main choice for president is a Black Democratic legislator -- Julian Bond of Georgia -- who has no intention of leaving the Democratic party. (See January 2, 1976, Militant for more details on projected campaign.)

As well, on February 21-23, the NBA organized a National Committee for Peoples Politics (NCPP) meeting in Washington, D.C. The NCPP is supposed to be the nucleus for a future campaign committee for the "independent" Black campaign. However, this body, which is not all Black (only half), plans to consider running a white woman as the vice-presidential candidate. (See Baxter Smith's article in the March 5 issue of the Militant.)

Just from this information it becomes clear that the NBA is not planning to run a truly independent Black campaign but instead it is projecting to launch some type of "peoples campaign." The Militant that will be sold at the convention will further analyze this perspective of the NBA.

Although it is not clear what the NBA will decide to do in Cincinnati, or what the size of the meeting will be, we can safely assume that several hundred Blacks will probably come to the convention. The major Black media has already given the convention much publicity. And it is likely that many Blacks will come to the convention just to "check it out" and to see if the convention will nominate or draft Julian Bond to be its presidential candidate. Others will be there because of their opposition to the two major parties and will be looking for an alternative to them.

These independent-minded Blacks will be open to our ideas. The convention thus provides us a valuable opportunity to discuss our socialist ideas with many radicalizing Blacks from Cincinnati and around the country. Willie Mae Reid will be at the convention and a major socialist propaganda intervention is planned. PRDF will also be bringing literature to the convention.

The National Student Coalition Against Racism and supporters of the May 16 ERA demonstration will be bringing literature to the convention too. NSCAR is seeking to get a pro-busing speaker at the convention.

We are encouraging as many Black comrades as possible to attend the Cincinnati meeting to help carry out these different activities. Where it is possible, we want comrades to try and become elected delegates to the convention. Based on past experiences, only delegates are allowed to speak and participate in state caucuses and to speak from the floor. We especially, therefore, want to encourage comrades who are candidates for office to become delegates. Registration fee for delegates is \$25; for observers, \$10.

A national fraction meeting will be held at the Tangenman Center (Student Union), University of Cincinnati at 7 p.m. on March 17 (Wednesday). The room number will be posted. (If there are any problems finding the place, comrades can reach me or someone else at Rick Mitts' -- 513-272-2596.)

Everyone should also bring sleeping bags for mass housing. The cost will be \$1 per night.

Finally, we need to know by March 15, at the latest, how many comrades and campaign supporters will be coming to Cincinnati. Please drop me or Nan Bailey a note or call once this information is known.
