The Chicago comrades are planning to respond publicly to the idea of a massive demonstration, supporting the idea and offering to cooperate with Jewish leaders and whatever other forces that might support such a call.

B. New Orleans

Stapleton reported on discussions he had with New Orleans comrades during recent visit there on debate inside Louisiana ACLU over whether or not the ACLU should provide legal defense for the Nazis.
