Declaration of a "Parity Committee" set up by the OCRFI,

the Bolshevik Faction, and the Leninist-Trotskyist Tendency

1. The need to the dispersal of forces and organizations claiming adherence to the Fourth International, which was provoked by the policy and organizational measures that the United Secretariat adopted regarding the revolution in Nicaragua, requires the organization of a common and international discussion by all the lements, forces, and organizations that base themselves on the Transitional Program, with the aim of rebuilding and restructuring the International and its organizations into a reunified Fourth International. Today the danger of dispersal of the Fourth International's forces is far more serious even than the threat posed by Rabbasia beginning in 1951, because the attack against our principled positions is much more ruthless than it was in those years.

2. Several weeks ago the Bolshevik Faction and the Leninist-Trotskyist Tendency, tendencies the United Secretariat, were put in a situation akin to expulsion by the majority before

the convening of the United Secretariat's Eleventh World

Congress. The Bolshevik Faction and the Leninist-Trotskyist

Tendency feel that the administrative injunctions invoked by

the United Secretariat majority signify a desire to stifle

the discussion that alone can provide the foundation for democratic

centralism.

The Organizing Committee to Reconstruct the Fourth

International, the Bolshevik Faction, and the Leninist-Trotskyist

Tendency feel it is their duty to set up a party committee

among themselves in order to fight against the dispersal

of the forces and organizations claiming adherence to the

Fourth International. If we did not take this decision,

it would create a situation where the SWP leadership,

abandoning the terrain of Trotskyism and of the Fourth

International in order to pass over to the Castrotism,

would succeed in increasing the confusion within the

ranks of the Fourth International.

A a time when the forward march of the World

Revolution, which has just been reconfirmed in Nicaragua,

finds the revolutionary movement of the working masses confronted

by the combined forces of imperialism, the The Kremlin bureaucracy, and Castroism, all united on the policy of peaceful coexistence, the establishment of the Parity Committee is an abostute obligation.

3. The Organizing Committee for the Reconstruction of the Fourth International, the Bolshevik Faction, and the Leninist-Trotskyist Tendency invite the United Secretariat, all those who want to remain 1 yal to the principles of the Transitional Program adopted by the Fourth International at its birth (1938), to participate in the Parity Committee that we have decided to establish.

4. The Organizing Committee and the Bolshevik
Faction fully endorse the declaration adopted by the
Leadership Committee of the LTT on October 28, 1979:

"In view of the fact that the resolutions of the last United Secretariat meeting on Nicaragua constitute

Plice political cover for the revisionist policy of the SWP leadership, and that the Secretariat's organizational injunctions are, by their very content, liquidationist and splittist;

"In view of the fact that the maintenance of the cauxus as a leadership bloc always prevents the International's leadership from defending the Fourth International by fighting against the positions of the SWP leadership;

"In view of the fact that the United Secretariat's refusal to suspend the organizational injunctions and postpone the World Congress give that congress a totally undemocratic character, and in view of the Secretariat's opposition to reversing the course adopted at its last meeting;

"In view of the need to defeat the liquidationist offensive now being directed against the fundamental acquisitions of the Fourth International, and in view of the need to prevent a new scattering of the Trotskyist forces;

"In view of the existing possibility to overcome the present crisis by working in a positive way toward principled regroupment of all the forces claiming adherence to Trotskyism through the reunification of the Trotskyist movement as a whole;
