Judge Malvey denied the motion saying only that previously another judge had so ruled and he would uphold the decision. The second motion was to have the jury sequestered, Judge Mulvey denied this also; his only reason being that he had denied it when Ericka's lawyer, Katherine Rorabach had requested it earlier.

Before jury selection begins, the candidates are told what function they will perform if chosen to serve. Although the instructions are given with only the jury, the judge and the defendants present, the transcripts of those proceedings are read to the spectators and the press when they are later admitted into the courtroom, Mulvey repeatedly mentioned the phrase "Innocent until proven guilty" and stated that the standard of proof in a criminal case is higher than that in a civil case. He also stressed that the burden of proving guilt is on the state.

While it appeared that the statement indicated the impartiality of the court, it soon became clear that it served only to tell the prospective jurors what to say when examined. The judge's instructions anticipated the answers to many defense questions by telling the inexpeienced jurors what the correct answers were. They were told repeatedly that a policeman is the same as anyone else and that grand jury in-· dictments do not indicate guilt, Because

The defense lawyers have said that old middle-aged white people could not understand the defendants or the majority of defense witnesses, given their difference in background, life styles and language. One prospective juror has said that she has no idea of how Black people are living, "never associated with them," And then the woman said she "knew" the defendants had killed "one of their own color", and left honestly not understanding why she had been so readily excused,

Thus far 100 candidates have been considered, of these only two have been accepted as jurors, Both State's Attorney Markle and the defense attorney have used two of their 60 pre-emptory challenges to eliminate four persons from the jury. One of Charles Garry's challenges was used against an insurance investigator who works closely with the police, in fact doing police work. Markle made use of one of his challenges to reject a men heavily involved in union work. The remaining

number have been excused by the court for various reasons. Among the reasons given were because of hardship, because the juror would believe the word of a policeman over a layman, because the juror felt arrest or indictment evidenced guilt, because the juror had a firm opinion of the case already, because of prejudice against the defendants or the Black Panther Party, because the juror did not believe in capital punishment, and because the juror felt Ericka and Bobby could not get a fair trial.

Of the jurors accepted, both are male, one is White and one 's Black, The first is a 37 year old mailman who attended eight years of grammar school. His wife is a factory worker and he has stated that "as far as I am concerned, I'd be a too good juror". He said that he had no feelings either way about the Black Panther Party and his only regret about serving was that he would miss the Christmas overtime at the Post Office.

She noted that they were picking a jury to decide a verdict and not to deter mine the sentence. She said that it would be possible to empanel another jury for sentencing if necessary and that it was unfair to continue to search for a conviction prone jury because there was a possibility hat they would have to consider sentencing. Her arguments were recorded but made no immediate difference, Sometime later, a man simply said "I don't believe in an eye for an eye" and he was excused.

The third panel will be sworn in on Tuesday, Nov. 24th. At this rate it seems likely that the first ten panels will be defeated within a month, making necessary a whole new series of panels. It appears evident that jury selection will extend into the next few months, far exceeding the 4 week period in which a jury was chosen for the trial of Lonnie

McLucas.

THE SPIRIT OF SPURGEON 'JAKE' WINTERS LIVES

"When they killed Jake, they took the best that humanity possessed,"

Spurgeon "Jake" Winters 19, member of the Illinois Chapter, of the Black Panther Party, gave the most that one can give towards the liberation of oppressed peoples- his life. At 3:30 A.M. Nov. 13th, 1969, Jake was murdered in a shootoot in Chicago where three pigs were killed and seven were wounded,

The shoot-out was precipitated by an ambush made by the standing army of Chicago (Chicago Police Department) on an abandoned building at 5801 S. Calumet. Arriving on the scene with armaments and men (more than 1000 policemen equipped with 12 guage shotguns, M-1 carbines, .357 magnums, billy clubs, mace, tear gas, paddy wagons, belicopters and canine unitsy for domestic warfare against the people in the Black colony, these fanatical pigs started attack by opening fire on the be forgotten and not primarily for the brothers in the building. 

But although Jake was equipped only with a shotgun and was murdered, the results attest to the fact that the people with their intense desire for freedom can combat the forces of aggression.

A June 1969 honor graduate of Englewood High School, Jake worked in the Breakfast for Children Program and for the Free Health Clinic; he was a member of the Education Cadre. In essence he was a servant of the people.

There can be no compromise with the forces of oppression or the forces of fascism. The enemy must be wiped out thoroughly , completely and resolutely. And we say, "Right on, Jake."

Declaration of the executive secretariat of solidarity with the Afro-OSPAAAL in American people and Angela Davis.

The government of the United States, under the Nixon Administration, is travelling frantically toward the establishmens of fascism as the logical culmination of monopoly domination over the economy and the politics of the nation.

In order to carry out its shamelass aggressions against the people of the world who refuse to live under imperialist oppression, the US Covernment requires the complicity or the silence of domestic opinion in the United States. The criminal war unleashed against the heroic people of Viet Nam has unmasked the true face of the Yankee imperialists to such a point that, as a result of that aggression, the US Government has been unequivocally ostracized and coademned by all peoples, including large sectors of the North American people themselves,

Following the escalation of the war in Viet Nam, the Yaakee imperialists have begun the escalation in Indochina, extending the war to Cambodia and Laos at the same time they set in motion the dirty policy of Indochinese fighting Indochinese. With the extension of the war to Cambodia -- ordered by Nixon because of the brilliant success of the Vietnamese patriots and his government's failure to stop the liberation of the Asian peoples --Nixon noped to excricate himself from the military defeat in Viet Nam. Thus, the North American youth and other sectors of the population once more saw Nixon's total contempt for their opinion and their will confirmed, which triggered a veritable explosion of rebellion throughout the whole country. In retaliation the repressive forces of imperialism burled themselves against the students and

other radical sectors who demonstrated their justifiable repudiation of the aggressive Nixon policy. With similar objectives the Nixon Administration develops the policy of extermination of the Afro-American people carried out by its predecessors. Yankee imperialism is not content with the oppression of the people who suffer under its boot, but also practices a similar oppression against such national minorities as Indians Chicanos, etc., attempting to stifle their legitimate rebellion and sending against them troops trained in the expermination of fighters.

Nixon has unleased against the black people a repression which is to all intents genocidal, imposing a terrorism reminiscent of his Hitlerian teachers. There is systematic recourse to assassination of the leaders and fighters of the brave Black Panther Party who bring together in their struggle the best revolutionary traditions of the Afro-American people. Nixon and his administration persecute the North American Blacks in order to justify their policy of exterminat-

The campaign unleashed by the Yankee Government against Angela Davis, whose only crime is that of having headed a committee to aid a group of black prisoners jailed on the infamous charge of murder, is directed not only against her, but against the entire black movement and the rad calgroups in rebellions As at other times their fury has been turned on black leaders such as Huey P. Newton, Bobby Seale Rap. Brown and many others, so now it is directed against Angela Davis

Just as Yankee imperialism will be defeated and finally expelled from the countries it now oppresses in Asia, Africa and Latin America, so will it also be crushed by the Black Movement and other progressive forces that struggle to oppression.

Today Angela Davis, Huey P. Newton, Bobby Seale and other black fighers are suffering at the hands of Yankee imperialism but their names like those of Malcolm X and Martin Lather King Ir, are already the pride of the Afro-Americans and there brothers in the struggle, in every corner of the earth.

The world voices its opinion, clamoring for the liberation of Angela Davis, victim of a victous and dastardly accusation.

In the six days that I was there, something struck me that had previously passed as another hopeless trait of capitalism. I would like to describe it here and now along with its connection to a well known principle, "Information is the raw material for new tdeas". Information: Although to most sisters in the Women's Hoase of Detention, there is little practical difference in bails of \$100,000 \$10,000, \$1,000 and \$100 a large number of women are being decained at amounts ranging from \$100 to \$1000, Simultaneously, a great deal of the charges accompanying these bails, are what we shall refer to as survival (or defensive) offenses. This means that these charges stem from acts widch, if successful, would have eased some of the economic burden of the sister, thus eliminating any need to steal, prostitute, con, stick up or sell marijuana or drugs,

Obviously the problem, from the beginning, was an economic nece thus we have a political contradiction. When the trained mercenary (police) discovered this act of dofense, he as no time inquired of the sister, why she felt such a compulsion to risk death or imprisonment, for such a small act. a never occurs to him to investigate the situation fairly and objectively. He needs to make only his monthly arrest quota to insure his job security, if he makes so many accests, his chances of promotion are greater.. He camo: maintain his job if he makes no arrest in a moath, or if he only makes two arrests. We can see from this that his interest is never in fairness or objectivity. The nature of his job as a policeman, dictates that he be unjust and subjective.

Me inwhile the sister is taken to a jail cell, where she is booked and held pending trial. Noone has yet asked her if she is intocent, or it her actions were justified or ever if her children are taken care of in her absence. Either the same night or the following morning, she is taken before a judge, He does not speak to aer as all He usually takes turns, looking either at a yellow sheet of paper that has her name, address, sez age, racerelgion and charge or charges, or he

He is not asked to discover whether or not the sister is guilty or insocent, rather he is pald to assume she is guilty, and to gather any and all information and materials to lend credence to his assumption,

> The Asst. District Autorney reads off the charges with one or two new ones added for good measure, then he recites a well used speech about the criminal threat the woman poses on society. He asks the judge to set ball at some ridiculous amount that has nothing to do with the constituttional requirements for bail. He does not bother to follow those requirements because he understands that he will not be held responsible for upholding any of its codes. He has already been conditioned to ignore such an inefficient document.

The judge follows the suggestion of the Asst. District Attorney and sets bail. He does not ask her if she has eaten recently, if the clothes she wears treberoaly remnants. He doesn't ask herif her babies are fed everyday or if they have a decent house to stay in, All he does, is set what amounts to ransom and confines her to a building whoce she is guarded, ignored and sarassed. There is no point in her even dreaming about going home, because she knows she has no money, fit she did she wouldn't be there anyway). Her friends have no money, or if they do, it is just enough to survive with. She faces a one to three year sentence, or even a six month sentence and she cannot post bail or hire a lawyer. She lays there

The court appoints, at random, a legal aid. He is employed by the state. He is given approximately ten caseloads a day and is either unable, or chooses not to adequately defend any of them, He has very little time to file all the complex motions accessary. The thought of a trial is repugnant to him thecause he knows he can't (or won't) prepare for one.)

The legal aid confers with his "client" only on the days she comes to court. He periodically takes a porfolio of cases to the Asst. District Attorney and asks for deals, in return he promises not to take the state through the costly trial process. He then tells

his client to cop out to a lesser charge so that she can get out of jail at the "earliest possible time." She has very little choice, In fact she has no choice she accepts. The judge first gives her a long speech about her "criminal nature" and tells her to rehabilitate so she can be an "asset to society." Then he gives her ninety days or six months, Sometimes be

She spends the entire sentence counting off days, In jail, she nustles to survive. Strange isn't it? Even in jail, the name of the game is money. She cannot buy cigscrettes, personal basic necessities or the Sunday newspaper, The economic need is till there, Her instinctive compulsion for survival mores her to, in effect, pimp off her sisters in jail.

One of the other restrictions of women's jalls, is communications. There is no history of either political or religious struggle, in wamen's detention centers. As a result of these conditions, a group of women in New York, have come together in order to eliminate some of these conditions.

We are organizing brigades of women to force the prison administration to admit us into these ple pens so that we can find out from the sisters themselves, what their specific needs are, We will then take steps to meet those basic needs (just as in the medium security of our communities, we are trying to meet the basic needs of our people). We will begin to take the necessary steps to insure the wedfare of our sisters. Where there is a bail of an amount that we can raise, we will bail the sister out of the pig pen. We are beginning to send letters inside, so that the sisters know that we are putting our theories into practice. We want to utilize all of the progressive services available so that these sisters are given better treatment. The only way to educate is to communicate We need help in all areas. We need decent jobs, advice, money, stamps, paper, revolutionary pressure on the prison administration and help for sisters who were addicts at the time of their arrest. We need clothes, houses, beds, every and anything. We apped people to help us turn this idea. into a revolutionary reality.

On December 20, 1970, there will be an evening rally at the nouse of Decention to demonstrate our solidarity and to inform the sisters of what we are doing. It will also be in support of the Provisional Revolutionary Government of South Viernam's eight point program. On a cloudy Mondy afternoon at approximately 2:00 p.m. John Daniels 39 and his son John Williams 22, took their last automobile ride. The 2 brothers along with sisters Ruth Howard 19, Yvonne Jones and brother Moses McCload were on their way back to New jersey from New York when three plgs of the N.Y. City Narcotics Detective Squad pulled along side their car as they rode down Atlantic Avenue in Brooklyn and told them to pull over. Last week in the trial of Black Panther Party Chalrman, Booby Seale and Sister Ericka Huggins, in New Haven, Connecticur a defense motion to have the jury sequestered during the trial was denied.

The jury will be allowed to read the prejudiced accounts of the case in the paper and listen to racist news commentators give their 'public opinion' as to the guilt or innocence of the defendants, By allowing the jury to be exposed to the establishment press, judge Mulvey, in conjunction with the fascist U.S. government, is insuring the railroad of Chairman Bobby and Ericka to the electric chair. To gather support on a national level, the pigs all across the country have intensified their vecbal defamation and actual harassment of the Black Panther Party.

In the dark hours of this morning, Nov. 23rd,, the Compton pig department raided a house of some members of the Black community, In the raid on the house at 361 W, Fig St., the pigs stole weapons and ammunition. A few hours later, the plg press reported that the pigs had raided the Compton Headquarters of the Black Panther Party and selzed a large cache of weapons, 40 sticks of dynamite and written plans to attack police stations.

This airedged 'Panther fortress' is in no way connected with the Black Panther Party, or our offices, or our N.C.C.F. community centers. By indoctrinating the commonity with this false information, the pigs hope to build support to justify gestapo raids on the Black Panther Party.

By a constant program of intense harassment and character slander against the Party the pigs are waging a frantic propaganda campaign through the press to salvage even an ounce of recognition in the community.

This propaganda campaign is designed to insure the fascist railroad to prisons or gas chambers of all Panthers. When Panthers are constantly being vilified by the press, it is impossible to get an impartial or unbiased jury. Panthers like Ronald Freeman in Los Angeles, Rory Hithe and Landon Williams in Denver, the N.Y. 21, and Chairman Bobby and Sister Ericka in New Haven will never be able to receive a fair trial anywhere in Babylon.

EXPOSING CONDITIONS IN TOLEDO'S LUCAS COUNTY JAIL

Standing at 814 Jackson St. in the heart of the law and order section of downtown Toledo, Ohio, is a infamous building apporpriately named "The Dungeon" by its inhabitants. It is known by uninformed citizens of Toledo as the Lucas County Jail run by Sheriff Metzer.

This jail is over 80 years old and was built to hold a maximum of 150 inmates in 1887. The present total population is over 200 inmates of which approximately 150 are Black. The rest of the inmates are Mexican-American or White. Although the inmates are from different ethnic groups, they all come from the game oppressed class of people in this city and county. So therefore they could not get their stories of starvation atroclous unsanitary conditions, and inhuman treatment, (comparable to a medival dungeon) printed in the power structure's pig news media.

After relating to these brothers for almost a month on the purpose of the Black Panther Party and the voice of the people, the Black Panther Paper, they agreed to tell their stories knowing they would be published in the people's paper. Some of their's and our personal experiences and observations are told factually and truthfully to the people for the first time.

In the maximum security section there are five useable cells with the sixth cell converted into a shower. Each cell is approximately 6'x8' containing two inmates per cell. Sleeping facilities consist of two small steel bunks and a thin filthy uncovered mattress or piece of foam rubber that is passed on from inmace to inmate without any type of cleaning. No sheet or bed covering except one wool blanket per inmate is issued. These bunks must be placed next to each other inside the cell in order to fit, so there is no room to move around.

To use the washbowl or toliet you must walk sideways between the bunks. Two inmates cannot move around without one getting on his bunk to let the other pass. No shelves or space is provided for clothes and personal items. The only space available is under a bunk or on it. Putting necessary items under the bunk is dangerous, because when the toilets leak or overflow as they all do. the things on the floor have to be thrown away after being contami-

Almost all inmates sleep with their personal belongings at the foot of their bunk. Five men are assigned to spaces in the hall of this section. These five sleeping spaces take up the entire length and half of the width of the one area accessible to immates outside the cells. This is supposed to be an excercise area, but because of the overcrowded conditions of this jail there is barely room for two inmates to walk pass each other.

Three of these men assigned to the hall are fortunate to have steel bunks. The other two must sleep on matteresses on the floor. One of those presently sleeping on a mattress is a crippled 73 year old Black man, These five menhave no privacy or toilet facilities. They must use the toilet facilities of the already crowded five cells, which were originally designed for one man per cell.

The size of the portions given in each meal is very small. No seasoning is put in the food and it is served cold. It took a nineday hunger strike and near riot to get a small packet of salt and pepper included with the dinner. Almost all food served is thrown away by the inmates because it is not fit to eat. Candy bars, cookies and milk from the jail's commissary make up the meals of almost all inmates.

All food is served and handled by sentenced inmates who have not had any type of health examination, and are Hable to spread serious diseases. These same men mop the halls and empty the garbage cans of the various cell sections. There is no heat, light or ventilation in this room. An inmate is beaten and stripped naked before he is thrown in the hole. There are no toilet facilities, so an inmate cannot keep clean. All human waste must go on the floor to be sat and slept in, No drinking water other than the water served during the meals can be obtained. The only food served is bread and water.

Women inmates are put in the hole also. If men inmages are in the hole, the guards will either wait till their time is up or let them out and put the women in, If women are in the hole, and they want to put men in there, the method is

While in the hole, if an inmate makes any noise, the guard will turn a high pressure water hose on him. Sometimes they are threatened by a German Shepheard dog. The hole is constantly damp and full of rats, roaches, spiders and all other types of crawling insects which prey on the unclothed Heary Burton, Raymon Gentile. bodies of the helpless inmates.

These are but a few examples of the inhuman, barbaric, brutal treatment suffered by the inmates of this detention center. Most inmates are awaiting ball or on trial. Therefore by the existing constitution are supposed to be innocent until proven guilty. The freedom and right guaranteed in the pigs constitution are nothing but empty promises. All the rights and freedoms of the oppressed people of Babylon have been cancelled out by the existing social and political systems, which the ruling class of American has used the constitution to create and maintain. The ruling class controls the means of production, and the institutions of this country. Seven brothers and eight sisters are being held on charges of marder, conspiracy to commit murder and malicious destruction of police property.

These charges stem from an incident that happened On October 24th when a nine year old youth and 2 members of the N.C.C.F. were severly beaten by the fas' cist pigs The people in the co.nmunity showed their contempt for the pigs by harling bricks and bottles in their direction, In response, the pigs drewtheir gons and began firing into the crowd of people. An exchange of fire took place between the pigs and as unknown assailant. The results were one dead pig and one wounded pig. and a victory for the people,

Using this as an excuse the pigs raided the N.C.C.F. office. The brothers and sisters inside the office relating to Executive Mandate No. 3, defended their home in a confrontation that lasted from 6:00 p.m. to 4:00 a.m. the next morning. The pigs and alerted the national goard and they were about to enforce the McCarran Act. If the whole community would have been armed the cowardly pigs wouldn't have even come into the community brutalizing the people, the brothers and sisters would not be in jail and the people would have had an even greater victory.

As it stands now they are all being held on trumped-up charges. The sisters have ransoms of \$10,000 with 2 sureities, the brofor one brother (Erese wassebail ransom is \$30,000 pus 2 sarcities.

They have all been brura'ly beaten and constantly garassed by the dogs since they have been incarcerated, Cassandra limps, (due to a beating from the pigs). The entire left side of Linda's face is swollen from being beaten; David's face is also swollen, from being beaten, Kim's rightforearm was busted by a pig who stamed a cast fron door on it. And Jerome has severe burns his face, neck, ears and right arm), from a pig trying to set him on fire

They were arraigned in court on the 25th of October and had their preliminary bearing on the 30th of October, A preliminary hearing is held to determine if the pigs have enough evidence to prosecute the defendants.

If there isa't sufficient evidence produced then the defendant is to be released from custody. The pigs realizing that they didn't have any evidence whatsoever to continue the confinement of the brothers and sisters, decided to employ the fascist tactics of "the 17-man citizens grand jury". This grand jury has been given the authority to continue the confinement of the defendant on given word from the police department, "The 17-man citizens grand jury' was ruled unconstitotional by Genesee Circuit Judge Elra H. Papp, Judge Papp ruled against the grand jury lawon three

The first issue deals with the provision in the law that a defense attorney cannot see grand jury testimon from a witness until after that witness has testified at the trial, Judge Pupp found that to the principles of a fair trial".

"Never could I effectively prosecute or defend without thorough investigation, discovery and preparation", she said,

The second issue concerns the right of an accused person to have an effective attorney.

The judge ruled that an attorney cannot be effective when he gets a copy of grand jury testimony during the trial.

"He can neither properly prepare a defense , nor can he recommend to his client that he plead guilty without knowledge of wirat witnesses have said against that client" Judge Papp said,

The third issue involves the denial of a preliminary examination to persons indicated by a citizens grand jury.

"Preliminary examination or at least access to the grand jury transcript before trial is vital for one accused of a crime" she said,

A preliminary examination's purpose is to determine if there is evidence to force a person to stand trial.

Judge Papp said that under the citizens grand jury law, this is done by inexperienced lay people "acting as an arm of the prosecutor".

The pigs are desperately trying to make a case. They have no evidence, since all of the original complaints and warrants have been dismissed. But the fascists are still trying to railroad these prothers and sisters on make believe trumped-up charges. This is just another example of the need for a Revolutionary People's Constitutional Convention

PIGS MURDER UNARMED BROTHER

On the morning of November II. 1970, the Alco Bar on 8th Ave. in Harlem was robbed of \$50.00 and 15 bottles of liquor, A short while later on 123rd Street and Lenox Avenue, Arthur Ross who was running with a case of lignor in his hands was shot 5 times in the head by pigs from the 28th precinct. The brother was unarmed, Arthur's brother, Albert Ross, came to his side when he fell and was immediately snatched up, hardcuffed and thrown into a pig

The pigs sealed off 123rd St. and several pig vans carrying weapoas came into the area. The pigs. suited up in bullet proof vests and armed wit. rifles, began breaking into somes and intimidating people on the streets. They were alledgedly looking for two more robbery suspects who were supposed to have run down 123rd St. The tension in the community began to mount and the people poured into the street and began shouting at the pigs about the murder of Arthur-Ross, At this point, the police called the 'search' off and left the area.

Arthur Ross who lived at 1754 Corliss Avenue in the Broax was

21 years old. Arthur Ross was killed like thousands of other Black youth in Babylon have been, trying to take what he needed. Throughout the ghettos of New York and all of Haby lon the masses of Black youth are engaged daily in a struggle to alleviate hunger in their families, to kill rats and roaches and groud lead poisoning in their homes, Once again the pigs killed another Black man to protect the avaricious capitalist businesses who are robbing the people daily. These types of deaths in the Black community are endless and will continue until the people strike out at the real enemy.

The real enemy is the rich ruling class of America that pays the pigs from Nixon on down to oppress Black people. They pay Nixoa to carry on the war in Viet Nam. They pay the U.S. Senate to write repressive laws; they pay the judges for convictions and fascist railroadings and they pay the plgs to protect their merchants in the Black community.

To end suffering in our lives we must help to get rid of the oppres.

JUDGE MURTAGH AND PROSECUTOR FRANK HOGAN EXPOSED

"He's a haagman, a hatchet man, and a killer. He makes Julius Hoffman look like King Solomon, That's what New York Panther "21" lawyers say about Judge John M. Murtagh.

Before the trialhad started Martagh had been involved in quite a few racist things. He wouldn't let Lee Berry have decent medical attention for over four months wille Lee was held for \$100,000 ransom. Lee has since been severed from the trial, three operations and ten months after his kidaap by New York's finest from Veteran's hospital.

On June II, 1969, an attorney was forced to beg Martagh; "One last request, your Honor. One of the defendants, Mr. Berry, I believe. We attempted to brine him a chance of shirt today, We were told by the Correction Department to bring that up to your Honor's attention as to wnether he may change his shirt. He could not do it earlier, because the Correction Department said that would have to be decided by the Court. We have the shirt with us. And it would be a simple matter just to give it to aim, if your Honor would approve it."

Murtagh replied; "I will allow the management of matters of that kind to be handled by the Department of Correction," (In other words, go deal with the D. of C .

At the same time, the lawyers asked if the "21" could meet together as a group since it was impossible to prepare a defense on a "conspiracy" rap when the Punthers were spread out in dangeous all over New York, Martask refused saying to visit them individually does "require greater effort" but that it could be done. Then he didn't even bother to answer a request that the Punthers

allowed to see their own indictment, which the corrections department refused them.

It took him until November to allow the "21" to meet together for "one hour a week" to prepare their trial.

His own files were used as evidence against him, Murtagh's files showed that top cops had large bank accounts and that plainclothesmen admitted to owning thousands of dollars in war bonds,

In Brooklyn, the eager beaver prosecutor decided he wasn't going to let Murtagh off, Murtagh was brought before Judge Samuel S. Leibowitz and a Grand Jury. (Leibowitz, by the way was Al Capone's lawyer), Lelbowitz asked Martagh why the cops weren't prosecuted when the District Attorney produced volumes of files from Martagh's own office, incriminating the cops, including financial questionnaires from over 500 New York cops.

Each time, he was asked Murtagh denied he knew anything about the rumpant graft.

"Although the accountants broke down these things, that's where the investigation broke down," the prosecutor said.

Martagh almost screamed from the witness stand, "Do you realize many of these men might have inherited that money? Many of them worked years for it? My investigation was exhaustive, but I owed them a common decency and courtesy. I would rather behumane than a dozged, unfair prosecutor."

This is all very strange since he's kept the Punthers juiled for a year without a trial on the assumption that they are "very dancerous people" or like the prosecutor said "They abe Punthers : are not ordinary defendants. They are terrorists.") One can only conclude that the ruling class knows how to take core of its

"I made at least ten a tten reports to the Mayor." Me tagh responded. "I'll tell you, the Pledge matter in Queens, one in the Broax, another to District Attorney Hogan and one in Westchester."

"The Pledge report!" shouted Judge Lelbowitz, "They white washed that one too. That was when Joe Pledge, a hookie, charged a police inspector with taking graft, and they made Pledge the defendant instead,"

Then Judge Leibowitz ordered the files seized, "Have these cards stored in a warehouse for use by the Grand Jury, Under no circum stances are they to go outside of the state" he warned,

Martagh had made a nig thing of his files before Senator Kefauver's racket committee. Ma Bell provided him with duplicates. of all the toll card slips of the big gangsters in the New York-New Jersey area (as thetelephone company often does with communists' and other such incendiaries' phone slips) and Murtagh vaunted the slips before the press and various "investigating committees. But he never did anything about nailing the cops or the gangsters who were stealing from the people.

Leibowitz asked, "Aren't you shocked by these disclosures?" "Yes Judge."

"Of course, you are."

Martagh got scared and figured that Leibowitz was going to expose him, Lelbowitz, by this time, had threatened Murtagh with a contempt of court citation for lying in court, for lying to the press the told reporters that he was just "helping the grand jury investigation" but the grand jury issued a statement (which is very unusual) to the effect that Murtagh was not "helping the investigation" but was, in fact, being investigated himself.

Murtagh started a lawsuit (Martach vs. Leibowitz) to have the case switched from Leibowitz's jurisac diction in Brooklyn to Manhattan where his friend Frank Hogagwas the District Attorney,

Mortagh argued that if he committed a crime, it took place in Manhattan, His evidence? Now Frank Hogan is a very powerful man. He is one of the few District Attorneys in the country who can pick and choose who will try his cases. A perfect example is the Paather case, Hogan wanted Murtagh to try the Panthers and everybody in the courts knew that "Murtagh wants that case," In Manhattan, a case won't go on a judge's calendar until the District Attorney puts it

On the final day of a two-year period for criminal action, the Manhattan Grand Jury pointed out that the "key witness" refused to show up for the hearing. The key witness was Mayor O'Dowyer who claimed he could not come because he was engaged in "secret business" as the Am'assador to Mexico. O'Dwyer skipped out of New York just as soon as it became clear that he was about to be pinched for his super-corrupt administration, lie stepped down from his ambassadorship a few months later but stayed on as a resident of Mexico and set up a little business until the Statute of Limitations for criminal action against him ran out in the early 1960's.

In the meantime, many members of his administration were investigoted, tried and prosecuted for graft and corcuption. Many others left their jobs in disgrace, including top echelons in the police and fire department.

Martagh kept his judgeship after the grand jury "cleared" him. O'Dwyer awarded aim the judgeship in 1950, just before he hopped a plane bound for Mexico. The Grand Jury "cleared" Murtach because they couldn't ansolutely pin the rap on him. They wrote: "We must comment at this time upon the mysterious disappeopulate of numerous documents toom the Department of Investicathor's fales (which Martagh he led . This is obviously not a cuse of even miscellaneous papers hyving been mislaid through mistake or carelessness. On the contrary, the unexplained absence of all documents reflecting addiesce all critical majorial from the files." The report said that while "there is no evidence that defendant had anything to do with this puzzling electristance, the

shocking fact is, however, that not one of these documents, which concerned a most vital phase of the investigation could be located: and that not a single person could be found who could or would supply the slightest clue as to where or how they had vanished."

The Grand Jury report investigating Murtagh continued: "It seems to us that the investigation ordered by Mayor O'Dwyer and conducted by the defendant, was hardly calculated to uproof corruption in the police department. In the first place, the fact that the defendant had been directed to investigate the department was blatantly publicized by the Mayor. The corrupt members of the police department, thus were put on notice of their peril and given an opportunity to cover their tracks."

The Grand Jury continued: "The chances of success" an investigation so instituted might have had certainly been lessened when the defendant failed to pursue leads obtained from the financial inquiries and questionnaires. While there appears to have been considerable endeavor to check the basic statements of the rank and file plainclothesmen, concerning the rank of their asserted assets, no effort was made to ascertain the source of those assets, even where the amounts called for further inquiry."

"Of greater significance is the failure to check the financial Information obtained from the 45 high-ranking officers. The lack of sufficient accounting personnel asserted by the defendant, does not adequately explain his decision to expend months and months of effort in the analysis of the finances of over 300 plainclothesmen, to the exclusion of a less onerous inquiry into the officers of the 45 officers."

The Grand Jury kept right on writing: "Nor is there any persuasiveness in the defendant's contentions that retirements among officers reduced the importance of the investigation, and that he did not, at the time, have a satisfactory questionnaire form available."

The Grand Jury, at this point pointed out that O'Dwyer told Hogan that "highly secret, restricted matters" were occupying his time in Mexico and he couldn't testify about Murtagh and his dealings with him. The Jury wrote; "There is little doubt that the defendant was the Mayor's protege, dependant upon him for political preferment and beholden to him for advancement in public

The Jury said that it had to acquit Murtagh because he said he had talked to the Mayor about the corruption in the cop department and this technically was all that the law required but "This suspicion naturally is accentuated where the Commissioner follows a general practice of submitting written reports to the Mayor then departs from it in a particular instance. The defendant, like his predecessors ... ordinarily submitted written reports but failed to follow that practice with regard to the Police Department investigation."

"From the entire pattern of the investigation and the surrounding circumstances we were thoroughly convinced that, in the mind of Mayor O'Dwyer, the uprooting of corruption in the police department was not, in fact, the true purpose of the investigation".

"Remembering that it was O'Dwyer who promulgated this investigation, that he was unquestionably cognizant of its direction and progress throughout and the defendant's confidential relationship with him, there can be no doubt that the defendant was merely carrying out O'Dwyer's purpose," the Grand Jury stated.


"Illustrative of these ineffectual measures was the highly publicized departmental "shake-up" of August, 1947, which transferred police supervisors of questionable caliber from one locality to another. This more, while stimulating decisive executive action served only to provide different geographic spheres of activity for the same suspect personnel."

One year later, Chief Magistrate Murtagh, back on the bench declared that the time had come for the voters of New York to elect a non-political candidate for Mayor, He cited Frank Hogan, who was running for Mayor, as the type of candidate he had in mind, (Remember that Hogan had just finished "prosecuting" Murtagh the year before).

In 1958, when Hogan ran for Congress, a reporter asked him what his relations with Carmine DeSapio were, He answered "Friendly. I admire the manner in which he has provided leadership and I don't know of any other county leader who has made himself available to the same extent to the press, radio, and television. There is nothing of the backroom character about his operation." Hogan's "friendliness" with



SCHOOL BOARD TRAMPLES ON THE RIGHTS OF 22,000 BLACK CHILDREN

October 1970

The people of East St, Louis, Illinois, are finally beginning to realize the need to implement point 5 of the Black Panther Party, which states that "We want an education for our people that exposes the true nature of this decadest American society. We want an education that teaches us our true history and our role in the present day society."

After countless efforts of negotiations, four nigger lackeys and three waite fascist pigs on the school board of East St. Louis have totally refused to respect the rights of 22,000 black children to have an educatioa. Schools have been closed for about seven weeks with no

UNITED FRONT NEWS RELEASE: end in sight. But this situation only points to the fact that the lying demogogic politicians who control the school system don't care about the black children. The president of the school board is a bootlicking lackey named Charles 'pighead' Merritts, who during the crisis left for a three week tour of Europe on 'doctor's orders'. PIGS CREATE LIE TO ATTACK THE BLACK COMMUNITY

On November 12, 1970, the Black and oppressed community of Carbondale III, was attacked by the pigs. Allegedly the incident crupted when campus security guards. The suspeet (who got away) was supposedly traced to a house in the Northeast section of town, and this same house just somehow happened to contain people who had been working with the Black Paather Party Community Center, which is located one block away. The pigs claim that as their car approached the house, it was fired upon by the occupants of the house However. witnesses state that the pigs attacked the house first using machine guns, shotguns, teargas and other powerful hand weapons, An armored tank was called infromnearby Cairo, (a community which has been attacked many times.

The pigs attacked the house around 6 a.m., applying the same raiding tactics used by Chicago pigs when they assassinated Deputy Chairman Fred Hampton and Mark Clark on December 4, 1969. It was evident from the assault pattern that the pigs intended to murder ormaimall the occupants in the house. State pigs and County pigs, combined with Carbondale pigs and SIU pigs all participated in the attack, Witnesses say that local racists were also involved even though the attack fiself affected not only Black people, but poor white people who live in the area.

The plgs shot holes in people's cars, damaged their homes and property. One brother named Jessie Russell was shot in the shoulder. A sister named Vera Moore, who has ten children and lives next door to the house which was attacked, said that bullets came into her house so fast that she and the children had to lay flat on the floor. The pigs used this attack on the house as a pretext to arrest other brothers in the community who were active in the liberation struggle or worked with the center. Two

brothers were found handcuffed and shot in a ditch, and they are both in critical condition.

During the attack and after, an unidentified man shot at two the entire community was isolsted, no mail was allowed to enter or leave and telephone services were disrupted. It is obvious that the pigs were trying to prevent the correct information from feaving the community.

After a 3 hr, battle the brothers in the house surronded the Community and came forward to insure that the pigs did not murder them. It was reported that previous to the surrender, as soon as the pigs learned that the brothers were coming out, they attempted to disperse the community people, by threatening the people with further

PRESS RELEASE

We, the People's Action Committee, of Frederick, Maryland, write this letter so that you will be aware of how the city and county governments are violating the human rights and dignity of Black people in this community.

We are in hopes that someone will investigate our charges against the local government so that our community can at least stop living in constant fear of the police state in which we are living

The discrepancies we speak of involve, among other things, constant harassment of the community by police officials, improper arrest procedures, on the most irregular, if not illegal charges, and excessive bond being placed on members of the Black community. - The most recent examples of these charges are the following.

Recently in this county a narcotics raid was conducted watchresulted in the arrest of 23 people on narcotics charges, 14 Black people were arrested and 8 Whites. six of these eight Whites had bonds selow 32,000, of the two other Nuites arrested, one had a bond of \$5,000 and one for \$15,000, Committed on next print

These people were arrested before our committee made public a statement questioning the fact that bonds were so low for White people and so high for Black. All Whites with low bonds have been released, most of them on their personal recognizance.

Of the 14 Blacks arrested, 2 have been released on bond, For some strange reason, these 2 Black people were released on low bond with the same charges as the other Black people have on them. This was after our public statement on the matter, However, there are still 12 Black people incarcerated under bonds ranging from \$5,000 to \$45,000 on such charges as being a public nuisance keeping a public nuisance, attempting to distribute cocaine, or possession of controlled paraphernalia,

On the 1st raid policemen entered the house without a search warrant. They searched the bedroom without a search warrant, At that house a young Black man was arrested. He was charged with attempt to sell attempting to distribute cocaine in which there was never any cocaine or any other

On the 2nd raid a home was illegally entered; the policeman forced the door open, This home was also searched without a search warrant. The children were unnecessarily frightened by policemen ransacking the home. A young man and a young woman (pregnant) were arrested. They were charged with distribution of heroin, conspiracy to distribute heroin, and possession of controlled paraphernalia and keeping a common naisance. Combined together the bond was \$50,000. The young woman has been released.

On the 3rd raid the home was entered the same way as the 2nd but then forced the door in the man's face. He was taken off to jail. Bond was set at \$45,000. He was also thrown against the wall and his arm twisted by the policeman asking for information.

On the 4th raid the house wan centered the same as the 2nd and 3rd. A young woman was taken off to jail. Her bond was set at 522,000.

This involved all Blacks and of all Whites that were arrested not one of their doors were forced in.

"I White youth", a policeman's son, this is his 4th arrest. On the first charge marijuana was found in a flower pot growing in his home. On the 2nd it was marijuana and the 3rd arrest he was seized with \$8,000 worth of marijuana, Bond was set at \$2,000. On the 4th arcest he was charged with possession of marijuana, bond set at \$1,000.

in the recent raid, some of the se rch warrants were in direct violation of the 4th and 5th Amendments of the U.S. Constitution.

Defendants were denied their right to see a counsel. They are also denied the right to any visitors. One youth is in solitary. Of all Blacks that are in jail, the courts are giving them a secret speedy trial so they can railroad

This past winter 3 White secretaries were arrested and charged with possessic of \$50,000 worth of narcotics. They were released on \$250 boad, and eventually their cases were thrown out of court. On Nov. 4, a Black man was arrested for assault because he was alleged. to have 'old a narcotics agent on

the 14th of Oct. to stop narassing him, for he knew he was an undercover agent, so just stay away from him. This man was arrested Nov. 4, held incommunicado under \$1,000 bond, tried on Nov.6 without legal counsel, and found guilty. This list could go on and on, like the incident a few months ago where a Black woman who just happened to be walking down the street, was shot in the arm by 3 White men who just didn't have anything else to do. Then the police apprehended these assallants 5 blocks away and told them it would be best if they would leave town aid not to come back for a while

We feel there was a strong element of rucism involved in the arrest procedure, attitudes toward Black arresrees, and amount of bond levied.

We feel these discrepancies should warrant an investigation.

IN FEAR OF VOSTER'S THUGS



These pictures were taken in a Johannesburg street. The Africans were queueing outside a furniture store. A slight disturbance broke out. Instantly, white South African police attacked with dogs.

The cameraman had courage. Photography is a dangerous hobby in modern South Africa. When Johan Smit took an innocuous snapshot of a non-European restaurant, secret police nated down his name and the number of his car.

Smit is a 40-year-old Doctor: Dutch ancestry. English -born, a South African resident since he was 13. Now he lives in London with his wife and small son. They've quit South Africa for ever, sickened by the brutality of apartheid.

But fear remains. Johan Smit is not his real name. He's afraid that if he were identified his relations in South Africa would suffer for his outspoken criticism of the Var-

"It's a nightmare place" he says. "South Africa is the worst police state in the world. Only Nazi Germany was

"I've always had misgivings about apartheid. Under Verwoerd there was a least some attempt at justification: a political philosophy that the races should be kept apart to develop their own cultures. Under Vorster it's lost all semblance of anything but gratuitous brutality.

"You see it in the streets every day. My nine-year-old son watched an African youth beaten bloody by two Afrikaans policemen. It's reflex with them.

"You go to your office and find that one of the messenger boys isn't there. He's been pulled in for not carrying a pass... the police have hired him out to a farmer on the fringe of town. He's kept in a compound under guard, half-starved, working without pay. Technically it's illegal. It happens all the time.

"The government - and the vast majority of people believe in the instrinsic inferiority of the African. They want to see him put down. Whole families die of malnutri-

"If you shoot an African in the street, the police tell you

to drag the corpse into your garden. You won't be arrested. You've found him burgling your home . . . shot him in defence of your property and life.

"I know of an Afrikaans farmer who beat a native to death. The man was disobedient. The farmer put him in a gunny sadk, tied him to a tree and whipped him until he died. That was one case that got into the newspapers. Nabody was particularly shocked...

"In Johannesburg I saw a notive girl being beaten by a group of Africans. Three policemen were standing nearby. They just shrugged their shoulders. They were completely indifferent.

"So I drove to the police station. There was a white woman in the waiting room. When I told her what was happening she just said: 'So what? One kaffir less' "She'd come to inform on a white man for sleeping with a black girl!"

The Immorality Act forbids sex relations between the races. Smit shows you a pile of South African newspapers, all gloating over tragedy. The young couple whose marriage was forcibly annulled, when the wife was found to have Coloured blood. The small girl expelled from school for the same reason. A picture strip shows a white man and two small black children, Headline: The sex-buster ... and two kids for forbidden love. Caption: Ace Immorality Act cop Sergeant Piet Ras and the two Coloured children of so-and-so both parents were jailed.

"To sleep with a native girl is like sleeping with an animal", says Smit. "That's how the Boer thinks of the African. It's a criminal offence. And there are plenty of informers. Men have been known to blow their brains out rather than face charges under the Immorality Act.

"At the weekends you get gangs of drunks going through the border into Swaziland, where they can get sex without getting arrested.

"The newspapers are crammed with propagando. The Rand Daily Mail is one of the few free-speaking papers in the country, and it has to fight like hell to stay that way. Television is banned. It's said to be a corrupting influence. They're afraid of broadening the consciousness of

"The South Africans think England is degenerate. That it's betrayed the white man. They see themselves as the true saviours of white civilisation. The last bastion of Christian virtues. They find excuses for apartheid in the

"The chairman of the South African Broadcasting Corporation has a son named Izan. It sounds like a nice Old Testament name. Until you spell it backwards.

"Many Boers wanted the Nazis to win the war. Hitler's racialist policy agreed with their own. They used to beat up their own soldiers who'd enlisted to fight Germany. Today the police wear blue-grey uniforms like the Wehrmacht. There's a Superman complex. Johannesburg is full of weight-lifting clubs, ju-jitsu clubs.

"As a matter of fact Johannesburg is grotesque. The last bastion of civilisation? Certainly, if you equate civilisation with juke-boxes and drive-in cinemas and an astronomical divorce rate. Everything's a pale copy of America. Civilisation . . . if you don't notice the police beating up old native women and the black children trying to sell flowers when they should be at home in bed.

"The whole country is mentally under siege. They're terrified that the guerillas may come down from the north. It's almost impossible for an able-badied man to leave the country between the ages of 18 and 28. He has to be ready to fight in the Defence Force. They're marching against the flood of history. They can only hope to keep the Africans down by strengthening the police force.

"It's a police state. But that doesn't mean that the police will go into action if you have a burglary. They're absolutely inefficient as for as normal police duties are concerned. But they'll always be there to see the blacks have their passes, that they don't go in the subways reserved for Whites.

"South African whites are completely brainwashed. They can't talk about anything except rugby and servant trouble. That's why sport is so important to them. They

haven't got anything else. The anti-Springbok demonstrations hurt them very much. It's a pity Britain has to suffer. But thank God somebody is making an effective protest. I've left for good now. My only regret is that I didn't leave sooner. There's a new brand of refugee today. People like me, who have grown to detest the way of life in South Africa.

"We don't pretend that all black men are saints. But they're human beings. The way they're treated is inhuman. They're harassed and hounded all day and all night.

"The white man is dragged down too. He's besmirched by association with this regime.

"To live in South Africa today is to be degraded."

Comrade Dos Santos spoke to SECHABA in Rome while attending the recent international conference in support of the liberation fighters of the Portuguese colonies.

He said: "Since we are engaged in an armed struggle we require armaments, uniforms, and so on, but then there is also the work in the liberated areas which involves education, health and production.

Of course everybody cannot give arms but there are those who can. We have real needs in this sector, therefore material assistance must cover military aid. There are the Socialist countries who can do this and they do it. With uniforms its the same. On the level of National Reconstruction we have programmes for education, for health and production. For example in the programme of education in our country, we have to develop primary education, create new schools. produce new books for the pupils, increase the stocks of books, organise training courses for new teachers, improve the level of existing teachers, and expand literacy classes for adults. We also have other sectors of higher education for "cadres", mechanics and other technicians for which we do not have sufficient material means at present, particularly for nurses, electricions, etc.

CADRES

The formation of "cadres" is a difficult problem since we depend on certain material resources which are not always easily obtainable. There are two solutions: either we organise it ourselves with financial assistance or we send the trainees to other countries. The guerillas have undergone such courses in the countries where they troined. What we now want is to do these programmes ourselves in accordonce with our needs. We therefore need external aid and we don't know to what extent non-governmental organisations can help. We have found that political organisations and committees of support have great difficulties in finding material resources to help in such programmes, but it is not impossible. It means hard work and the mobilisation of individuals and organisations which are not in direct contact with us. We have already certain religious organisations from which we receive substantial assistance. In our health programme we have a real need to greatly improve our hospitals which are in the bush. Conditions are very poor and there is a great shortage of medicines.

Then we have programmes for the increase of production because we want to produce as much as we can for ourselves by our own labour. We also want to improve the quality of this production, by improving the techniques used and by diversification.

We have a special section dealing with these aspects, but it is not yet of a very high standard. We have a section of production and commerce and we hope to develop it into

you started the guerilla action? What was your "modus operandi"?

Dos Santos. When FRELIMO was areated we were almost completely convinced that only an armed struggle would allow us to fulfill our aspirations. We did not make a great discovery, in reaching this conclusion, as Angola had already started, and Guine as well. It was therefore not difficult to see that the Portuguese Government would not reserve some special treatment for the people of Mozambique. Nevertheless we were trying to create the minimum conditions for embarking on this armed struggle. At our congress in September 1962 we had no idea when we would start. But we set ourselves a number of tasks; first, to consolidate the organisation inside the country, the political organisation.

Were the people in the north of Mocambique well politicised before this stage? Had they participated in any kind of political movement before you started laying the basis for the armed struggle?

There were small groups which had been formed after the last war, to be more exact from 1948-49. They were spread quite widely, particularly in the towns, all clandestine and unknown to each other.

IN THE COUNTRYSIDE

But in the countryside?

First they grew in the towns but certain other movements. such as the cooperative cattle movement, were formed in the countryside. They were not at first a political movement but the nature of Portuguese Colonialism forced them into political commitment. There were conflicts with the Administration and the disputes became political. But it was the little groups I first mentioned which had clear political objectives. From 1955 some of these groups learnt about each other and linked up. In this way the political work progressed. There were also organisations such as the Mazambique African National Union which organised in the North at Cabo Delgado, or the Democratic union of Mozambique, formed, around 1960 which organised in the provinces of the centre and the South, But it is in the Northern district that important work was done. All these groups were inherited by FRELIMO, as most of the comrades who worked in these groups in Mozambique left for Tanzania ofter independence and arrived there after November 1961. These comrades had contacts with the external organisations who managed to organise the meeting of 25th June 1962 and then the Congress of September 1962

FRELIMO proceeded to consolidate them into a network inside Mozambique whilst defining the tasks of the new organisation.

MILITARY CADRES

While carrying out this mobilisation for armed struggle and structural activity we were also organising the training of military codres.

As early as 3rd or 4th January 1962, that is only three months after the Congress, the first group of 80 comrades left for Algeria to learn the art of guerilla warfare. Later we sent other groups to Algeria where about 250-300 guerillas were trained. When we had the minimum military organisation to launch the armed struggle we turned our attention again to the problem of the political structure which would support a minimum military network.

The problem was to establish what was a minimum military organisation - how many comrades? Further, it was not possible to determine the level of political consciousness necessary to support armed struggle. We also realised that it was not possible to develop a strong political organisation under a fascist system. You may have a clandestine political network but at a certain level it becomes vulnerable to enemy action. We therefore created the minimum network to give assistance to the fighters, by supplying food, organising hiding places and to give information to the guerillas. We then felt that it was through the armed struggle that the political organisation would grow.

So at first there was only the political network, then, when our comrades had trained in Algeria we had a military organisation which was received everywhere by the political wing. We then started our action in Cabo Delgado, Nyassa. Zambesi and Tete. But we were forced to stop the action in Tete and Zambesi in July 1965 because of insufficient supplies.

I must say that the political work was essential, the armed struggle being only an instrument, a tool. But it is now the principal action for independence. Others have had to mabilise the masses as their principal action towards independence, but for us it has been the armed struggle, whilst political work has not been neglected and is a determining

NEW CONDITIONS

What was the effect of the armed struggle on the political work? Was there higher morale?

The start of an armed struggle created new conditions for a new development of the political organisation. Under a fascist colonial system there are many militants who are not sure of the other militants. They are not sure who is with or against them. Because conditions are so difficult. people don't trust each other. When the armed struggle starts, two camps are established; the one who shoots at the Portuguese can surely not be on the wrong side. We then have a sure test. Whilst at the stage of political organisation, people are never sure even when somebody makes the right political statements, but when he fires on Portuguese troops and kills them you know who to trust. Secondly this military action creates the conditions for cleaning up and detecting the enemy elements and to destroy them, thereby creating new conditions for more efficient action by the organisation. This is how the armed struggle contributed to the political network

DOS SANTOS THEN DISCUSSED POLITICAL-MILITARY ORGANISATION IN MOZAMBIQUE

When you made the recent attacks in Tete did you prepare the ground with political work there too or was it a question of the "focus" opening the way?

In our work at the beginning of 1962, we started with the organisation of the political network. At that time there was no military organisation, so it was purely political work. Then when the comrades returned from training we had two sectors: the sector of political work and the one for military work. We tried to establish a coordination between the two but this was not always easy. Its not easy to say exactly why and to establish the link between all the factors. The people who made up the political network inside did not always have the highest political understanding. These were the people who had established little groups even before the formation of FRELIMO.

These organisers gained the respect of the people but they did not have any military training whilst those who had undergone guerilla training had also acquired political knowledge, and we were to find later that the latter were the best militants of FRELIMO, the true interpreters of FRE-LIMO policy, when the armed struggle was launched When the comrades of the military sector arrived they were placed under the authority of the political organisation which gave the orders. But new problems grose with the armed struggle and the political organisation could not solve them. At the same time the population were saying that it was the military wing which was killing the Portuguese, not the political wing and this gave immediate prestige to the military wing.

The Chairmen, because of their lower political understanding, thought that the armed struggle would be short, leading to independence.

They believed that in the independant Mozambique under FRELIMO they would be the leaders of the new administration. Many of them began to behave as traditional chiefs. We must admit that the blame for this situation must be borne by the leadership of FRELIMO for failing to foresee such a situation. It was not the fault of the people but of the FRELIMO Command. We did not foresee these revoluntionary problems and conflicts developing.

PROBLEMS AND SOLUTIONS

Once these conflicts came into the open we had to analyse the situation and impose certain solutions. This we did. But certain of the comrades had wrong conceptions about the Chairmen, in spite of their inability to govern the liberated areas. The population was always asking for solutions to problems such as how they were to obtain clothing etc after the departure of the Portuguese.

At this stage did the peasants feel that they were gaining from their new freedom?

Well, there was no more tax to pay, but where to get clothes, where to get soop? In 1965 we had not yet made provision for this. But the fighters had a good understanding of the situation and this was natural because they were forced to have this full comprehension of the problems. They understood that in the fight against the Portuguese they had to kill the soldiers or they would be killed: they were also forced to discuss and understand what relation they should have with the people.

But the population themselves; there must have been some conflict in their minds between the material conditions under the Portuguese and the new situation, and they had to choose?

They chose the bad conditions.

Why? What factors helped them to choose?

Just one at the beginning - freedom. They said we have nothing but we are free. But to be realistic this stage could not last long. There had to be something else. We had to satisfy their needs. But where to obtain clothes? And other materials? We knew that whatever our efforts we would not be able to supply all their requirements in this field. Therefore we were forced to give them something else - o political awareness. We had to develop political mobilisation. It was simply impossible to satisfy all the material needs. We had to explain this and show that we were creating conditions for improving the situation very quickly.

Were the conditions very bad at this point?

Yes, we had many cases where people went back to using bark to clothe themselves. But we explained to the people that it was a new situation for everybody and that we were trying to find solutions.

What about the urban groups during this period? Was there also struggle in the urban areas or not?

In the towns we only increased the pressure of the clandestine movements but did not take any military action.

HE PRESERVATION OF LEADERSHIP

To turn to another question, what is your policy on the question of preservation of leadership? Clearly a movement has to preserve its experienced codres, this is an objective requirement, but at the same time there is a necessity to involve the leadership. What is your policy on this question?

Earlier we were talking of the political problems and we said that at the beginning we had two sectors and that we had many problems. We had to solve these problems by putting into practise our ideas of a guerilla movement: namely that everyone is a political codie and yet everyone is also a fighter. But one must determine the tasks for each sector - for example what are the tasks of the guerilla? First to fight then mobilise the population, then to produce. What is the task of a peasant? First to produce, then fight in self-defence, and defence of the region where he is. For the teacher, his first task is to teach, then mobilise, then produce. The medical orderly, what is his task? First to treat patients, then produce, then fight. Everybody has a common task which is production. At every school there is a field for production, also in every base, in every haspital It was established that this was necassary. But conditions differ greatly. When we wanted to re-start the fighting in Tete recently, we sent comrades who already had a politica-military formation. But there were islands of mobilised people in certain areas where the terrain was not favourable to an armed struggle. On the other hand where people had not been mobilised the terrain was favourable to guerilla action. With the help of the politicamilitary codies we were able to detect the most favourable points for military action in the Tete province and carry out a simultaneous mobilisation of the population in these

pose the practical solution of the politica-military codre. We realised that there our tasks were really new. We observed that the problems were quite unpredictable, and we learnt that one must be attentive to all the phenomena and problems as they arise. This means that there must be comrades who are able to detect the problems quickly by observing and understanding the situation. This can only be done by responsible leaders being in the area. This is absolutely necessary. If we can then accept the idea of politico-military codres and the need for the presence of responsible leaders, we can then talk of the preservation of the leaders. The requisite vigilance which must be assured but in the battle area, this is where it must be done. Every leader of FRELIMO has a security curtain around him, but

Did you have any requests from the people in the South to introduce guerillas to fight for their defence?

Yes, we had our organisation in the South, clandestine and political, and the comrades trained in Algeria went to the South in 1964.

bique, South Africa will do it. They say it openly. South Africa is at present an Imperialist nation in Southern Africa and unless she changes her present policies it is SA which will be the great enemy of everybody. Portugal will be the secondary enemy. We are now fighting the Portuguese but it is South Africa which directs the strategy and determines the policy. So you see your struggle as a protracted wor, with a steady increase in territorial power in Mozambique, but at the same time a situation of constant struggle until the whole of Southern Africa is free?

I agree with this perspective. And this points to certain responsibilities which we must shoulder to create greater. cooperation. We must learn to coordinate our action to face the enemy and assume our historic responsibilities.

Without any doubt Tanzania and Zambia plcy an important role but at the present stage of our struggle I think that even if the border with Tanzania was closed, we would not stop our fight. Why? because the resources of our struggle are now very large. Our ability to create at this stage are very good.

It is possible to break through any such barrier and I must say that we would be able to stop the creation of a barrier. Furthermore there are other ways of assuring supplies.

Do you use the coast at all? Are you able to penetrate to the coastline? I understand that some coastline forts have been attacked by FRELIMO forces, have you been able to get to the sea and have you been able to establish some permanent presence on the coastline?

What reports do you get from inside on the SA economic and military presence in Mozambique?

The information which we have is that South Africa is trying to consolidate her position in Mozambique by investing in companies and also by direct military intervention. For example there are SA battalions at Fingue and Chiane.





What We Want What We Believe



Huey P. Newton Minister of Defense Black Panther Party

1. We want freedom. We want power to determine the destiny of our Black Community.

We believe that black people will not be free until we are able to determine our destiny.

2. We want full employment for our people.

We believe that the federal government is responsible and obligated to give every man employment or a guaranteed income. We believe that if the white American businessmen will not give full employment, then the means of production should be taken from the businessmen and placed in the community so that the people of the community can organize and employ all of its people and give a high standard of fiving.

3. We want an end to the robbery by the CAPITALIST of our Black Community

We believe that this racist government has robbed us and now we are demanding the overdue debt of forty acres and two mules. Forty acres and two mules was promised 100 years ago as restitution for slave labor and mass murder of black people. We will accept the payment in currency which will be distributed to our many communities. The Germans are now aiding the Jews in Israel for the genocide of the Jewish people. The Germans murdered six million Jews. The American racist has taken part in the slaughter of over fifty million black people: therefore, we feel that this is a modest demand that we make.

4. We want decent housing, fit for shelter of human beings.

We believe that if the white landlords will not give decent housing to our black community, then the housing and the land should be made into cooperatives so that our community, with government aid, can build and make decent housing for its people.

5. We want education for our people that exposes the true nature of this decadent American society. We want education that teaches us our true history and our role in the present-day society.

We believe in an educational system that will give to our people a knowledge of self. If a man does not have knowledge of himself and his position in society and the world, then he has little chance to relate to anything else.

6. We want all black men to be exempt from military service.

We believe that Black people should not be forced to fight in the military service to defend a racist government that does not protect us. We will not fight and kill other people of color in the world who, like black people, are being victimized by the white racist government of America. We will protect ourselves from the force and violence of the racist police and the racist military, by whatever means necessary.

7. We want an immediate end to POLICE BRUTALITY and MURDER of black people.

We believe we can end police brutality in our black community by organizing black self-defense groups that are dedicated to defending our black community from racist police oppression and brutality. The Second Amendment to the Constitution of the United States gives a right to bear arms. We therefore believe that all black people should arm themselves for self-defense.

8. We want freedom for all black men held in federal, state, county and city prisons and jails.

We believe that all black people should be released from the many jails and prisons because they have not received a fair and impartial trial.

9. We want all black people when brought to trial to be tried in court by a jury of their peer group or people from their black communities, as defined by the Constitution of the United States.

We believe that the courts should follow the United States Constitution so that black people will receive fair trials. The 14th Amendment of the U.S. Constitution gives a man a right to be tried by his peer group. A peer is a person from a similar economic, social, religious, geographical, environmental, historical and racial background. To do this the court will be forced to select a jury from the black community from which the black defendant came. We have been, and are being tried by all-white juries that have no understanding of the "average reasoning man" of the black community.

10. We want land, bread, housing, education, clothing, justice and peace. And as our major political objective, a United Nations-supervised plebiscite to be held throughout the black colony in which only black colonial subjects will be allowed to participate, for the purpose of determining the will of black people as to their national destiny.

When, in the course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume, among the powers of the earth, the separate and equal station to which the laws of nature and nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

We hold these truths to be self-evident, that all men are created equal; that they are endowed by their Creator with certain unalienable rights: that among these are life, liberty, and the pursuit of happiness. That, to secure these rights, governments are instituted among men, deriving their just powers from the consent of the governed; that, whenever any form of government becomes destructive of these ends, it is the right of the people to alter or to abolish it, and to institute a new government, laying its foundation on such principles, and organizing its powers in such form, as to them shall seem most likely to effect their safety and happiness. Prudence, indeed, will dictate that governments long established should not be changed for light and transient causes; and, accordingly, all experience hath shown, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. But, when a long train of abuses and usurpations, pursuing invariably the same object, evinces a design to reduce them under absolute despotism, it is their right, it is their duty, to throw off such government, and to provide new guards for their future security.

RULES OF THE BLACK PANTHER PARTY

NATIONAL HEADQUARTERS 1048 PERALTA STREET OAKLAND, CALIFORNIA

Every member of the BLACK PANTHER PARTY throughout this country of racist America must abide by these rules as functional members of this Party. CENTRAL COMMITTEE members, CENTRAL STAFFS, and LOCAL STAFFS, relading all captains subordinate to either national, state, and local leadership of the BLACK PANTHER PARTY will enforce these rules. Length of suspension or other disciplinary action necessary for violation of these rules will depend on national, state or state area, and local committees and staffs where said rule or rules of the BLACK PANTHER PARTY WERE VIOLATED.

Every member of the Party must know these verbatum by heart. And apply them daily. Each member must report any violation of these rules to their leadership or they are counter-revolutionary and are also subjected to suspension by the BLACK PANTHER PARTY.

THE RULES ARE:

- 1. No Party member can have narcotics or weed in his possession while doing Party work.
- 2. Any Party member found shooting narcotics will be expelled from this Party.
- 3. No Party member can be DRUNK while doing daily Party work.
- 4. No Party member will violate rules relating to office work, general meetings of the BLACK PANTHER PARTY, and meetings of the BLACK PANTHER PARTY ANYWHERE.
- 5. No Party member will USE, POINT, or FIRE a weapon of any kind unnecessarily or accidentally at anyone.
- No Party member can join any other army force other than the BLACK LIBERATION ARMY.
- No Party member can have a weapon in his possession while DRUNK or loaded off narcotics or weed.
- 8. No Party member will commit any crime against other Party members or Black people at all, and cannot steal or take from the people, not even a needle or a piece of thread.
- 9. When arrested BLACK PANTHER MEMBERS will give only name, address, and will sign nothing. Legal first aid must be understood by all Party members.
- 10. The Ten Point Platform and Program of the BLACK PANTHER PARTY must be known and understood by each Party member.
 - 11. Party Communications must be National and Local.
- The 10-10-10-program should be known by all members and also understood by all members.
- All Finance officers will operate under the jurisdiction of the Ministry of Finance.
- 14. Each person will submit a report of daily work.
- Each Sub-Section Leader, Section Leader, Lieutenant, and Captain must submit Daily reports of work.
 All Panthers must learn to operate and service weapons
- 17. All Leadership personnel who expel a member must submit this information to the Editor of the Newspaper, so that it will
- 18. Political Education Classes are mandatory for general membership.

- 22. All Chapters, Branches, and components of the BLACK PANTHER PARTY must submit a monthly Financial Report to the Ministry of Finance, and also the Central Committee.
- 23. Everyone in a leadership position must read no less than two hours per day to keep abreast of the changing political situation.
- 24. No Chapter or Branch shall accept grants, poverty funds, money or any other aid from any government agency without contacting the National Headquarters.

 25. All Chapters must adhere to the policy and the ideology




