PHYSICIANS DESPAIR

Rome, Nov. 9.-Unable to stand the confinement of the vatican, Pope Pius X., is slowly wasting away. This the opinion expressed today by Dr. Lapponi, in the first official announcement made in regard to the pontiff's health.

"AN EYE FOR AN EYE" BY G. S. DARROW

The Story of a Condemned Man's Last Night on Earth.

"I was so scart I didn't care much what they done, so when the one in front asked me to surrender or he'd shoot, I come out to where he was, and he put his hand on me kind of rough and said I was under arrest for bein' a tramp, and to come with him.

Then he took me back to town with all the men follerin, and when we got up into the edge of the place 'most all the boys, black and white, turned in and follered, too. They took me to a little buildin' over on the side of the town, and went downstairs into the cellar and opened an iron door and put me in-There wa'n't no light except one window which was covered with iron bars, and they locked the door and went away and left me there alone."

"I was locked up in the cellar for a long time before anyone came to talk with me. I looked hound to see if there was any chance to get out, but I seen it couldn't be done. I thought it wa'n't hardly worth while to try. Honestly it seemed a kind of relief to be ketched, and know I didn't have to run any more. I didn't know why they arrested me, but I s'posed they just thought I'd done something ,and they'd try to find our what it was, so I thought about what I'd do, and made up my mind I hadn't better say much. rtal.

After a while some fellers come down to see me and took me up in the office. One of 'em was the marshal and another was a lawyer or police judge or some thin' of that kind. They said they wanted to fill out some sort of a paper about who I was and where I come from and what my business was, and who my father and mother was, and what my religion was, and whether I ever drank or smoked rigarettes, and the color of my bair and eyes, and how much I weighed, and a lot of things like that. So I told 'em I was from St. Louis, and guessed the rest of the an swers the best I could. Only I told 'em I never knew who my father and mother They wa'n't satisfied with my antwers and fired a lot more questions at And then they told me they thought I lied, and they'd put mesin the lock-up until mornin, so they put me back there and give me a plate o' scraps supper, and a straw bed to sleep on and then went away.

"Somehow I slept better that night than I had since I'd run away. I rather thought it was all up and only a question of time when I'd get back here. but I knew where I stood and wa'n't so scart. I've slep' time ever since I was here, only the time when the Jury was out and when I was waitin for the Su-preme Court, and some special times like that. As near as I can find out most of does when they knew it's all off, just like people with a cancer or consumption, or with they're awful old. They get used to it and sleep just the inless they have a pain, or somethin'. They don't lay awake thinkin' they're goin' to die. And after all, I guess if people done that there wouldn't any of 'em sleep much. For 'tain't very long with anybody, and bein' sentenced to death ain't much differ'nt from dyin' rithout a sentence. In one way ever'ody's sentenced to death. Of course, I ose it's a little shorter, and still that ain't always the case. There's two fellers that I knew died since I come here; one of 'em had pneumonia, and the other was a switchman that thought the engine was on the other sidetrack. John Mur-phy was his name. Still-I guess my time's pretty near come now.

"Well, in the mornin' the marshal came in and brought me some breakfast. Then he took me up to the office again. He waited a few minutes until the judge come, and then they commenced firin' questions at me. They asked me how I got from St. Louis to where I was. That kind so puzzled me, for I didn't exactly know where I was. I answered it the best I could; but I know I didn't get it right. They told me I hadn't got over lyin' and I'd have to be shat up some more. Then they asked me what public buildin's there was in St. Louis. I made a guess and told 'em the courthouse and state-house. They langhed at this and said St. Louis wa'n't the capital of Missouri. And of course I didn't argue with em about that. Then they wanted to know how I come there and I said I walked. And they wanted to know what places I come through and I couldn't tell 'em. You remember the time? I wish now I had. He didn't pay any attention to this, but wired to Chicago, givin' a full description of me. He nee'n't worried so much, for I was clean tired out and discontaged, and I felt better in there than I had any time-since I killed her. Bein out of jail ain't necessar'ly liberty. If you're 'fraid all the time and have got to dodge and keep hid and can't go where you want to and are runnin' away all the time, you might just as well be shut up, for you ain't free.

"Soon as the marshal found out who I was, it didn't take the news long to trevel round the town, and it seemed as if ever one there come to the lock-up to see me. The boys used to come up round the windows and kind of stay back, as if they thought I might reach out and ketch em, but I always kep as far away as I could. Then the people would come down with the marshal to the cell when he brought my supper and look in at me to see me eat, and try to get me to come up and talk to 'en and watch me same as you've, seen em look at bears when they was feedin up at Lincoln Park, and thry'd point to me and say. "That's him; just see his for head. Wouldn't I hate to get caught out alone with him? Anyone could see what he is by lookin at him. I bet they make short work of him when they get him to Chicago!" I always kep back as far as I could for I didn't want to be seen. No one had ever looked at me or paid any attention to me before, or said anything about me, and I hadn't ever expected to have my name or picture in the paper, or to have people come and see me, and anyhow not this way.

"Of course, I knew well enough that it wouldn't last long, and that they'd be here for me in two or three days. I can't tell you just how I felt. WHOLESALE BRIBERY **FAILS TO WORK**

Street Railway Withdraws 3-Cent Fare. Votes Cost \$25 Apiece.

[Scripps-McRac Press Association.] Detroit, Mich. Nov. 9 .- The Detroit United Street Railway at midnight withdrew the cheap tickets which it placed on sale two weeks ago in an effort ro convert Detroit into giving it a ne franchise and amonifeed that it would receive the tickets already out until November 15, after which it will redeem them for what the purchasers paid. The complete returns show the defeat of the franchise was more decisive than even its opponents had expected. There were 13,316 for and 28,833 against. Thompson's majority for mayor is 3,341. There is a probability that Mayor Codd and the Republican council may attempt to forestall Mayor-elect Thompson in reaping the fruits of his victory by attempting a settlement with the street railway company between now and Jan. 1, when Thompson takes hold.

To Submit New Proposition.

It is already rumored that the company will submit a new proposition embracing a three-cent fare with the sanction of the mayor, and that the council will likely approve it. This is somewhat improbable, however, as most of the aldermen are pledged not to grant a franchise without its approval by the people and there would be no opportunity to get such approval in time. FEW PENNIES TO QUIET MEN; STOP UNREST!

Corporations rear Workers Will Become Dissatisfied and Take the Government.

THROW OUT PROFIT CRUMBS

Will This Benevolence Make Wage Earners Satisfied?

Frightened at the rising tide of unrest, the great capitalists of America have decided to disgorge a portion of their spoils in the hope of thereby retaining the remainder.

In the midst of the greatest business activity ever known in history, when even the most hopeless corporations are paying dividends, when profits and surpluses are rising to a height that makes them a troublesome embarrassment to directors, with prices of all commodities soaring skyward, wages have remained at the standard set during the panic years of the '90's.

An Impending Panic.

Already the signs of a surplus began to appear It became evident to the more far-seeing of the industrial kings that it would soon be impossible for the wage-workers with their insignificant incomes to buy back the tremendous flood of commodities they were creating at the high prices which were maintained. All possible schemes were first attempted to dispose of this surplus before the idea occurred to the masters of industry that it might be shared with their employes by raising wages.

The Russo-Japanese war gave a mome itary respite. The Panama canal is looked to for another. In both of these enterprises great amounts of the surplus value taken from the workers can be absorbed, and the panic thereby post-

Cost of Living Highest for 20 Years.

The Dun Commercial Agency and nounces in its regular bulletin that the cost of living had reached the highest point for twenty years. When it is remembered that Dun does not take rent into consideration, and that this item, which is usually the largest in the wageworker's budget, has increased at an even more rapid rate, the need for some sort of action to stay the impending storm is evident.

The Threat of Revolution.

Moreover, the workers have refused to keep quiet under these conditions. Everywhere signs of a coming revolt are evident. Never has there been as much unrest as at present. This has not expressed itself so largely in strikes as in previous years. There has rather been a tendency to strike at the whole system. This has expressed itself principally in the amazing growth of a conscious and

Throw Out a Sop.

So it has been decided to throw out All the great corporations that make up the community of interests which rules America have decided to toss a few pennies to their army of workers, hoping thereby to keep them quiet.

The Standard Oil Company, as bees the king, leads the way. The United States Steel Company, next in the order of industrial precedence in the nobility of plutocracy, follows with an ment of a uniform increase in wages for its host of workers. Then comes the Philadelphia and Reading, exercising its "divine right" of benevolence to its vassals. After this comes, still in strict order of precedence, the Vanderbilt railroad system, and following that all "he lesser lights of the industrial nobility are supposed to follow

The union will meet Sunday and make plans to get concessions from the employers.

Butchers' Union Grows.

Meat cutters and butcher workmen are growing stronger, according to M. Donnelly, president and organizer of the Amalgamated Meat Cutters and Butcher Workmen of America.

"We have had a particularly success ful summer in organizing unions of butcher workmen," Mr. Donnelly said. "Unions of butcher workmen have been organized in especially large numbers in Indiana, Illinois, New York and Kentucky."

"The men organized are in every case those working for independent packing companies. The beef trust is still holding a club over the heads of the workmen. Any man joining the union is promptly discharged."

Organize a Tenants' Union

Tenants, the flat dwellers and "roomers" should form a union. Landlords have the Real Estate Board and numerous protective associations.

They guard their interests in the city council and in the legislature. While these powerful land owners unite for greater strength, the 'independent" renter stands alone in his weakness. If he complains that the flat is not kept warm according to contract, he has no recourse but to

move, if the landlord does not give him heat. If he cannot pay his rent he is blacklisted. Rent can be raised and he has to stand the increased cost of living. Twice a year is witnessed the

vain quest of the tenant class for a "good landlord" and an "ideal flat." This search will never end, but tenants can organize a union that will

be stronger than any landlords' association. It will have a law department that will "litigate" for the rights of tenants until the landlord has all the law he wants.

With its strong legal bureau it will have a tireless machine to prosecute building owners that keep insanitary tenement houses and let rooms get cold and cause children to sicken and die. It will stand between the landless man and the landlord.

The usefulness of such an organization of tenants cannot be measured until it becomes a reality. The columns of this paper are open to any renter that wants to say a word about the "National Tenants' Union." After a few days of discussion the first Chicago local will be organized and tenants will be brought to a realization of the class struggle.
