The fundamental principles upon which the seals are sold are two: First, that all money derived from the sale shall be devoted to anti-tuberculosis work; and second, that this money shall be spent in the community in which the seals are sold are sold. The American Red Cross, therefore, acts simply as a central supply and distributing agency.

ANTI-BREAD TRUST CAMPAIGN

A well attended joint meeting of the Anti-Bread Trust Campaign Conference of New York, New Jersey and Connecticut, the Joint Executive Board of Greater New York and the German Agitation Committee (all of the Eakery and Confectionery Workers' International Union of America), was held on October 5, at headous was held en October 5, at headquarwas held en October 5, at headquar-ters, 240 East 80th street. The pres-ent delegation consists of a body of fair-minded hard workers for their causs, which is nothing but a fair one. International Representative Henry Koch assured the delegates that the international will assist this section so as to be successful in the work. International Organizer Kerker was unable to be present, having important work to attend to at Poughkeepsie, N. Y., but submitted a plan and promised to attend the next meeting of the body to lead the organization in its work. Word was recevied from the Central

tion has declared for the open shop," that "all bakery products not tearing the union labe! be placed upon the unfair list of organized labor, espe-cially the products of the Ward Bread Company, known as "Tip Top," and the Corby Yeazt, the Shults Bread Com-pany, known as 'Mother,' 'Home Made' and Bronx Bread; the General Bak ing Company, known as Buster Brown, Butter Crust, Butter Nut. 'Honey Bread,' 'Pan-Dandy' and 'Ted

A report was received from all over this section that the Bread Trust, which manufactures all this fancy named non union bread, is trying not only to destroy the Bakers' Union and the smaller bakeries, so as to get con-trol of the bread market, but to do the same as other trusts are doing to raise the price of this necessity, and to cut down the wages \$2 to \$4 a week. #### WHEN THE CAT'S AWAY, THE MICE PLAY

The humorous "troubles of Mr. Bowser," the fatuous figure whose domestic afflictions have formed for years a standing diversion for the readers of provincial newspapers, are as nothing com-pared with the political troubles of that clown of politics, William

That celebrated lightning change artist has for some time past been in Europe, and in his absence his "Independence League" has been doing some unwarranted stunts on its own initiative.

A short time ago it indorsed the candidacy of Bull Mooser Straus on the Progressive ticket, at the instigation of a local politician named O'Loughlin. Immediately afterward a message was received from Hearst in Europe which contained a specific indorsenent of Sulzer, who is the Democratic nominee for the same office

And now explanations are in order as to why "Mr. Hearst's convention went contrary to his wishes," as the reports have it. Probably the League in Hearst's absence was trying to do something to justify its title of "independent," that is, independent of Hearst.

Mr. O'Loughlin "does not wish to defy Mr. Hearst," but is of the opinion that the latter has been misinformed about Sulzer, and that he will change his mind when he hears the Straus side of the question. Maybe he will, and then, again, maybe he won't. idea of an "Independence League" taking on itself to do anything without the Hearst sanction, or contrary to the wishes of that champion of independence, is too serious a matter to be lightly passed over. The mere change in itself is nothing, but changing without Hearst's permission is contrary to all ideas of what a real "Independence League" should be.

However, Mr. Hearst will return next week and will dictate all necessary future changes that should be made, and rescind those that have been made in his absence, that he may not approve of. Thus the "independence" of the "common people" so violated by the wicked trusts and corporations will be preserved by this "Happy Hooligan" of local politics, who is always ready to lend a helping hand to put things straight, and who usually "gets it in the neck" for his solicitude.

The situation is somewhat complicated by the recent statement of Mr. Sulzer, to the effect that "William Sulzer never had a boss, and his only master is himself." Doubtless this defiant outburst will be used to the limit by Mr. O'Loughlin when Hearst calls him in the carpet to explain his unwarranted action. If Mr. Hearst is inclined to take such a statement at its face value, it is possible that he may ratify the action of his Independence League in his absence. Such a remark is, of course, contrary to all Hearstian ideas of inde-sendence, but then again Hearst is perfectly competent to disriminate between what a politician says and what he really means. He has his own statements in past years to use as a criterion, and to one knows better than Hearst just what they are worth.

### HARMLESS ATAVISM

We have all been mistaken about the trust. The Federal Gov ernment cannot destroy it, he admits, because it is not a creature of he Federal Government. But the States can destroy it, because it is a creature of the States. The States, whose Legislatures, accordng to Lawson, are bought by the trusts "like so much stinking nackerel on a Boston wharf," have ever so much more power than the Federal Government to destroy the trust.

Marshall knows this from experience. Did he not valiantly withstand all the efforts of the Steel Trust to kidnap the McNamaras rom the sovereign State of Indiana, of which he was Governor? Why, certainly. And hasn't the same sovereign State of Indiana lesroyed the Oil Trust within its borders since he became its Gov-Of course.

And here is Marshall deliberately stultifying his own power in the State by seeking the office of Vice President under the Federal Government, a position in which he can do nothing against the trusts, because he will be nothing, as a Vice President usually is.

Marshall is really too big a man to be lost in such an insignificant position. He is needed in the State, so that the republic may What a tragedy it would be if the republic were to die while he was wasting his time in Washington! And he sees the remedy
