Can She Live Contentedly On Fifty Cents a Day? Women of Leisure Asks.

According to a plate-matter article just making its round through the capitalist papers the Englewood (Ill.) Women's Club recently discussed the following "The Working Woman; How Can We Help Her?" when one Mrs. Coonley Ward made a plea for a simpler life, and one Mrs. Corinne Brown in answering her

brought up the fifty cents a day topic.

"If the leisure classes would share the burden of the working people and live more simply," declared Mrs. Ward, conditions of the working people would be greatly bettered. The extravagance in overdress by the leisure class is what causes a great deal of the misery in the working class. The poorer try to imitate those who dress extravagantly, and this effort to imitate eats away their wages. If women would not be so prodigal in dress the working women would be better off."

Mrs. Brown and Dr. De Bey took issue with Mrs. Ward and wanted to know if she could live on fifty cents a day and be

happy.
"I could live on fifty cents a day and possibly be happy in the tropics," de-lared Mrs. Ward, "where the demands of fashion are not so great."

"I could not live on fifty cents a day and would not," declared Mrs. Brown. "If anybody told me I'd have to, there'd be ething doing." Mrs. Brown said the working woman could best be helped by being given better wages, taught inde-pendence, and the value of organization. be said it was the duty of all women to stick by the working woman in her fight for higher wages. "Higher wages is the chief ingredient of happiness. Money is the surest path to happiness,'

After having read the above and reflected on the farces enacted by the 'leisure classes," men and women both, to "do something to help the poor"—"the leserving poor," as it sometimes is significantly put—I recalled a quotation I once taw, from Tolstoi, that "we are willing and envious to do snything for the poor with the exception of getting town from off his back," or something to that effect. But let us examine a few of the above arguments.

The plea for a simpler life may be all when made for hygienic reasons; out when made as a measure for bettering the condition (the economic condi-tion) of the workers it looks kind of out of place. Why should "leisure class" women have scruples about spending lav-ishly the money which their husbands, fathers, and brothers are doing their level best to squeeze out of the workers for that very purpose? If they can approve if the manner in which that money is unde, they certainly ought not to have my scruples about how to spend it.

l'ifty cents a day is little enough to ive on even for a working woman, let lone one belonging to the "leisure class." and yet there are, in this land, thousands apon thousands of families who are conpelled to subsist on even less than that,

Oi course, we know that no "leisure lass" woman with her brains and her detire for enjoyment in working order will ever attempt to live any simpler and cheaper out of mere solicitude for the poor. All their professed solicitude and their agitation of that kind is only s sham affair—very much as the debates and discussions carried on merely for stractice and entertainment in high whools, colleges, etc.—their chief purpose using to make the workers satisfied with pittance they receive in return for incessant toil, to which the followng from the same article will amply estify:

"A woman can be happy on fifty cents woman can be nappy on nity cents that if she has contentment of mind and tweetness of spirit," declared Mrs. Le Frand Lockwood. "Education should simple and sweetens our lives. It should rive us enjoyment of what we have, no natter how little it is, and not make us

Mrs. Lockwood urged that the best way to help the working woman was to teach her contentment, to be happy with her

For these "leisure class" women, they style themselves, to prescribe to the workers how to live contentedly on as little as possible, while they, the "leisure class," themselves and their husbauds, are never contented, no matter how much work they receive for the pittance they pay the workers, is the very acme of audacity, equalled only by their general solicitude for the poor.

The capitalist or "leisure class" women

ere as much the enemies and tormenters of the workers as their masculine classfellows. That they are in a position to better wear the cloak of a feigned solicitude for their tolling fellowmen than their men folks, ought not to deceive anybody as to the true object of all their so-called benevolent work, that of shield-ing the robber system of capitalism

In the United States, where religion is a private matter, an affair of conscience, where no religious sect dominates, or pretends to dominate, others, it must be difficult indeed to realize the bitterness of the contest that rages in most of the countries of Western Europe between the Roman Catholic Church and its opponents. It is not alone in France that this contest grows in intensity.

During the last few years throughout Western Europe there has been a marked reaction toward clericalism. The Catholics have organized themselves into powerful and well-disciplined parties. The covert authority of the convents, which had been abolished by the Revolution, has been developed under new forms, and religious associations have attained a greater control over education, while the political influence of the Church since the beginning of the pontificate of Leo XIII. has made itself felt on all sides.

In our little Belgium the Conservative party, made up in large part of the supporters of the Church, has been a power for the last nineteen years. In the Netherlands the majority in the States-General (the two legislative houses) belong to a truly extraordinary coalition of Catholics and Protestants-of disciples of Loyola and of Calvin. In Germany the Centre (the Catholic section of the Reichstag), though its declines in influence among the working class, appears more and more the hub of the Government majority. Protestant Conservatives pay their court to it; while the Lutheran Emperor betakes himself to Rome to bow before the Pope. In England, where frequent conversions to Catholicism are udly advertised, and where the Established Church reveals a growing disposition to imitate the Roman Church, Mr. Balfour's Ministry grants equal appro-priations to all the religious sects in the Education bill and makes important concossions to Rome in order to conciliate

In short, all the countries of Western Europe, in Germanic or Anglo-Saxon as well as in the Latin countries, clericalism gains, or at least seems to gain, ground. When in the minority its opposition becomes more aggressive; when in the majority, or holding the balance of power,

its domination waxes heavier.

calism, which had been relegated to the background on account of the pressure of socio-industrial issues, has again appeared, and is spreading in every direction. In France, in Italy, and even in Catholic Spain, the old cry of "A bas la calotte!" resounds on all sides. The veterans of former battles return to the ranks. The youth are divided again into Catholies and anti-Catholics.

But it would be an illusion to believe that nothing is changed, and that the reviving struggle between the clericals and the anti-clericals has the same meaning as had that of the epoch of Pius IX. and his syllabus. First of all, it is clear that since the rise of Socialism the efforts of the Catholic Church are not directed against the same enemies as of old. From having defended the nobles and the kings of "l'Ancien Regime" against the liberal. republican, revolutionary middle class, it turns to-day to defend the middle class, which has become conservative, and even reactionary, against the assaults of the

Socialist proletariat. Fifty years ago Catholics denounced Liberalism as "a pest and a frenzy!" To-day clericals chant the "Marseillaise," since it has become, through strange vicissitudes of things, the national hymn. Clericalism calls itself liberal when, as in France, it is the minority. It disdains, or, at most, uses the Liberals when, as in Belgium and Holland, it is in the majority. But always any everywhere it attacks Socialism, and by cunningly encouraging the fears which Socialism inspires in the classes which have property to lose, it succeeds in holding its old positions, and even advancing to

further ones. It would be a great mistake-and farseeing Catholics have no illusions on this subject-to suppose that the present revival of clericalism means an awakening of religious faith, even among Catholies. Doubtless a certain number of persons of conservative religious instincts, fearing the logical consequences of rational-isr, return to the Church, and by interpreting symbolically the old articles of faith. natruct a new creed, which contents them. But these are only superficial drifts; they are but eddies of the great tide that bears the people of Euope in a diametrically opposite direc-

lose souls." Even in Belgium, where the Church reigns through intermediaries; where the Government, in its complete subservience, chooses magistrates and functionaries, imposes religious teaching in the schools and grants appropriations as authority and wealth command, there is no doubt that the masses reveal a growing disaffection to the ecclesiastical power.

It is an indubitable fact that, notwithstanding appearances to the contrary, Europe is decatholicizing herself. One might even go further with safety and say that she is dechristianizing herself. Slowly but wurely, with the irresistible movement of a geological subsidence, faith is waning among the industrial workers, and even among the peasants. One can safely assert that about twenty years ago nearly every one held to some religious creed. Free-thinkers were few and to be found only in the middle class. Societies for promoting secular marriages and burials existed only in the larger cities. To-day we see them spreading and multiplying throughout the industrial centers, and wherever mining and manufacturing are carried on. In Belgium, in France, in Germany, the workmen who follow no particular creed number hundreds of thousands—yes, millions -and as their hopes of a heavenly kingdom dissolve other hopes assert them-selves with a growing intensity. Wherever free thought penetrates, Socialism enters also. We know, it is true, many workmen who become Socialists without relinquishing, or without totally abandoning, their religious convictions; but, aside from "yellows" and "blacklegs," act solely from mercenary motives, we neither know nor can conceive of any free-thinking workman who is not at the same time a Socialist.

What wonder, then, that this conservative middle class, instinctively antagoistic to Socialism, should become more and more antagonistic to free thought! Just as the coming of spring in the mountains dissolves the glaciers and sends down floods of icy water, which cools the atmosphere of the lowlands, so under the sunshine of free thought the breaking up of the religious creeds of the proletariat chills the rationalistic tendencies of the middle class. Frightened by the socio-industrial consequences of free thought, an increasing section of the rich class leans toward the Church, and especially toward the Catholic Church, The Roman Church in Europe may gain I which is regarded by all as the strongest

The terror of revolutionary ideas drives this section to at least the pretense of believing; and sometimes, thanks to the efforts of the Jesuits, it succeeds in inculcating belief in its children. It is thus that the apparent clerical re-

action is explained. Far from its corresponding to a general awakening of religious faith, it is, in fact, a corollary of the decline of faith among the masses. But it is, nevertheless, true that the alliance of priest and capitalist, the coalition of spiritual and temporal power, against Socialism and free thought, furnishes the conservative and reactionary parties with formidable means of action and constitutes the most redoubtable threat against the immediate future of European civilization. Progressists have not only clericalism to fight, but also, under different forms and labels, militarism, protectionist imperialism, and, in most countries, a marked tendency on the part of the sovereigns to enlarge their personal power to the detriment of the sovereignty of the people.

What else than proletarian power can we oppose to this reactionary power? Can we depend upon the middle class as a class, or on Liberalism as a party? Facts answer. In Belgium, in Holland, in Germany, the Liberals are terribly weakened: the fear of Socialism demoralizes them. It is only too often that the reactionary majority in the elections is due to their votes. In England the division and melting away of the Liberal opposition made possible the South African war, and rendered possible, if not probable, the success of Mr. Chamberlain's fiscal plans.

Justice forbids, however, to reproach English Liberalism as a body with the reactionary complaisance of the right wing. In France, too, there is a distinction to be made. The Republican middle class and the radical democracy do hesitate to accept the help of the Social Democracy in the fight against the Catholic Church by enrolling Millerand in the Ministry and electing Jaures Vice-President of the Chamber of Depu-

But we must not lose sight of the fact that France is, above all, a country of bourgeoisie and small land holders. The industrial centers are far apart, except in the territory bordering on the Belgian and German frontiers. The organization of the working class is, therefore, comparatively weak. Socialism itself is often, in France, but the idealistic ex-

thus seems natural enough that the middle class parties should not show it, but should be anti-derical rather than anti-Socialistic. But let industry develop on To the "Socialist."

a large scale, let the antagonism of the classes accentuate itself, let the French proletriat strengthen and extends its organization, and we shall see in France. as in the rest of Western Europe, the middle class facing about and asking pardon of the Church for the ills it has suffered through her.

Thus it is, in the Old World, that two gigantic coalitions are formed by the elimination of intermediaries-the Black International and the Red International. On the one hand are all those -ho hold that authority should descend from above and who find in the Catholic Church the most perfect expression of their ideal the most inflexible guardian of their class privileges; on the other hand are those who insist that authority shall come from the people, and who, by the logic of circumstances, can found their hopes on nothing but Social Democracy.

Between these 'wo extremes Protes tantism hesitates and Liberalism shifts from place to place. One may see clearly the truth of the prediction that was made fifty years ago by the Catholic writer, Donoso Cortes:

"The Liberal school honors equally darkness and light. It has undertakenextravagant and impossible undertakings -to govern without the people and without God. Its days are numbered. One sees already on the two opposite points of the horizon, the rising sun that proclaims God and the ominous cloud that announces the mad rage of the people. In the terrible day of battle, when the whole arena shall be filled with the Catholic and Socialist phalanxes, no one will know where to find the forces of Liberal-

One may welcome or deplore the fact of this coming concentration of forces about the Catholic Church on the one side, the Social Democracy on the other. But none, can deny that this concentration is inevitable, and that the future struggles will have to be fought out between these two armies. To those, therefore, who are interested in the social movement of Europe, we say: Observe, above all else, if you wish to consider only the essential factors, the political activities of the Roman Catholic Church and those of International Socialism.

It is really wonderful, but the fact remains: In the authoritative locations the sense of sympathy and of appreciation have been lost, one is not in contact with the soul of the party, one is not able to comprehend what happens. Have we ever in the forty years of the existence of the Party, faced a storm of indignation like the one in regard to this question? Of course mainly after Comrade Vollmar entered the arena and not only accepted the views of Bernstein, but his way. Vollmar likes to rise seldom, especially to a question of programme, but when he believes the hour has come to fight for a cause with his whole might he proceeds in a certain solemn manner, exactly as if he were about to suddenly proclaim a new doctrine. (Hilarity and assent.)

So was it also in Munich. I thought the tale were already finished and it would be heard of only in the delegation I said to myself then already: Now, for once, will you be able to sleep quietly. (Hilarity.) Then came from Munich the news of Vollmar's speech. The public appearance of Vollmar's in 1891 is still remembered; when in a speech at the Kolloseum he delivered his programme, for which he was highly lauded by the bourgeois parties. Then it was said: Yes, that is the only man in the party who knows how to feel the pulse of the times. The same as now. Particularly Herr Nauman, who sits in front of me, actually conjured him: "You are the man for the situation, descend from the Bavarian mountains, step to the front, the whole people will receive you with jubil-ations." (Great hilarity.)

(Great hilarity.) But with the jubilations it was a little different. Certainly there was jubilation in Munich, but such is always there, when Vollmar arrives. (Hilarity.) Mu nich is the Capua of the German Social-Democracy. (Great hilarity.) In Munich nobody wanders with impunity among the beer bottles for any length of time. (Renswed hilarity.) In Munich the proudest pillars of the Party perish in time Just take a look at this Parvius (hilarity) of whom, until lately, everyone would have sworn that he is a radical would have sworn that he is a radical of the clearest water. To be sure, as a former radical, he went to pieces in a

manner different from that in which fate would overtake a revisionist, still he did go to pieces. His fate was the same as that of many a one, who entered Munich as a brave, principled, stanch comradeome of them I notice sitting at several tables. (Great bilarity.) After a few years of Munich they were broken in oody and soul. These are my imprersions and if I myself should make my home in Munich, I believe I would become afraid of myself. (Stormy hilarity.)

Vollmar's debut was not only by a ceived with fervent acclamation, but also, almost without exception, by the bourgeois press. (Quit right!) Gradually it has come to pass in our Party that certain cliques are surrounded by a corona of bourgeois journalists in the form of Corybantes. I do not say that they have been called for. (great applause), and Segitz promptly exclaims "Not I!" (Bravo!)

Comrades: -On returning to Barrow, after spending a most enjoyable fortnight's holiday among the members of the party in Scotland, I settled down to carry on the agitation with the object of organizing a branch of the Party here. Three weeks only have elapsed since I returned, yet I have to report progress even beyond my own expectations.

I set about getting readers for the Party organ, and, after getting them, I supplied them with back numbers of the paper, old copies of the "Weekly People," and all the leaflets issued by the Party. While delivering the January issue of the "Socialist," to the readers, I found many of them desirous of forming a branch. I accordingly gave each man a copy of the platform constitution and rules, and called a meeting for Sunday, January 17, at 3 p. m.

At exactly ten minutes past three on that day, a good number being present, the meeting was called to order by Com rade Abbott rising and suggesting that, in consideration of the object of the meeting, a chairman be appointed. Comrade Abbott, on motion, was elected to the chair, and after briefly explaining the object of the meeting, he called on the writer to address the meeting on the platform of the Socialist Labor Party and the principles of Socialism generally.

The writer upon rising thanked in a few words the friend who had that day accommodated us with a meeting place, when such a thing was so difficult to get. In addressing the meeting for over an hour, he traced the evolutions of society right from the period of savagery, through barbarism and primitive communism, into the feudal state. He went on to show how, at the close of the eighteenth century, the rising industrial bourgeoisie, aided by the proletariat, which was only then making its appearance, overthrew the landowning aristocracy, the then ruling class, and established their economic and political supremacy. The rise and development of the Socialist movement was touched upon, and the springing up of the Socialist Labor Party in America, France, Italy, Canada, Australia, and Great Britain, and its principles and tactics were dealt with at length.

In conclusion an appeal was made for those present to fall into line at once. and get a branch of the S. L. P. formed in Barrow. After some discussion and some questions had been answered, wherein the writer pointed out that Daniel de Leon, who had been twenty years in the movement, and the late William Liebknecht, who for fifty years fought in the ranks of the German proletariat, were two of those "young men" who maintained that "a straight line was the shortest distance between two given points." It was decided to ask the permission of the Executive Council of S. L. P. to form a branch. With eight of those present promising to take "The People" every week, a most successful meeting came to a close. I really intended to finish this letter right here, but, even at the risk of encroaching on our sphere. I must say a few s about local affairs. Barrow, besides being a town of mushroom growth, is purely a working class centre, and is practically kept on the map by one firm, lickers, Sons, & Maxim's naval construction works to wit. Being well supplied with government contracts, the wageslaves send a tory to represent them in parliament in order that the "good times" may continue. A "labor" man is putting up at the next election, supported by the local L. R. C., the Liberal and Radical Association, tory trade unionists, liberal trade unions, co-operators, the Barrow Socialists (?) Society, and the local "Social Demoquacks," in their capacity as "trade union officials." A new capitalist newspaper has recently made its appearance, run by the L. R. C., to support Charles Duncan, the "labor" man. The editor of this thing is secretary

of the above mentioned B. S. S., assistant secretary L. R. C., and for some years has served the capitalist class in their struggle against the working class as a newspaper correspondent. An S. D. F. CHAPTER III.

EPISCOPALS AND COMMUNIERS.

Fergan put on his caseque, and presently giving his arm to Joan the Hunchback, as Colombaik gave his to Martine, and Quatre-Mains to his wife Simonne, the three couples sallied forth from Colombaik's tannery, followed by his apprentices, who, likewise were members of the Commune.

The rivalry of the bells continued undiminished. At intervals the bells of the churches intermitted their clangor, no doubt in the hope of having silenced the belfry. Its sonorous and regular peal proceeded, however, unchecked, and the clerical clangor was renewed with redoubled fury. The incident, puerile in seeming, but serious at bottom, produced a deep resentment towards the party of the nobles. It was a long distance from the tannery of Colombaik to the market-place, the rendezvous of the bourgeois militia. Large crowds blocked the streets, moving towards the communal Town Hall, that had been three years building and was recently finished. Only the casting and hanging of the bell in its campanile had retarded the inauguration of the monument so dear to the townsmen. More than once did Joan turn back to look, not without uneasiness, in the direction where her son followed with Martine, together with Quatre-Mains and Simonne. Joan's apprehensions were well founded. A large number of the domestics of the noble and clerical households were dispersed among the crowd, and from time to time hurled some vulgar insult at the communiers, upon which they would immediately take to their heels. Knights, clad in full armor, crossed and re-crossed the streets, their fists upon their hips, their visors up, and easting disdainful and defiant looks apen the people. These provocations increased particularly in the vicinity of the rendezvous of the militia, at the head of which, and armed as if for battle, the Mayor of Laon and his weive Councilmen were to march in procession to the Town fall in order to inaugurate by a solemn session the meeting of Lese magistrates, held until then at the house of John Mol-

in, the Mayor. The market-place of Laon, like that of all the cities of Gaul. ensisted of large stalls, where, on Saturdays, occasionally also u other days of the week, the merchants, leaving their everylay shops, exposed their products for sale. Outsiders and the uburb population, who drew their supplies from Laon, thus ound at one place all that they might want. But on that day the market served as the gathering place for a goodly number of bourgeois and artisans, who had armed themselves to join the procession and impart to it an imposing appearance. In case of war, every communier was obliged to furnish himself with a pike and an axe, or club, at the first call from the belfry, and hasten to the rendezvous. As a rule the crowd seemed indifferent to the insolent gibes and provocations of the episcopals. The communiers, at least a majority of them, felt themselves strong enough to despise the challenges to riot. A few, however, yielded to a certain sense of fear for the iron-clad nobles, who were accustomed to the use of weapons, and with whom the Laonese, who owed their enfranchisement to a contract and not to an insurrection, had not yet had occasion to measure themselves. Finally and moreover, hardly freed from their rude and base servitude, many of the townsmen still preserved, involuntarily, a certain habit, if not of respect, yet of dread for people whose cruel oppression they had so long been subject to. Shortly, the captains-of-tens, commanding squads of tens, and the captainsof-hundreds, commanding companies of hundreds, all under the command of Fergan, who had been chosen constable, or chief of the militia, drew up their ranks along the stalls of the marketplace. Colombaik was a captain-of-ten, his body was complete except for one lad called Bertrand, the son of Bernard des Bruyeres, a rich bourgeois who, three years previous, was assassinated in the cathedral by Gaudry, bishop of Laon.

"Probably," said Colombaik, "poor Bertrand will not join us to-day. This is a feast day, and there are no more feast days for the poor fellow since the murder of his father."

"Yet there comes Bertrand!" cried out one of the militiamen, pointing at a young man, who, pale, frail and sickly-looking, of s timid and kind appearance, wearing a steel casque and armed with a heavy axe that seemed to weigh down his shoulder, was approaching from a distance. "Poor Bertrand!" the militiaman added, "so feeble and wretched! He is excused for not having avenged the death of his father upon our accursed bishop!"
Cordially received by his companions, Bertrand answered their solicitous inquiries with some embarrassment, and silently took his place in the ranks. The Mayor arrived soon after, accompanied by his Councilmen, some unarmed, others armed like Ancel Quatre-Mains, who joined them there. John Molrain, the Mayor, a man in the vigor of life and of a countenance at once calm and energetic, marched at the head of the magistrates of the city. One of them carried the banner of the Commune of Laon, -if the steeple of the people's belfries rose daringly in the teeth of the feudal donjons, the communal banners floated no less high than those of the seigneurs. The banner of Laon perceented two embattled towers, between which rose a naked sword. The emblem signified: "Our city, fortified by walls, will know how to defend itself by arms against its enemies." er Councilmen carried in a vermillion casket, lying upon ilk cushion, the communal charter, signed by the bishop and he nobles, and confirmed by the signature of Louis the Lusty,

King of the French. Finally, a third carried, also upon a cushion, the silver seal of the Commune, which served to attest the acts and decrees rendered by the town Council in the name of the Commune. This large medal, cast in bass relief, represented the Mayor, who, clad in his long robe and with his right hand pointing heavenward, seemed to be taking the oath, while his left hand held a sword with the point resting on his breast. "I, Mayor of Laon, have sworn to maintain and defend the franchises of the Commune: sooner die than betray my trust!"—such was the patriotic meaning of the communal seal, in short, "Liberty or death!"

When the city magistrate arrived, Fergan, who was issuing his last orders to the militiamen, saw a priest, the archdeacon of the cathedral, called Anselm, step out of the crowd. Fergan held the tonsured fraternity in singular aversion, yet greatly esteemed Anselm, a true disciple of Christ. "Fergan," whispered the archdeacon to the quarryman, "press your friends to redouble their calmness and their prudence, I conjure you. Prevent them from replying to any provocation. I can tell you no more. The time is short. I must proceed to the episcopal palace." Saying this, Anselm disappeared in the crowd. The advice of the archdeacon, a wise man, beloved by all, and, due to his office, in a position to be reliably informed, struck Fergan. He no longer doubted there was a conspiracy, secretly hatched by the episcopals against the Commune. Profoundly preoccupied, he placed himself at the head of his militiamen, in order to escort the Mayor and the Councilmen to the Town Hall. The obscure names of this magistracy, taken from Fergan's family archives, and over which he inscribed the exhortation: "May they be ever dear to your memory, ye sons of Joel!" were: John Molrain, Mayor. Councilmen: Foulque, the son of Bomar; Raoul Cabricoin; Ancel, son-in-law of Labert; Haymon; Payen-Seille; Robert; Remy-But; Menard-Dray, Raimbaut the sausagemaker; Payen-Oste-Loup; Ancel Quatre-Mains, and Raoul-

The procession started amidst the joyful acclamations of the crowd, who enthusiastically shouted their rallying-cry: "Commune! Commune!" swollen by the sonorous peals from the belfry, the clerical clangor having finally ceased, due to the apprehension of the episcopals, lest the prolonged ringing of their bells was taken for their participation in the festivities. Before arriving at the place where the Town Hall stood, the procession defiled before the house of the knight of Haut-Pourcin, a large and fortified dwelling, flanked with two thick towers, that were joined by an embattled terrace, projecting above the door. Upon this species of balcony were gathered a large number of knights, clergymen, nobles and elegantly bedezined ladies, some young and handsome, others old and ugly. Among the least old of the latter and yet ugliest of all, the dame of Haut-Pourcin was conspicuous. A gaunt virago of about fifty, bony, of parchment skin, and of arrogant mien, she wore a violet cloak with gold buttons and a cape of peacock feathers; on her grizzly hair she had coquettishly fastened a chaplet of lillies of the valley in full bloom, like a shepherdess. The whiteness of her floral ornaments heightened the yellowish color of the dame's bilious complexion, a complexion, however, that was less yellowish than her long teeth. At sight of the procession, headed by the Mayor and his Councilmen, she turned to those near her, crying out in a sour and piercing voice that was distinctly heard by the communiers, the terrace lying only twelve or fifteen feet above the street! "Mesdames and messeigneurs, have you ever seen a pack of asses tramping to their mill with a more triumphant air?"

"Oh!" answered one of the knights aloud, laughing and pointing with his switch at the Mayor, John Molrain: "And look at the master-ass that leads the rest! How he prances under his furred saddle-cloth!"

"Pity his headgear conceals his long ears from us!"

"Blood of Christ! What a shame to see these Gallic clowns, made slaves by our ancestors, now carrying swords like us of the nobility!" put in the seigneur of Haut-Pourcin. "And we, the descendants of the conquerors; we knights tolerate such villainy!"

"Halloa, there, Quatre-Mains the baker!" yelled the dame of Haut-Pourcin in a squeaky voice, leaning over the railing of the terrace, "Seigneur Councilman, trotting cuckolded and content while armed for war! The last bread that my butler fetched from your shop was not baked enough, and I suspect you of having cheated me in the weight!"

"Halloa, there, Remy the currier!" added a bulky canon attached to the cathedral, "Seigneur Councilman, who are there loitering about, administering the affairs of the city, why are you not at work on the mule saddle that I ordered?"

"Oh, messeigneurs, there comes the cavalry!" exclaimed a young woman laughing and smelling at a nosegay of sweet marjorams. "Look at the swagger of the vagabond who commands his braves, would you not think he was about to hew down everything in sight?"

"Oh, messeigneurs, look at that hero yonder! Oppressed by his visor, he is carrying his casque front side back and his sabre on his shoulder!"

"And that one, who holds his sword like a wax-taper! Guess he is a Pope's soldier!"

"And yonder goes one who came near putting out the eye of his neighbor with his pike! What a ridiculous set! What silly people!"

"For heaven's sake, messeigneurs, are you not frozen with terror at the thought that, some day, we may find ourselves face to face and lance in hand, with this bourgeoisie, this formidable rabble-rout of shaven fronts, big paunches and flat feet?"

At first, patiently endured by the communiers, these insults, accentuated with outbursts of contemptuous laughter and disdainful gestures, ended, nevertheless, by irritating the more impetuous. Dull murmurs rose from the crowd; the procession halted, despite the entreaties of Fergan, who urged upon the militiamen the silence of contempt. Some threatened the episcopals with their fists, others with their arms; but their tormentors redoubled their gibes at the sight of such signs of irritation. Suddenly John Molrain, the Mayor, rushing to one of the stone benches, common near the doors of dwellings to assist riders in mounting their horses, jumped upon it, ordered silence, and addressed the crowd in a sonorous voice, that reached the ears of the episcopals:

"Brothers, and all those who have taken the oath of the Commune of Laon, make no reply to impotent insults! Let any dare attack the Commune with deeds and not with words, then will we, your Mayor and Councilmen, summon the offender before our tribunal, and justice will be enforced upon our enemies—prompt and energetic justice! provocation with disdain. The resolute man, strong in his rights, despises insults. At the hour of judgment, he condemns and punishes!"

These wise and measured words quieted the excitement of the crowd, but they also reached the ears of the nobles, assembled on the terrace of the house of the seigneur of Haut-Pourcin, and added fuel to their rage. They menaced the communiers with their canes and swords, while redoubling their gibes. "Your swords are not long enough, they do not reach us!" Colombaik cried out to them, while passing under the balcony with his division of the militia. "Come down into the street! We shall then see whether iron is heavier in the hands of a bourgeois than in that of a knight!"

This challenge was answered by the episcopals with fresh insults. However, they dared not descend into the street, where they would have been seized and taken prisoners by the militia. For a moment delayed on its march, the procession resumed its way and arrived at the place of the Town Hall, a monument dear to the artisans and other townsmen.

The edifice, a spacious and handsome structure recently erected, formed an oblong square. Elaborate sculptures ornamented its facade and the lintels of its numerous windows and architrave, which consisted of three ogive arcades sustained by elegant sheaves of stone columns. But the portion of the edifice upon which particular care had been devoted, both in point of construction and ornamentation, was the tower of the belfry and the campanile, where hung the bell. This tower, proudly rising above the roof, stood out in full view. From tier to tier a slender sheet supported rounds of small columns surmounted with ogives chiseled in trefoil, so that across the network of chiseled stone the spiral of the staircase was visible that led up to the campanile, veiled in white cloth up to the moment when the procession issued upon the place. When the covering dropped off and the campanile stood unveiled, a shout of admiration and patriotic enthusiasm rose from all breasts. Nothing so airy as that campanile, looking like a gilded cage of iron, whose outlines stood out against the blue of the sky like a lace-work of gold, glittering in the rays of the sun. Above the dazzling dome, the communal banner floated in the spring breeze of that beautiful April morning. The enthusiastic cheers of the crowds rose again and again, and the north wind must have carried to the ears of the episcopals the cry, a thousand times repeated:

"Commune! Commune! Long live the Commune!"

CHAPTER IV.

THE ECCLESIASTICAL SEIGNIORY OF GAUDRY.

The episcopal palace of Laon rose close to the cathedral. Thick walls, fortified with two heavy towers, between which stood the gate, surrounded the dwelling from all sides. From the view-point of the benign morality of Jesus-the friend of the poor and the afflicted-nothing was less episcopal than the interior of this palace. One would imagine himself in the fortified castle of some feudal seigneur, a broiler and hunter. The singular contrast between the place and the character that it should have presented, left a painful impression upon all upright hearts, and such, indeed, was the feeling experienced by archdeacon Anselm, when, shortly after engaging Fergan to urge upon the communiers indifference towards the provocations of the episcopals, that disciple of Christ crossed the yard of the bishop. This last circumstance struck the archdeacon with amazement, and increased his fears for the peace of the city. The venerable man was overcome with sadness and two large tears dropped from his eyes.

Although an associate of clergymen, Anselm was a man of great kindness of heart, pure, disinterested, austere and of rare learning. He was called "doctor of doctors." He declined the episcopacy several times, fearing, it was said, to seem to censure, by the Christian meekness of his nature and the chastity of his habits, the conduct of most of the bishops of Gaul. His face, at once pale and serene, his hair thinned by study, imparted a distinguished aspect to his person, tempered by the kindliness of his eyes. Modestly dressed in his black gown, Anselm was slowly crossing the yard of the abbey, contrasting their noisy tumult with the repose of his own studious retreat, when he saw, approaching him from a distance, a negro of giant stature, dressed in Oriental garb, his head covered with a red turban. This African slave, of mean and savage physiognomy, was named John since his baptism. He was, many years before, given as a present to Bishop Gaudry by a Crusader seigneur, returned from the Holy Land. By little and little Black John grew to be the favorite of his new master, the intermediary of the latter's debaucheries, or the instrument of his cruelties, before the establishment of the Commune. Since that transformation, the persons and property of the communiers had become safe. If an injury was done to either, the Commune obtained or itself enforced justice against the wrong-doer. Accordingly, the bishop and the nobles had been forced to renounce their habits of violence and rapine.

When the archdeacon saw Black John, the latter was descending a staircase that ended in a door, wrought under a vault closed with a grating, that separated the first two walks of a green reserved for the bishop. A woman, wrapped in a mantle that completely concealed her face, accompanied the slave. Anselm could not restrain a gesture of indignation. Knowing the dwellers of the palace, and aware that the staircase under the vault led to the apartments of the bishop, he had no doubt that the veiled woman, leaving the palace at so early an hour and under the guide of Black John, the bishop's regular procurer, had passed the night with the prelate. Blushing with chaste confusion, the archdeacon had turned his head away with disgust at the moment when, having opened the grated gate, the slave and his female companion passed close by him. Stepping into the vault, the archdeacon entered the green, -- a spacious enclosure, that, swarded and planted with trees, spread before the windows of the private apartments of Bishop Gaudry.

This man, a Norman by extraction and descended from the pirates of old Rolf, after having fought in the ranks of William the Bastard, when he conquered England, was later, in 1106, promoted to the bishopric of Laon. Cruel and debauched, covetous and prodigal, Gaudry was, besides all, a passionate huntsman. Still agile and vigorous, although beyond the prime of

life, he was at that moment trying a young horse and breaking it in to step on the green that Anselm had just entered. In order to feel more at ease, the bishop had taken off his long morning robe, lined with fur, and kept on nothing but his sock-pointed shoes, his hose and a short jacket of flexible material. Bareheaded, his gray hair to the wind, still an able and bold cavalier, and riding bare-back the young stallion, that had for the first time come from the paddock, Gaudry was pressing his nervy knees against the flanks of the mettlesome animal, resisting its boundings and kicking, and forcing it to run in a circle over the sward of the green. The bishop's equerry applauded with voice and gesture the skill of his master, while a serf of robust frame and gallows-bird countenance followed the riding lesson with cunning eyes. This serf, who belonged to the abbey of St. Vincent, a fief of the bishopric, was named Thiegaud. The felloworiginally charged with the collection of toll over a bridge near the city, a dependency of the castellan Enguerrand de Coucy, one of the most ferocious feudal tyrants of Picardy who was dreaded for his audacity and cruelty-had been guilty of a number of extortions and even murders. "If you keep the horse, seigneur bishop," answered Thiegaud, "give me a hundred and twenty silver sous. That's the price they demand."

"That's all right. What's the hurry?" rejoined the bishop,

"Not so," said Thiegaud, "the tenant-farmer is waiting at the gate of the palace. He has been ordered to take the horse

If the bishop of Laon had entertained any doubt upon the indifference of the serf of St. Vincent regarding his daughter's shame, it was removed by the man's words. Accordingly, doubly satisfied with the tokens of Thiegaud's devotion, the bishop addressed his people in these words: "I am glad to find you in such a frame of mind. Remain so. The hour for going to work will arrive sooner than you may think. As to you, my brave John, you have avenged me on the insolence of those communiers. Fear not. Not a hair of your head shall be touched. As to you, friend Ysengrin, notify the farmer that I keep the horse, and I shall pay him if I choose. Then, see our friends the woodsmen and colliers of the forest. I may need them any day. RECURRING PHENOMENA.

Suppose that, some time between 1770 and 1778, some enterprising Briton and fore-runner of the late lamented Captain Pond had started a lecture bureau in London town; suppose the undertaking were well or otherwise subsidized by the Cabinet of George III; and suppose the manager of the bureau, knew that in the then American colonies there was a "seditious spirit" on foot, and that the subject of "democracy" was on most peoples' lips and minds; suppose then, that the manager picked out and sent to the colonies some lecturer to tour the country, disabuse the peoples' minds regarding their illusions on "popular government" and stem the tide of political freedom. Suppose, finally, the lecturer arrived, and appeared and in the course of his lecture delivered himself as fol-

"Democracy is the most ambitious remedy that has been offered. Democracy can not be well defined. It has been likened to a great rubber band, which band, which may be stretched and stretched until it to compass the whole of society, but finally it reaches the point where the strain is too great, and it gives way altogether. Applied to the individual maricter and conduct it gives much good: but it will not admit a large ap-plication. Democracy is not a vital prinsiple. It is not a constructive force.

Does anyone imagine that democracy would have felt triturated by such asserions? Does anyone imagine that the wheels of time would thereby have been turned back, and the Revolutionary Fathus would have thrown up the sponge and 'e-placed their necks into King George's roke! Hardly! The lecturer would have been laughed at by the Spirit of '76.

Now, then, strike out in the above quotation the word "Democracy," every time it occurs, and place in its stead the word "Socialism," and you have the exact words from a speech by Carroll D. Fright, delivered on Sunday, the 6th of this month, at Hartford, Ct. The substitution of "Democracy" for "Socialism" illumines the string of assertions in the speech, and is their complete refutation. No argument is needed. It suggests itself to the reader.

And there were just such speeches made in the seventies of the eighteenth century by the Carroll D. Wrights of that generation, floated by the corresponding element that floats the Carroll D. CORTELYOU A BRYANITE.

On the 5th of this month, Secretary George B. Cortelyou of the Department of Commerce and Labor delivered an address in Providence on econonite conditions in New England. The address was a eulogy of the said conditions. Prosperity, the Secretary claimed, was soaring high and wide, with employers and employees as common sharers. Nor was the Secretary chary of figures. Of these New England figures two sets will answer for the present.

For the year 1850 the Secretary places the number of employees in the manufactures of New England at 312,000 with wages at \$75,000,000; in 1900 the number of employees is placed at 1,000,000 with wages at \$420,000,000. In other words in 1850 wages were \$240, in 1900 they were \$420, or \$180 higher .- Stick a pin

Nine days before Secretary Cortelyou delivered this speech and brought forth these figures a bill was introduced in the United States Senate to raise the salaries of Congressmen. And the argument made in support of the proposition was that the present standard of salary was determined according to the standard of the cost of living at that time. The cost of living having gone up considerably, the old standard of salary should be abandoned and brought up to the present standard of the cost of living. Among the men who took part, in the informa discussion that followed the introduction of the bill was Senator Hoar of Massachusetts, who stated that as compared with the cost of living the exist ng salary is not equal to more than 50 per cent. Stick a pin there. We need not verify Secretary Cortel-

you's figures. We may accept them as correct, for the sake of argument; and as to the matter of the cost of living. verification is there superfluous. Senator Hoar's experience in Washington, Horace Greeley's experience in New York, everybody's experience everywhere coincides. The cost of living has gone up. The estimate of a 50 per cent. increase on the cost of living of the well-to-do is moderate. Taking Secretary Cortelyou's figures together with the evidence furnished by the hill to raise the salaries of Congressmen, we obtain the following proposition: Wages have risen 75 per cent.; cost of living has risen 50 per cent, to the well-to-do, consequently it has risen at least 80 per cent to the workingmen, who, having to buy in small quantities, are plucked both in actual and in relative price to say nothing of the quality and more shrunken quarters. In other words in 1900 the workingman received a dollar with only 20 cents in it; or to use a very modern political term, he received a "cheap dollar" for his full or dear dollar of labor.

The conclusion is obvious. Secretary Cortelyou says that the conditions he describes denote deep and wide-spread prosperity. Of course he believes it. But in believing and proclaiming it, whom else does he rank himself with than with William Jennings Bryan? Mr. Bryan, as the anti-free coinagists showed, believed that the more dollars a man has the richer he is, regardless of the value of the dollar. Four dollars that together contain 240 cents, Mr. Bryan takes to be greater prosperity than three dollars that amount to 300 cents. Mr. Bryan was sincere in his belief, as sincere as Secretary Cortelyou is now when he declares there is greater prosperity now than in 1850, because now the workingman receives \$420 whereas in 1850 he received only \$240-although the \$240 dollars of 1850 contained a purchasing ower of 24,000 cents, while the \$420 to-day contain a purchasing power of

only 8,400 cents. We would not question Mr. Cortelyou's sincerity, however fallacious his economics. But his very sincerity in such economics makes him a Bryanite- and that is what all the gold standard Republican officials of to-day are when they give their reasons for the prosperity that they ascribe to the workingman: they remain anti-Bryanite only in the matter of the economics according to which they determine the standard of their own salaries.

THE ALABAMA SCHEME ON FOOT. About four years ago, a report was published in these columns of the convention, or rather, two conventions held in rapid successsion by the ininers of Alabama. The report was written by a miner himself who was there, and "knew all about it." It was to this effects Delegates had been elected. When they met the officers found them intractable. The scheme had been concocted between the officers and the mine owners to reduce wages. The delegates would not. Indeed, the temper of their constituents, when elected, was all but brotherly to Brother Capital. The rank and file had acted under sentiments that presupposed that, knowingly or unknowingly, they the legitimacy of their alleged Brother Capital. They suspected the gentleman

felt nowise friendly, least of all brother ly towards him. The labor leaders or fakirs, labored hard to work the delegates "around." It was no go. Thereupon these leaders resorted to their powers-those powers that brand the vast majority of the pure and simple Union organizations as mere satrapies, with the labor fakir as the satrap who can do with the members as he will. They dissolved the convention; ordered another election; saw to it "by virtue of their powers" that a different brand of delegates was returned; met at that second convention; and there registered the will of the mine owners. That happened in Alabama. It looks as if the performance is now to be repeated in the north.

The bituminous miners' convention, of which Mr. John Mitchell is the much praised president (by capitalist concerns) has been in session at Indianapolis. At the convention and at the meeting of the mine-workers and mine-owners delegates Mr. Mitchell landed by slow gradations down to the demand of the mineowners for a reduction of 5 per cent. from the present scale of wages. Whether it is that such a cut, now when the price of everything, bread included, is going up; or that the miners' delegates have begun to see through Mr. Mitchell; whatever it be, the male widow of Senator Hanna labored in vain to convince them to cut their own throats. They would consent to no such, or any other cut, and the mine-owners left, realizing, as the despatches have it, that "they could do nothing with that convention." Did the mine-owners therefore go home disheartened? Indeed not.

Here are some of the statements made by the homing mine-owners:

"Affairs look now more promising than ever. We have won over the officials.'

"The officials will now win over the miners. This will be done through a series of district conventions, at which the workers will be told of the unwisdom of holding out."

"The rank and file will be asked to send UNRESTRICTED DELEGATES TO ANOTHER NATIONAL CONVEN-

So there we have the Alabama scheme in full course of operation. And how well posted these operators are upon what the plan of campaign is to be in pursuit of the goal to bring about a convention that will register the mine-owners' will!

The Mitchells are the decoy ducks of the capitalist class; their forms of Unionism is but the hook and net with which to land the workingman limp as a fish on the capitalist's banquet table. The Labor Movement must smash both decoy-ducks and hooks and nets, and organize anew into bodies that are Trades Unions in fact and not in name, and whose structure may leave as little chance for the Mitchells to decov-duck in as light in a shop gives burglars a chance to play their pranks.

DYING AT THE TOP

The "Evening Post" publishes with much relish the full list of the names of the newly formed "Philippine Independence Committee"; and "pointing with pride" at the galaxy, declares it an evidence that "American ideals are not dying at the top." A careful consideration of the galaxy proves the reverse of the "Evening Post's" contention.

Unquestionably the Philippines as a colony present one of the darkest clouds that are gathering and brooding over the horizon of our country. It is not merely that the keeping of the Philippines has led to the first step that costs towards transforming this government of the United States into a military oligarchy. That is bad enough, no doubt: but military oligarchies can be got rid of, and once rid of the evil is cauterized; they may kill, but they do not poison or vitiate the system. The Philippines as a colony, however, are a Dismal Swamp from which must inevitably rise the miasma of corruption, inevitable upon the chase of placemen for distant offices, too distant to be supervised by the home people, and where wealth can be amassed by venalty. The thing happens even nearby, at home, as the increasingly scandalous Postal Scandals show. What will it not be in the instance of a colony at the antipodes! Corruption will breed corruption. Corruptly places will be obtained, more corruptly will they be held, and still more corruptly will the official labored under strong doubts regarding misdemeanors be cloaked over. The Philippines threaten to render the woof of the nation too rotten to hold any correc-

can see deeper. He realizes that the very danger from corruption presupposes home conditions too weak to resist the deadly microbe; and the better informed spend, accordingly, little time on the Philippines, but seek to restore at home the popular conditions of economic freedom that capitalism undermines. That gentlemen of high ideals and who figure in the high places of capitalist society should not be equipped with the mental powers to see so deep is not surprising. Their class interests disqualify them. Nevertheless, blind though their class interests may render them on economics, it does not therefrom follow that they must also be dead to the ideals that rocked the cradle of their own, the capitalist system of society,-ideals which were loftiest with the capitalist revolution of America. However absurd it would be for anyone to expect to see these ideals realized in the now full grown capitalism of America, nevertheless devotion to them would still be a redeeming feature in the system or its intellectual upholders. Among these ancient American ideals is that of independence of thought. What evidence is there that it survives, or is not dying out? The Philippine Independence Committee furnishes an evidence that that ideal for one IS dving at the top: that, in fact, what is left of it is not worth mentioning.

Here we have a country of 70,000,000 people with thousands of distinguished and intellectual posts, held of course, by the most brilliant members of the capi talist class. That these realize the mias mic influence of the Philippines, as a colony upon America there is no doubt. Nor can there be any doubt that those who gathered the committee did all they could to present as long a list as possible. And with what success? Leaving aside the calibre of the committeemen, and bringing for the present only the number under the scalpel, what do we see? Only 42 names could be scraped together for such an ideal purpose! Only 42 names, after scurrying over a country of the vastness of ours, and with such a large quarry from which to draw! That hundreds and thousands of others feel the same way is unquestionable: but they dare not utter themselves, lest they forfeit their posts! They dare not utter themselves even on such a purely ideal matter as purity of government! They dare not, because the social system that has reached the rotten-ripeness when it must fall, dies at the top. Its ideals become tainted with its essence, and the greatest of all ideals, manly independence of thought and speech, is no more.

Such is the lay of the land with regard to the Philippine Independence Committee when looked at from the numerical view point only. Applying the scalpel to its quality, even that insignificant number shrivels and almost vanishes. Barely three, say, five of the names deserve any consideration. The remaining thirty-seven are just so much trash. There is, for instance, the inevitable Robert Fulton Cutting, a picturesque moth, who would sooner die than not be on some committee; there is President David Starr Jordan of Leland Stanford University, who was perfectly willing to be reduced to the level of chief cook, or chief gardner, at any rate, of valet of the lady who virtually owns the Univerhis opinion regarding the fitness of an instructor, and to dismiss him at her orders,-and who is happy in that capacity; there is the Rev. C. H. Parkhurst of unspeakable "tricks"; -and so forth and

Ave! American capitalist society is dying at the top. Its one time ideals are no more. May the decadent body not have to linger much longer! Another social system, another class, with whom true American ideals are a living fact, is pretty near virile-ripe to take the place of the capitalist class-rotten-ripe for replacement.

A NECESSARY AMENDMENT.

On either side of us lies a documentone a morning paper of this city, the other a circular issued by a trades union. The document to the right has an editorial which closes with these words:

"No labor leader is safe who considers harmony between Capital and Labor possible, and who denies the class-struggle character in the struggles of our days. The intellectual error gradually develops into a moral one, and the at first but mistaken labor leader into a traitor."

What paper may that be from? We do not wish to hold our readers long in suspense. We shall proceed to answer the question; and shall do so by now turning to the document to the left, the cirof having been hatched from a cuckoo's tionary stitches. All this is obvious. Of cular issued by a Trades Union—Fire-cor in their nest. At any rate, they course, the better informed, the Secialist, men's Union No. 30 of the Int'l Brewesy Rhody contributed to this end.

Workmen. The document opens with this passage:

"The Volkszeitung declared itself : short time ago ready to accept a truthful statement on the cause of the dis turbances among the brewers, but THE MAJORITY OF THE MEMBERS OF THE UNDERSIGNED UNION HAVE LOST CONFIDENCE [it was time!] IN THE SAID PAPER, since its Editor refused to accept communications from us when it was still time to PREVENT the trouble. We were then systematically killed with silence, despite all requests by letters and committees. By a timely interposition on the part of the Volkszeitung, there would not be to-day any brewery troubles in New York. But. IN CONSIDERATION OF THE PROMISED ADVERTISEMENTS FROM THE POOL BREWERIES, the Volkszeitung preferred to remain silent

Nor is this the only document of that sort to our left. There are several others whose history may be summed up with the above. It is this:

The labor leaders who run Local No. 1 (New York City) of the Int'l Brewery Workmen's Union, were convicted at the national convention of the Union, held in Cincinnati, O.; Feb. 1-14 of last year of having sold out to several breweries in the matter of contracts by which their rank and file were betrayed to the employer, and several of the delegates of the Local were expelled from the convention. Being hands-in-glove, like all fakirs are, with the brewery firms concerned, these officers-one of whom at least has amassed a house on his nefarious practices-bearded the national convention of their Union and subsequently their national officers, and cracked the whip over their local rank and file. Not all of these submitted. A strong portion resisted. But they were "disciplined"-fined out of their eye-balls, and driven from work. In this fight in New York, the German labor press was arbiter. According as it suppressed or published the facts, the corruptionists would win out and Labor would be betrayed, or the corruptionists would be beaten and the interests of the working class safeguarded. The "New Yorker Volkszeitung," the only local German daily that claims to be a labor and a Socialist paper. to boot, LAY LOW. Its Editor, Herman Schleuter, all in a tremor refused to take the protests from the fighting men of Local No. 1, containing an account of and exposing the rascality of their labor fakir officers, on the ground that the Board of Directors of the Volkszeitung Corporation had ordered him "to take no further (!!!) part in the controversy," while the gentleman's fit associate on the paper, Alexander Jonas, almost dislocated his spine in the snakish contortions that he went through before the protesters in his usual feat of trying to escape one lie by squirming into two. And all that, Why? The passage above quoted gives the answer-because of advertisements from the very brewery bosses concerned-advertisements that no

accept, let alone solicit! The maxim, quoted at the beginning of this article from the Volkszeitung is by the light of the above facts-to here leave unmentioned scores of others where that paper sold out the interests of the working class in consideration of advertisements and subsidies from labor fakirs and from capitalists-obviously needs amendment. It should run this way:

"No labor leader is safe who considers

honorable labor and Socialist paper would

harmony between Capital and Labor possible, and who denies the class struggle character in the struggles of our day. Consequently, and above all, no paper can be considered safe that, being the property of a private corporation, is able and ready to profit by the corrupt conspiracies of such labor leaders with the capitalist exploiters of labor; or that so completely shuts its eyes to that essential feature of the modern class struggle, the brotherhood of the working class. and the oneness of the plundering class, as to call 'traitors' only the Irish or American labor fakirs, but lovingly hobnob and share the plunder with its own German dittos. With the labor leader, the intellectual error gradually develops into a moral one, and the at first mistaken labor leader into a traitor; with such privately owned paper, however, the rottenness and treason are congenital, and the development is from rottenness to deeper rottenness, from treason to deeper treason."

Thus amended the maxim will hold water, and will be a pillar of fire by night and of smoke by day.

The press despatches report the capture by Hearst of the Rhode Island State delegation to the Democratic National Convention. It would be interesting to know to what extent, if any, the "Socialist" alias Social Democratic party of Little SHOT NO. 2.

The Louisville, Ky., "Journal of Labor," well known as an organ of the capitalist class has gathered a long string of questions which it heads "Pertinent Questions for Socialists to Answer." It is not our habit to answer the dog that barks from behind a fence. For the canine we keep the toes of our shoes, should be get too near. But even if he remains at a distance, if he is too insolent, we see to-what? To him? No! To his master. And so now, especially seeing that his master-the picbald combination that feeds and eggs him on -has been stupid enough to expose him self through these questions as a target that it will be fun to riddle with shot So now and at it, shot after shot-at the master. Shot No. 1 having been fired last week, now for shot No. 2.

Another of the "questions" is this:

"Is it not true that the policy of So cialist journals has been to slander and malign Trades Union leaders?"

Seeing that the individuals who make up the piebald combine behind the poodle -whether they be lay or clerical-have ever been found anxious when cornered to pronounce themselves "Socialist" of some description or other (Father Doyle is the latest clerical instance to our knowledge, Carroll D. Wright, the latest lay ditto) superfluous as it may be, we shall repeat that the Socialist Labor Party politely, and with whatever firmness may be requisite, declines to shoulder the "Socialism" of that mongrel crew. Excluding, accordingly, all such "Socialisms," the answer is:

No! The statement implied in the question is false of the whole cloth; moreover the shoe lies on the other foot.

The journals of the Socialist Labor Party have made a long number of charges against certain Trades Union leaders, in each instance named by name. For instance:

Gompers has been charged with and convicted of endorsing Jacob Cantor for Senator in this city within six months after Cantor had stood by and even applauded Governor Flower for sending the militia of the State to Buffalo, to break the efforts of the switchmen on strike to enforce the ten-hour law for railroad workers, which law the same Compers had praised as a victory; again,

Tobin has been charged with and convicted of making contracts that expressly provide security to the employers against higher wages, in consideration of their forcing their employees to pay dues to Tobin, and the documents were published; again,

Mitchell was charged with and convicted of helping the bituminous coal mine owners, Hanna among them, by keeping up the strike of the anthracite miners, while ordering the bituminous wing of the union to seab it upon its anthracite wing by remaining at work and furnishing coal. The figures were published showing the picnic that the bituminous coal mine owners had during the strike turning out coal at almost five times higher prices than usual-due to the searcity produced by the anthracite strike which was obviously lost;

Perkins of the cigarmakers was charged with and convicted of making himself a telephone for the lying claims of the capitalist class regarding the improved sanitation and longer lives of the working class. His figures, claiming that the eigarmakers were enjoying better health and longer lives, were pilloried with facts gathered from his own trade's journal and with the figures furnished by the Census itself, showing a vaster mortality; again.

A number of Trades Union leaders were charged and convicted of preventing the unification of the working class through the high initiation fees and dues that they demand-all intended to keep out members and establish a hard-shell corporation for a few; they were charged and convicted of denying the necessity of political action by Labor, while at the same time they were found on lobbying committees to Legislatures; they were charged and convicted of pretending to aim at the improvement of the working class by fathering certain legislative resolutions, and then betrayed their hypocrisy by supporting the parties of the capitalist class who would not listen to any such resolutions; they were charged and convicted with facts, figures and reasoning of ignorance and stupidity, and of responsibility for the obvious impotence of the Unions and for the obvious decline of the condition of the working class. To sum up, in a pamphlet entitled "Two Pages from Roman History" a long list of these miscreant labor leaders is furnished, stating the exact act of betrayal of the working class that they, as the "labor licutenants" of the capitalist class, are

U. S .- See here: Sound or Socialist economics prove that under the capitalist system the share of the wealth that # labor receives depends upon the supply of and the demand for labor. This ev. is a result of the private ownership c the machine. If labor receives one loaf's worth of wealth it is not because of the cheapness of the loaf, or because of any other reason; but because the value of the loaf represents the value of labor under supply and demand.

B. J .- Very well.

U. S .- Now then, this principle implies the other-that the cheapness of things does not determine the amount of wealth labor receives. The cheaper the loaf the lower will be the wage. In other words, the labor question is a question of production, not consumption. Your co-operative store takes up the question from the consumer's standpoint.

B. N .- But are not working men consumers?

U. S .- Surely; but their poverty starts with them as producers, and not as consumers. Seeing that their poverty arises from being a merchandise, the price of which is determined by the law of supply and demand, it is senseless to start relief at the consumer's end. Relief must be started at the producer's end. Enable them to keep all that they produce and their consumption will take care of itself. On the other hand, make goods as cheap as you like, and consumption will not be improved so long as the working class is held in wage-

B. J .- Well, that may be; but in what vay would my co-operative store play into the hands of false economies?

slavery.

U. S .- In this way: The middle class particularly is howling about prices. It may justly do so. If prices are low it will have so much more money. If wages are one loaf of bread, and the price of the loaf goes down 50 per cent., the working class won't be in pocket the 50 per cent, saved, because its own value will thereby have been reduced, and, accordingly, its wages will fall proportionately. But if the price of the loaf goes down by 50 per cent., the middle class and the capitalist generally will be so much in pocket, because their share of wealth is not determined like that of the workingman. It is for this reason that the widdle-class folks are always after cheapness; and it is a cry so de-Insive that it usually takes in the workers, and thereby draws their attention

OPENING THE EYES OF SUPERIOR'S WORKMEN.

To The Daily and Weekly People:-On Sunday, February 28, a successful meeting was held at German Hall by Section Superior, S. L. P.

Comrade Wilkie of Milwaukee, who happened to be in the city, spoke on The Difference Between the Socialist Labor Party and the Social Democratic Party."

The audience, numbering about 100 men, seemed to be much interested in the question, which the speaker handled in an admirable manner.

ALFRED MOSELY, LONDON, ENG .-The statement from the N. Y. "Journal of Commerce" that free trade is the "corner-stone of its (the Democratic party's) position" and that the party "can find littleelse to stand upon," is too sweeping to be correct; and yet there is no little truth in it. The fact is that to understand the tariff attitude of the two large parties one has to begin by sweeping away the cobwebs that both have woven over themselves and each other on the tariff. When that is done the following will be found to be facts in the case:

1. The doctrinaire protectionists are in the Republican party; the doctrinaire free-traders are in the Democratic party. 2. The doctrinaires rule neither party.

3. Both parties raise and both of them lower the tariff according to the concrete interests of those in control. For instance, the Dingley tariff was gentle on certain lumber, because Dingley (Republican "protectionist") imported lumber from Canada; he wanted "free trade" on that; on the other hand no Democratic tobacco leaf-raiser in Democratic Kentucky would listen to anything like a lower tariff, let alone free trade on tobacco: etc.

4. All that the doctrinaires do is to furnish theories which either side uses as occasion may offer.

5. With these qualifications, it is true that the Democratic party has little else to rest on than free trade, that is to say, in that party are grouped the interests who want free trade on more things than the interests grouped in the Republican party want free trade on; and inversely, in the Republican party are grouped the interests who want protection on more things than the interests grouped in the Democratic party want protection on.
