This statement is as manifestly unfair as it is untrue The Socialist Labor Party was teaching clearly scientific socialist philosophy be fore the bastard (S. D. P.) was born of the Debs colonization scheme, and the newly born movement which set itself ountry, in its methods and tactics and n its knowledge of economics bore about the authority of Daniel Conroy and Fred Lloyd, who have been closely identified the same relation to the real Socialist Movement that a newly born infant does to a full grown and intellectually matured adult. That the real party of Socialism, the S. L. P., should condemn the alien would-be rival in the political field, with its puerile tactics and hostile attitude towards the real socialist cult, was natural. The facts and conditions have not changed materially to-day. There s room for only one Socialist movement If there are two in the field, one of them must be a pretender. It follows, then, that S. L. P. antagonism towards the propagandists of a false politico-economic cult has been simply an incidental part of the important work the S. L. P. has done and is doing in its warfare against

Capitalism and its allies in ambush. That the S. L. P. position in its philsophy and tactics has been corre attested by the fact that as the youngng rival grows older it has gradually een adopting the methods, tactics and phraseology that have characterized the S. L. P., but without giving credit to the party that originated them. But, does the S. L. P. really "fight" us! Does it not rather, as our schoolmaster, punish our recalcitrant conduct by laying over its knee and applying the shingle n vigorour castigation! COST OF MINING COAL.

Intensity of Labor Makes American Cheaper at Pit Than Any Other.

It is interesting, as having a bearing n the general costs of production in which coal plays so prominent a part, to find that the estimated value of coal in the United States is much less than the value of coal mined in the other great fuel-producing countries. Thus, although he production of coal in the United Kingdom was nearly 43,000,000 tons less than the production of coal in the United States, the value of this fuel at the pit's nouth in Great Britain was estimated to be \$467,000,000, while our coal had at \$372,060,000. The German production in 1902 was only a little more than half as much as ours, but the value given to this output at the pit's mouth was more than two-thirds the value of the United States output.

The difference is due not to the quantity of the coal, but to the superior methods employed by us in mining and to the greater efficiency of those who work our mines. We employed as miners in the year 1902 518,000 men, but our English cousins had engaged in this work 805,000 men and the Germans about 450,000. The necessity of this is made evident when it is seen that the aver age production per miner in the United States was 520 tons, in the United Kingdom 278 tons, in Germany 242 tons, in France 198 tons and in Belgium 166

This shows why it is that we can af than what is paid to their rivals in what are frequently assumed to be competing countries. By more intelligent employment and, we dare say, by the utilization of machinery for hand power we are able in this industry to make men twice as productive as their competitors on the other side of the Atlantic, and this, too when a large proportion of those engaged in mining in the United States are of foreign birth and of such brief stay in this country that they do not speak our language.-Boston Herald.

THE EMPTY CRADLE

America's Race Suicide Not An Evil of the Working Class

Mrs. Lydia Kingsmill Commander, in discussion of the "race suicide" question in the Independent shows that the large family is no longer an American institution, especially with the rich and the middle class.

In the early days of this country the large families was considered as conducive to the welfare of the nation as well as a blessing to the parents. Benjamin Franklin was one of fourteen children, a number far from uncommon at that time, but scarcely to be met twice in a lifetime now. Franklin stated that eight was the American average family then and, figuring on that basis, fore saw for this country a population of 100,000,000 by 1900.

Instead we have 76,000,000, of whom 11,000,000 are foreign born and 13,000, 000 the children of foreign born parents So far from eight being now the average family, that number is considered astonishing large.

The fact that landlords in the "better neighborhoods" refuse to rent to large families, is taken as evidence that the number of families with few or no children is now great enough to furnish them with a sufficient supply of the sort of tenants they prefer.

In a house on the Boulevard containing suites renting from \$400 to \$800, Mrs. Commander found sixty families and only five children. In another, among thirty-five families there was only one child, a month old baby. In sixteen eleven-room suites in the next block only four children were found.

Two houses, side by side, each contained twelve eight-room flats. These were especially large apartments, there being one hundred feet of private hall running from the rear of the drawing room to the front of the dining room The former room was 23 x 21 and the latter almost as large. The rents ranged from \$800 to \$1,200, indicative of incomes from \$4,000 to \$6,000; yet in one house there were three children, in the

Twenty-two apartment houses, containing 485 families, were visited, in which were just 54 children, or about one child to every nine families.

Mrs. Commander visited forty-six New York physicians, men and women, practicing in different parts of the city to get their opinions on the question. Thirty-eight of them were willing to discuss the matter, thirty considered the ideal American family consists of a boy and a girl. Six said one child. One said: "Having a family is not an American ideal." One woman physician whose practice is among people living on incomes ranging from \$3,000 to \$5,000 said that among her patients the majority did not want any children. When they do want one, the second is an accident, the third a misfortune and the fourth a the pit's mouth an estimated value of tragedy. She had on her desk a photograph of the largest family in her practice-the picture showed three children!

The doctors interviewed whose practice was among people in comfortable circumstances, all agreed that the large family does not exist and is not wanted. Clerks and bookkeepers ape the "upper class" in this as other things. Shrady deplored the falling birth-rate among native Americans, but says: "The Irish, the Germans and the Italians go shead and have children," The foreign population is freest from the tendency to restrict the family but, is influenced to some extent by the American idea. Mrs. Commander says that the only

physicians who gave her reports of unrestricted reproduction were those who had patients among the "unintelligent poor." One such doctor said that the tenement woman having no sense of responsibility, and no care for her childreh after they are here has children without regard to numbers. One thought that the poor were indifferent as to how many children they had, because they could depend on charity to help provide for them! The general testimony of the doctors with experience among the very poor is that there is no "race suicide" in that quarter.

The very rich want a child as heir, the well-to-do and those in more moderate circumstances, do not want to support more than one or two children. The American man of to-day has no horror of a childless life.

The opposition to large families is not only individual but social. Not only do | tion New York.

A physician who has practiced in New York for over twenty years among well-off Americans, as well as having done a great deal of clinic work, said "The large family is never anything but an unintentional misfortune at the present. Nowadays the mother of a large family feels humiliated. She is really an object of ridicule. People laugh at her at best, and blame her if she is poor. Society does not approve of many children. Unless people have plenty of money we do not excuse them for having a large family. We know that only ample means will enable parents to do justice to many children." Another doctor, who has practiced for six years among different classes of people, said: "I often have women say, Doctor, I

be laughed at." The opponents of Socialism bring the charge that Socialism would destroy the family, but we have evidence that under capitalism the family is fast disappearing, its decline being greatest among the rich and the middle class. This decline is not due to a natural falling off in the reproduction powers of the race, it is due to the adoption of measures calculated to limit or elmininate the family. Those who make no effort to limit the number of their children are the wage workers, and for this they are dubbed ignorant and irresponsible.

CURRENT COMMENT.

According to a Norfolk dispatch of the 7th, inst:

Clerks at the Southern Stamp Works at Richmond, Va., struck yesterday rather than be bossed by a womar. The foreman resigned and the proprietor, Samuel Rosendorf, placed Miss Ray Henshall in charge of the force. The men employed, some of them married and with families, decided, with all due respect to Miss Henshall, that they did not desire to work under a woman.

Such attempts are bound to fail, for capitalism will employ woman wherever she proves more profitable than man, and as long as woman finds it necessary to seek employment. The remedy is to be found not in an anti-woman crusade, but in the overthrow of the capitalist system, which profits from woman's employment and necessities, to the detriment not only to the male, but to all the membersb of so-

The asphalt workers, whose strike was supposed to be settled, and who are now at work, threaten to go on strike again this week because, they say, they are getting blacklisted and less wages under the agreement by which they went to work pending arbitration of all disputes. The Teamsters' Union, which ordered a strike in sympathy with the asphalt workers, says, too, that it has beeen left out in the cold in the arbitration arrangements and that its striking members are still idle. This is what happens whenever arbitration follows a strike. It goes to show once more that arbitration is a method of ending strikes in the interests of the emeployers.

The Southern cotton manufacturers, attending the convention at Washington, are congratulating themselves on the superior economic conditions that they now enjoy over their Northern competitors. They attribute the satisfactory progress of their mills to the demand for tentings, wagon covers, and other coarse cotton goods, created by the war in the Far East. These manufacturers are unconscious of the condemnation of capital ism that their words involve. Think of it! In order to make the child slavery of the Southern mills pay, war in the Far East is essential!

The star of empire is not journeying westward unaccompanied. From Minneapolis comes the news that the cigar trade is very much agitated over the report that the trust is going to open retail stores there.

WEAVING REVOLUTION

INTENSIFIED BY NEW INVEN-TIONS. Introduction of Long Bobbins and Elec-

WEAVERS DISPLACED AND WORE

tric Stop Motions on Cotton Looms Means More Profits for Manufacturer: and More Hustle for the Workers.

Fall River, May 16 .- It is estimated that no less than 5000 looms in this city are equipped with the long bobbins and mechanical or electrical warp stop motions. The adoption of this system is said to be a part of a plan which is revolutionizing the method of weaving in the mills and which is now only in its infancy. Three large machinery concerns are prepared to supply the growing demand for these improvements, and the mills are adopting them as speedily as possible. By their use, weavers who now attend a maximum of eight and ten looms look after from tweive to eighteen, and the number of weavers is reduced thereby.

The change is not being made without opposition. Already it has been taken up by the Executive Committee of the Weavers' Union. The members believe they see in the change a determination on the part of the manufacturers to reduce the wages of weavers materially, and exact from them more labor than they are disposed to give. Up to this time there has been no great outbreak among the unionists, as the trouble at the Bourne Mills, which is still on, is the result of dissatisfaction with other kinds of looms and the wages paid for handling them.

Manufacturers figure that they are able to save from three to six-tenths of ament per pound in the cost of weaving, by making the changes required, and they are able to use the common looms with some modifications which are not costly. It is estimated that a cost of \$25 per loom is entailed by equipping with electrical warp stop motions, and there other costs in the spinning department due to the additions of contrivances designed to put more yarn on the bobbins which go into the loom shuttles. In the estimates of savings given above, the interest on this money is included, so that it seems now that eventually all the mills will adopt the new system in some form. At this time the looms using the new devices are being operated on plain fabrics, as well as on five and seven harness work

The proposition before the weaver is this, in substance: "Do you care to operate eight looms under the old system, doing your own oiling, cleaning and aweeping, for \$8 per week, or would you prefer to look after twelve or more looms, for \$10.50 per week, and have others supplied to do the cleaning, etc., for you?" Up to this time most of the looms. This is due, in some measure, by the fact that the mills are not running in full, and work is not plentiful. Under the new system, manufacturers supply boys or young men to do the oiling, cleaning, and so on, leaving to the weaver only the work of attending strictly to the business of keeping the looms in operation. The manufacturer profits in two ways by the system. He gets cleaner and better cloth, and he gets a fuller production because the looms are kept more constantly in operation.

But, as in all cases where changes in the methods and working are made in consequence of the invention of new machines, the present revolution is causing some uneasiness, and many manufacturers hesitate to try the new means through fear of friction with the operatives. That phase of the proposition is as old as the adoption of power loom to supplant the hand loom, and will eventually result in the acceptance of the new methods by the weavers. In mills where it is feared that a prejudice might be strong against the adoption of the electrical equipment, manufacturers have chosen to supply the loom shuttles with bobbins containing about twice as much varn as the small and common bobbin in everyday use. By this means a great saving is made, as weavers have to replenish the bobbins only half as frequently as before, and the number of idle moments in the weaving department is lessened. That means more production from the machines and a con sequent lessening of cost.

"The nine strikers yet remaining in ALMOST ANOTHER SLATERSVILLE the village have been in the lead of the MADE OF VILLAGE BY BRAVE striking movement since it was inaugurated two months ago, and they consider MAINE FIGHTERS. themselves as marked men who must go

elsewhere for work. During the strike aid was sent to the strikers from other mills but no attempt was made to create a union effect by calling on the unions

of New England. Some of the people at present weaving in the mill are from the ranks of the original strikers, while others are strangers in this section. When the mill starts on full schedule again the vacant rents will be taken by strangers, but it is feared that for a long time the personnel of the help will not be such as was the old, most of whom had never worked in any other mill and had home and families in the village. The declaration that the strike is off is made on

with the strike since its beginning." The "strangers in this section" who con stitute the "change in the personnel" of the village are, a few poor Finlanders and Italians who were imported when the company was making vain efforts to break the spirit of the strikers. It will be noticed that the "village traders," the little business men who were so happy when their friends, the Selectmen were aiding the mill management to bring in the now unwelcome "dagoes" in the hope of scaring us back to work, are becoming very apprehensive of the result of their own middle-class stupid-

With their best customers out of their clutches and only a few "dagoes" to replace them, the matter has assumed a new face for the traders. Now they are beginning to look around and ex-"Furriners, dagoes, b'gosh! No money in them fellers. Any more of em comes along, next think we'll have the dago trader, b'gosh! Then we shan't be able to sell a derned thing to the varnints. No sirree, not a derned thing!

The little trader who never can se eyond his nose or his cash drawer, will not, however, be able to see the point n or draw the moral from this attempted importation of "furriners" as can we of the working class. And it is one that we should take to heart and do our best to bring to the attention of our fellowworkers; namely, that however much ur good American capitalists and their political henchmen, Republican and pocrat alike, may, at the approach of election time, try to bluff us with the pretence that they are willing to restrict or regulate immigration; however much they may theorize for our delectation about the high standard of American labor, their desire to conserve it, etc., they only do so for the double purpose of hypnotizing us into the be-lief that they are our friends and thus gaining our votes and incidentally stirring up in us a batted of our foreign fellowslaves in the hope of keeping our class divided. Incidents like this at North Vassalboro teach us that in practice the material interests of the capitalist. eigner whom he would have us despise is imported and to take advantage of that same foreigner's ignorance or ne cessity or both, to use him as a club which to beat us into submission to the terms he wills us to accept. The olitical representative of capitalism who tries to give any such jolly to those who were involved in this strike will waste

The strike is ended. It was bravely fought and those men and women wh took part in it deserve due credit for their display of courage. The members of L. A. 392 have taught the American Woolen Company another severe lesson The spirit and principles of the S. T. & L. A. have been again proven genuine and the necessity for building up such an organization and making it a powerful actor in the industrial field again made spparent. On with the good work.

That a rise in wages is offset by a rise in prices is not theory alone, it is a fact that is demonstrated to us every day. We also know that, in spite of the claims of pure and simple trade unionism that not a party of the future, we are a party of the present and the immediate present at that. What do we know of the future solutely. Relatively, if compared with the share of the workers' product, which the capitalist appropriates, absolutely when compared with general comforts, length of life of the workers, etc.

It may be argued: "If the workers gain nothing from a nominal increase in wages why do the capitalists oppose an increase in wages?" The capitalists understand their position well. "Why should they jeopardize their capital by bringing in-dustry to a standstill? They could just as well grant an increase of wages since it will come back to them in the form of

Terrible Thrust (!!) Made at "Sozialistische Arbeiter Zeitung" in the Letter Box of the "Chronicle," a New Fakirs' Sheet-Most Probably Started by Graven, Pommer & Co. for the Purpose of "Doing Dirty Work" to the National Union-Next Number Will Contain Biography of "Mr." Graven.

New York, April 3. At last the "Sozialistische Arbeiter Zeitung" has received its just deserts! and by no less a personage than the archcorruptionist, editor and secretary of Beer Drivers' Union, No. 23, the individual named Graven.

For three weeks, there has appearednot "to fill a long-felt want"-but, as the editors themselves concede, for the present without any necessity, a weekly paper; called "Trade Union Chronicle."

This curious publication claims to be the "official organ of Beer Drivers' Union No. 23, of New York and vicinity," although the members of this union-at least as many in the Bronx as I have had an opportunity to question-are in absolute ignorance of any resolution passed authorizing the publishing of a paper of this kind-still whatever the officers do, must be right. No member will dare to kick, for the orders read "Pay and shut up!"

In all modesty the editors of the sheet omit to publish their respective names, still even without the possession of the asserted that their names are Graven, Pommer, et al.

At the first glance, the "raison d'etre" of the printed thing does not appear very clearly, but its authors may be relied upon to be quite clear as to its final

purpose.
Undoubtedly the Brewers' Union faces a serious crisis. It refused, as is well known, to transfer its engineers and firemen to their respective trade unions, as resolved by the convention of the "American Federation of Labor," held in Boston In New York there no longer exists a necessity for such action, for ever since the signing of the infamous pool-contracts, the union engineers and firemen have found themselves compelled to surrender to ex-Deputy Sheriff Healy and Ward-heeler McMahon, at their own

The few members of this branch, who did not waver up till now in their allegiance to the union, have been able to stay at work in only a few of the independ ent breweries, and some of them, who were deprived of their jobs, work in factories and ice-houses, although they still continue their contributions to the Brewers' Union, members of which, s good many have been for over twenty years. And just these decent fellows who still believe in the intention of the International Union to regain last ground, are again being left in the lurch by the International officers, for, as far as Greater New York is concerned, the resolution to retain the unions of this branch within the national body, does not seem to exist.

The "Central Fakirated Union" is quite busy at present wiping out this small remnant, without any protest whatsoever on the part of the International officers. It seems that the latter, hoping for peace in the future, have left the field entirely to Pommer, Graven, et al.

Will this hope be realized? The publication of the above mentioned paper does not seem to warrant such belief, for the standpoint of the International Union does not find a defender in this sheet; while on the other hand it coquets with the centralized fakirs, whose latest resolution, to demand of Chief Fakir Gompers the withdrawal of the International Union's charter to the American Federation of Labor, it has not criticises in the

Denver, on April 18, the General Executive of the American Federation of Labor will decide, if the Brewers' Union shall be suspended or not. On this day, too the "Chronicle," or rather Graven, Pommer at al., will have to reveal its true color. These are the "honest people" in whose company the International secretary celebrated such an extremely joyous Christmas, after which he reported to the "Brauerzeitung" that, when the hour of danger should arrive, the New York and Brooklyn brewers' and drivers' unions would be found stanch supporters of the International body.

Whatever induced him to take this view is as much of a secret as the surmise that the Graven and Pommer Sauls should suddenly have been transformed into Pauls of the purest dye. It is much more probable, that, in case the American Federation of Labor should suspend the International Union, Pommer, Graven, Bohm et al., will remain true to the old Judas-roll and, by order of Gompers, "reorganize," or rather, destroy, the International Union. Naturally, these gentlemen will then be the officers of the new union, with "The Chronicle" as its official organ, for if these corruptionists desire the welfare of the International Union they surely would make use of the "Brauerzeitung," which has a much larger circulation.

For the present, the "Chronicle," mentioned above, has taken issue with the "Sozialistische Arbeiter Zeitung," whose disclosures have seriously disturbed the peace of mind of these unspeakably low rascals. Graven, the "proud Graven," rises to the following remark in the "letter-box":

SUNKEN PIERS.

Within one month two important decisions have been wrung from the courts by the Socialist Labor Party, thereby it sunk deep and sound two of the piers on which to rear the superstructure of manhood and freedom for the American workingman. The first of these cases was that of Michael T. Berry at the Tobin-Carey Boot and Shoeorkers Union, the second that of Charles Corregan against the Lynch-Hanford-Hayes Typographical Union. In both cases, the labor lieutenants of the cap-Stalist class who run those so-called Unions, "Secret Committees" and other , sought to victimize an S. L. P. mber for holding his political convictions and for free speech. In Berry's case they managed to throw him out of work because he refused to bend the knee to an organization that, under condition of the employers paying its officers for the label, promise the employer immunity for any rescality that he may com against his employes. Berry sued and got judgment for \$1,300. In Coran's case they threw him out of work after a "trial" to which he was not summored and on charges that he was not notified of, these charges being that he sed the right of free speech on the litical stump and proved the labor fakirs of his union to be a scabby crew whose actions were detrimental to the workers. Those two actions were signal calls. The posture of the S. L. P. n in these cases was one to encourage the workers everywhere. How much encouraged may be judged from the cir tance of the tomb-like silence observed upon them by the capitalist press. Most remarkable is their silence in the Corregan case. This case was decided against Corregan in the lower court several months ago. Immediately the capitalist press of the city burst forth into flaming head-lines, rejoicing at the way "the Socialists were downed." Now that the Appellate Court reversed the decision as preposterous, not a line have these talist papers. These papers know their friends and the foe of their

The New York "Sun" had to bite the dust before the labor fakirs who own the ernational Typographical Union, and pay them \$300,000. The S. L. P. makes the fakirs bite the dust.

LAWFUL SANDBAGS

Who was it that said words are inled to conceal and not to express thought? Whoever it was must have anticipated the capitalist politician, and certainly he hit the nail upon the head, how well he hit it may be judged from the following passage with which Eliot Danforth initiates the public into the thoughts of the prospective Democratic candidate for President. Having interviewed Judge Parker at Esopus on the burning question of the Trusts, the aspirant after the mantle of Theodore Roosevelt is reported to have said that he

"In favor of reducing customs duties wherever they enable lawless capital to wring extortionate prices from the con-

Lawless capital-as though there were uch a thing as lawful capital, any more

proved means of labor which, though proluced by the workers, is held by the idlers, and thus enables the latter to sandbag the people with, both as consumers and as producers. It sandbags them as consumers by arbitrarily raising prices; it sandbags them as producers by disabling them from competing with it, and thus compelling them to becom its wage slaves.

As the sandbag is a criminal weapon so is capital; the one and the other looks noffensive, leaves not even the mark of its blow, but all the more deadly is its result upon its victim. As the Democratic party, the same as the Republican, would sanctify the coward's weapon, their real name is the Sandbag Parties.

THIRD EPISTLE AT THE LAMBER-

In the two previous epistles we de molished two of the preliminary fallacies with which Father L. A. Lambert introduced his condemnation of Socialism in the April-16th issue of the "Freeman's Journal and Catholic Register." We are not yet ready to move to the assault of Father Lambert's main positions. Following the maxim of sound strategy, we propose first to open another breach in his fortifications. Accordingly we shall now leap to his concluding remarks, which are intended to buttress up his reasoning. He says:

"Socialism, according to its authoritative exponents, rests on a basis of materialism and atheism; it is therefore naterialistic and atheistic, and is therefore the foe of the Church and the fam

The architectural intricacy of twisting materialism," atheism," the "Church' and the "family" into one will not save the redoubt from demolition. Its keystone is the charge of "materialism." Now watch it crumble.

Two distinct schools of sociology divide society upon the subject. The on the anti-materialist, maintains that the ideal, the spiritual, the intellectual, institutions, in short, mind rules the world: its motto is: "Man does not live on bread alone." The other, the mater ialist, not only accepts the motto, but ictually takes the motto for its own device, and shows that the motto not only sums up the philosophy of materalism; but overthrows its adversary, the anti-materialist school. The materialist says: "Aye, aye, not of bread ALONE does man live, hence he needs bread ALSO, without which bread (matter) his mind (spirit) cannot function ate." And the materialist, accordingly rears the principle that matter is the roundwork, essential, and consequently, letermining, for the actions of mankind. It will not here be necessary to go into obstruse reasoning in order to prove the fact. It can be proved concretely. The concrete proof can in all instances, be taken from the mouth of the anti-materialists themselves. So it can and shall be in this.

vanization or institution, the Church, the

ery highest non-material, spiritual attributes. And yet, to take but one instance out of scores that might be adduced, one that may be said to sum up capitalist society, the one and the other all the others, what is their own language? what is the language of their authoritative, their "infallible" exponents? It is this: "Without TEMPOR AL fower the Church cannot fulfil its SPIRITUAL functions"! Here we have from the camp of the Lambertians themselves-a camp, at that, which claims to act directly under the inspiration of the Deity, aye, to represent the Deity on earth,-the plump and plain, however unwitting, admission of the full materialist theory,-of all that is essential to that branch of Socialist philosophy. If the spiritual functions of a divine institution are unfulfillable without temporal (material) power, how could man ecomplish the feat? Of course, he can not. Hence Socialism, planted squarely materialist philosophy, maintains that material conditions determine man's conduct, and, in order that his conduct shall be abreast of his mental and spiritual aspirations, he must furnish to these the requisite material basis.

Thus the fact is obvious that the essential difference which divides Socialism from Lambertianism on the subject of materialism is not a difference in practice, but a difference in preaching. The former, the Socialist, preaches what e practices; the latter, the Lambertian, preaches one thing but practices another In short the former is truthful, the latter, whether intentionally or not, is untruthful, and, consequently, if not a and intellectually unreliable guide.

Socialism does not derive its strength from the circumstance that other institutions stand upon this, that or the other Socialist principle. A Socialist principle does not become right because ome other ism also stands upon the principle. Socialism is self-sufficient; it rests upon its own basis. It must stand or fall according to its own soundness Not, accordingly, in order to establish the propriety of materialism is the demon stration of the fundamental materialism of the Lambertians adduced. The shot is fired to demonstrate that the pronounced foe of Socialism, Lambertianism, kicks itself to pieces when it attacks Socialism from the materialist side.

The "anti-materialist" buttress of Father Lambert's fortification is shatter ed. Being pivotal to the others-the "atheism," "Church" and "family" buttresses-on that side, the latter now wabble in the air. They may now be disregarded. The closing epistle of this series will wind them up. At present, wide enough breaches have been knocked through Father Lambert's outworks, for Socialism to storm the Lambertian citadel, and plant upon its ruins the banner of human freedom-intellectual, po

These successive storms will be the subject of the next epistles.

WHERE EXTREMES MEET.

Commissioner McAdoo issued on the tenth instant a statement in which h proved the connection between the poolrooms and the Western Union Telegraph Company and the New York Telephone Company. Thereupon the New York 'Evening Post" produces the names of the two directorates and proceeds to say

"To put the matter in plain English here are thirty-eight of the most promiment men in the country, who are responsible for the conduct of two comanies that systematically abet a felony for the sake of profit. No one of these gentlemen can justify himself on the ground that, scourged by poverty, he nust snatch at every dollar in sight, whether he wins it by fair means or foul. That defence is reserved for the outcast who steals bread for his starving family. No; the only pretext which President Clowry of the Western Union and President Cutler of the New York Telephone can suggest is that they want to swell the receipts of concerns that are already highly prosperous."

In other words, the financial interests hat control the "Evening Post," whose felonies the "Evening Post" habitually upholds, but whose interests are in conflict with the directorates of the Western Union and the Telephone companies, land the paper flat upon its back along side of the justly ridiculed wild-eyed reform freaks who see in the iniquities of capitalism only the result of the "greed of capitalists." The fact is that the "justification" of the outcast who snatches at every dollar in sight, will essentially hold good with the capitalist who swells the receipts of his "already highly prosperous concern." From the premises of the same.

Driven, scourged by poverty felony is committed, is not the capitalist also scourged? Can a million dollars, gathered under capitalist rule be kent safe without they are buttressed up by two millions? Do not the requirements for keeping the buttresses safe call for further millions? - How could these outworks of rapine, styled "individualism" be protected without a lavish expenditure of bribe and corruption funds? In short are there not, in direct ratio to the prosperity of a capitalist concern ew, imperative and absorbing wants orced upon it? Finally, is not "a dollar in sight" for the physical outcast with a starving family, quite as much as million in sight for the moral outcast who owns a "prosperous concern," all the more clamorous in the measure that it is "prosperous?" and inversely, is not, to such a concern, a million in sight as imperative as a "dollar in sight" to the

The felony committed by the Western Union and the Telephone Company illusrates where and how the extremes of capitalism meet. The underlying w of capitalist society is a scourge that ourges its members to felony-both extremes land at the same spot; nor is

free from guilt-it inevitably sheds the two. As the outcast of capitalist society commits felony to escape starvation, the pillars of capitalist society are forced to the same course lest they be come outcasts. In all of which lies a beauty of capitalism-its suicidal fea

Happily under the toppling tree of cap italism the acorn of Socialism is shooting up, ready to take the suicide's place and with its sounder growth afford a sounder social system.

WHOSE THE BLAME?

The echoes have not yet subsided of the great speech recently delivered by the New England Senator Lodge on, or rather, against immigration. It was great speech if greatness is to be meas ured by the stupendousness of an effort to make a pyramid stand on its apex. In that speech Senator Lodge attributed the hard times to the foreigner who comes to these shores-they, poor, ignorant, unskilled, and otherwise no good were the cause of Labor's troubles. That speech should be read by the light of the report, published in these columns, of the recent S. T. and L. A. strike at Vas salboro, Me. The facts brought out in that strike and given by the Maine local papers with regard to the foreigner are nothing new, but they come in timely to appreciate the monstrousness, or falsity of Senator Lodge's theories.

It is difficult to imagine a more self damaging attitude than that of the anti immigration capitalist jingo. He does not seem to realize how he contradicts himself. If the immigrants are so worthless, how can they take the places of the worthy natives? Can worthlessness displace worth? If the immigrants are so poor, how can they control the job which are the gift of the rich natives and capitalists? Can poor fellows force the hands of these rich natives and compel them to kick out natives and put foreigners in their places? The posture is too absurd for contemplation. The Vassalboro strike furnishes the facts.

Whatever "foreign trash" came into the place was fetched thither by the woolen company and THE SELECT-MEN OF THE TOWN. Without the urgent labor of these, the "foreign trash" could not have come, and much to the sorrow of these natives and capitalists so few were the foreigners that the strikers have inflicted irreparable loss upon the place. Unwilling to submit, they left town, and the how deserted place has become a free academy for the tradesmen, whose shops are now empty, to ponder over the beatitudes of capitalism.

On the New England soil, Senator Lodge's New England, in Vassalboro, we see to-day the native tradesmen and the rich Lodge-loving capitalists on their mental knees, before mental "furriners," mentally imploring these to come inand do what?-save the nation?-No help drag it down by lowering the standard of living and of manhood!

It is American capitalism that is di ging the native down to ruin; and it is Labor, whether native or "furrin," but class-conscious and characterful that gives it the only hope of salvation.

IN THE THROES

It is symptomatic of the struggle be tween employer and employee that as it grows in intensity and proportion, there are increased efforts made to belittle its significance and extent. The bad labor conditions and strikes of the early years of American industrial life are conjured up and the historically false contention is made that in the past and not the present is to be found the greatest de gradation of the working class. Like wise only very recently was it claimed that May Day was losing its significance, because working class conditions in this country were so good as to be unfavorable to the propagation of its doctrines. Unfortunately for them, two of the leading capitalist newspapers just come to hand, furnish information to indicate in how far these efforts to deride the class struggle are true, and in how far these contentions reflect the conditions which they are the symptoms.

The financial section of the Evening Post of Saturday, May 7, contains an article entitled "Business West and South," in which "one of the three mercantile establishments employing the largest number of salesmen in the coun try" gives the following picture, drawn from the data of these salesmen of labor conditions in the sections mentioned:

"Poor business in many sections is attributed to the unsettled condition of organized labor. Western Pennsylvania. northern Alabama, southeastern Iowa. eastern Ohio, and Colorado seem to be in the throes, and while conditions are brightening up in Pennsylvania, Iowa, and Ohio, Alabama, and Colorado are still up against it."

With five states in two sections "in the throes" of labor troubles, who will be so bold as to claim that present labor difficulties are as nothing compared to those of the past? When was there ever a time in early American industrial history that such a picture was presented?

"Bradsreets," also of Saturday, May observes editorially:

"May Day has lost some of its old time mportance as a period from which to date strike or other industrial disturbances, but there is still enough climatic or other influence making for unsettlement to render that day a notable one in the labor world. Agreeably to expectations, there have been, from the standpoint of numbers engaged, a large number of rather unimportant strikes or lockouts occurring this week which, reports to Bradstreet's indicate, involved nearly 45,000 men. Strikes of coal miners in West Virginia and Eastern Ohio, boiler makers in New York City, building hands in Philadelphia, vesselmen on all the great lakes, machinists in railroad shops in the southwest and wagon makers in New York are among the important troubles brought into evidence. In addition, strikes of bakers in Chicago and Boston have been especially annoying to consumers, who in some instances have been put to straits to provide for daily wants. Such incidents as the shipment of bread in large quantities from Pittsburg, Milwaukee and other points to Chicago exhibit the harrassing character of the labor troubles.

"At no time this year, however, have labor disputes assumed the epidemic character of last year, when the most disturbed labor conditions for nearly a decade existed. In all, about 170,000 men are reported to have struck since half the number striking in the same period last year. It needs to be recalled, however, that the real crisis did not come until after June 1 last year, that date seeing fully 300,000 persons idle as the result of strike disturbances, and over 600,000 striking for, the year 1903. It is possible that the number idle this year will show great increases later; but it is to be noted that business is quieter this year, conservative labor men are and have advised against extreme de mands, and there has grown up a more determined spirit among employers, who are more wifling to meet organization with organization, and shut down rather than grant exorbitant demands to the unions. It is satisfactory, therefore, to know that the present rather slow trade and poor crop outlook is apparently not to be further complicated by widespread These editorial observations of "Brad-

street's" furnish some of the details of the picture "In The Throes," painted by the mercantile house quoted by The Evening Post. They re-enforce the fact of the extensiveness of modern labor troubles, an extensiveness such as was unknown in early American industrial history. Further they show that May Day has not suffered at all from the al leged superior working class conditions of the present. On the contrary, they show that such is the degradation of labor, owing to "the hard times," and the attitude of the labor leaders and the employees, which are predicated on them, that a more extensive revolt is inad-

visable at this time. Labor awaits a favorable opportunity to again make more demands on the employers. Whether this opportunity comes on June 1 or later is immaterial, but come it certainly will. Then the smoldering embers of discontent will burst out into labor conflagrations, or strikes, whose heat and intensity scorch capitalism, as .it has never been scorched before. The class struggle is on. No amount of fine assertion, written or unwritten, will waft it aside. Capitalism is "in the throes" of it, and will be in an ever greater degree until its end.

Said E. H. Harriman, the railroad magnate at the opening of the St. Louis

Fair: "The first law of all our civilization is the co-operation of all individuals to improve the conditions of life. By division of labor each individual is assigned to or takes his special part in our social organization. The specialization of labor has become most minute. Not only is this true in scientific and philosophical research and professional and business life, but in the simplest and earliest occupations of men, such as the tilling of the soil, the specialist is found bringing to the aid of his industry expert and scientific knowledge.

"Thus modern society has become emplicated organization or machine which can only move when all its parts harmonize and which is obstructed or breaks down when any of these refuse to co-operate or perform their special functions."

Harriman needed only one thing more to complete the beauty of his address, and that was to show that since society labors co-operatively the means where with it labors should be owned co-oper atively. As it is now the Harriman's are the only ones who get the benefit of social co-operation.

NOE EVEN A FAKIR TO REPRESENT LABOR.,

To the Daily and Weekly People. has been some time since Erie has been heard from in the columns of The People. and it is about time that we made a report to our comrades as to how the battle is going in this city.

Some time ago the employers of labo organized under the name of the "Citi zens' Alliance," which is directly connected with the National Employers' As sociation.

They have adopted "the open shop policy, and, in many cases, have tied the working men who belong to the pure and simple unions by certain agreements. among which was "the abolition of the sympathetic strike."

Now the bosses are beginning to show their "love" for the working class: they (the business men's exchange) have elected, or intend to elect, a "board of governors" to settle all labor disputes, and their decision "shall be final and binding."

Labor has nothing to say in this matter, as our class is in no way represented not even by a fakir. This clipping from the Erie Herald, dated Monday, May 9, will make this clear:

"BOARD OF GOVERNORS

"Members Will be Elected by the City Firms This Week.

"Representatives on the board of gov ernors which will settle all labor difficulties and disputes in the future will be elected this week by the several firms represented on the Builders' Exchange. The master plumbers have already elected Fred. J. Miller and Adam Karch and the master builders E. W. Constable and Charles Schaper. The governors will be under \$1,000 bonds for the faithful performance of their duties. The decision of the board will be final.

"In voting the apportionment will be as follows: General contractors and builders, 10; plumbers, 6; architects, 2; brick manufacturers, 2; bricklayers, 2; cut-stone contractors, 1; electrical contractors, 2; excavators, 2; builders' supplies, 2; hardware dealers, 4; lumber, 2; stone masons, 1; painting contractors, 3; cement and plaster, 4; tinners, 5; total, 49. No more than two men will represent any one of these trades or firms and only one where a trade is entitled to a single vote."

We held a meeting at the corner of Tenth and State streets last Monday night, in order to call the attention of the working class to the fact that they must be upon their guard, and to begin our open-air meetings.

In the afternoon I called upon th Chief of Police to inform him of our intention. After a few questions as to the nature of the meeting, and the subject to be discussed, he referred me to Mayor Hardwick, who was present in the chief's office.

I had to explain to this pompous in dividual "why we were not able to secure a hall" for the occasion, and stated that even if we were able to hire a hall, we would not do so, especially as the weather was favorable to open-air meetings.

This seemed to anger his honor, and he said in a fierce manner: "Fellows like you, who go around agitating, ought to be taken care of, and if I had my way you would not be allowed to hold a neeting in the street-but as long a the other 'socialists' have the privilege I suppose I cannot prevent you from so

In answer, I told him that I did not ask him or anybody else for the privilege, but that I had simply notified the chief of police of my intentions, and was going to exercise my constitutional rights to free speech as a citizen of the United States, and my duty to my fellow workingmen as a member of the S. L. P.

When we had gathered quite a large crowd, a policeman came over to me and asked me if I had "a permit"; to which I replied promptly "Yes." "Where is it?" he queried. "It is in the constitution of the United States. Go and read it if you doubt my word," I replied.

He retired, and we went on with th meeting. Needless to say there was quite a large crowd, and the best of order prevailed even in the absence of the "representative of law and order."
