Serious differences between the Congress and the League with regard to the proposals made in the Cabinet Mission's plan in connection with sections and groupings. The Muslim League upheld the view that decisions of sections should be taken by simple majority of vote of representatives in the sections while the Congress maintained that Provinces have a right to decide both asto grouping and asto their own constitutions. As the views of both the organisations became irreconcilable, the Congress and League bosses were summoned to London where a series of Conferences were held under the direct guidance of British Cabinet and yet no satisfactory solution of the deadlock could be evolved. Ultimately the British Government came out with their "Statement of 6th December" in which they supported the view held by the Muslim League regarding grouping, suggested reference of the issue to the Federal Court for final decision and declared that unless the Constituent Assembly can evolve an ugreed Constitution, it cannot be enforced 'upon any unwilling parts of the country". This made the position of the so-called sovereign Constituent Assembly more anomalous and created further complications in the existing deadlock.
